National Crafts Council

Sri Lanka that claims a proud history of thousands of years is one replete with handicrafts and arts. State patronage was amply available during the reigns of ancient kings for the nourishment of handicrafts which is a cultural heritage.

The craftsmen who engaged in handicrafts were highly recognized in the society and were bestowed with State honours.

Upon Sri Lanka becoming a subject of foreign powers, handicrafts, craftsmanship and talents which were preserved and nourished and handed down from generation to generation over thousands of years, started to gradually wither away mainly due to the lack of state patronage and due appreciation and recognition.

With Sri Lanka gaining independence from the clutches of foreign rule, there occurred a renaissance in the field of handicrafts and government and non-government institutions sprang up for this purpose.

The National Crafts Council was established under the National Crafts Council and Allied Institutions Act No. 35 of 1982 with preservation and development of handicrafts as well as enhancement of the social status of the craftsmen in the field of handicrafts as its main objectives.

During the past few decades, the National Crafts Council has implemented a host of projects and programmes for the preservation and development of handicrafts and the welfare of handicraftsmen.

- To implement programmes to promote the socio-economic status of craftsmen and their families:
- To liaise with State institutions at provincial and divisional levels in implementing above programmes.

3.2. Development Programmes implemented during the year 2014


3.2.1. Registration of handicraftsmen

The National Crafts Council takes action to register the craftsmen engaged in the field of handicrafts who are scattered all over the island. What is envisaged herein is to maintain a healthy and perpetual rapport with the genuine craftsmen chosen from among those who are engaged in the field of handicrafts while ascertaining their identity. It is also expected herein to intervene at the state level for the development of socio-economy of handicraftsmen and also for the provision of necessary instructions and facilities for them to freely engage in their production processes.

The number of handicraftsmen newly registered with the National Crafts Council in the year 2014 is 1487. Following Table indicates the number of handicraftsmen registered with the National Crafts Council during the past four years and their province wise distribution:

3.2.2. Cultivation of raw material

The island wide programme to cultivate plants that are used as raw material by the handicraftsmen in their production process is yet another programme conducted by the National Crafts Council with a view to ensuring the easy access to such natural raw materials for the benefit of handicraftsmen. The primary objective of this programme is to preserve the local handicraft which is of traditional and cultural significance.

Priority has been given under this programme to cultivate plants that are threatened with extinction and are used for the local traditional handicrafts. Under the programme to cultivate plants used as raw material plant varieties such as reed, teak, ebony, Halmilla, Ehela, Mahogany.

3.3. Master Craftsmen Training Project

The National Crafts Council implements the Master Craftsmen Training Programme with a view to preserving traditional handicrafts by way of popularizing same among the younger generation, encouraging the unemployed youth for self-employment in the field of handicraft and thereby uplifting their socio-economic status. Under this programme, talented craftsmen in each of the handicraft fields are selected as Master Craftsmen and their vast knowledge and skills in the field of traditional handicraft are imparted on to the apprentices. Training courses are conducted for durations from 06 months to 12 months depending on the scope of each training course.

Accordingly, seventy five (75) Master Craftsmen Training Classes were conducted during the year 2014 enabling seven hundred and four (704) apprentice craftsmen to receive formal training in the field of handicrafts. These apprentices have been given training in the fields of handicrafts such as reed, bobbin lace, Talipot, spindle leaves, banana fiber, coconut matulu, coconut shell engravings, lace and embroidery etc.

3.4.1. Awareness Programmes for Handicraftsmen

The prime objective of these workshops is to make the craftsmen aware through discussions of the required standard of an exhibit to be displayed at National and Provincial Handicraft Exhibitions and of the problems the craftsmen encounter in producing exhibits of such a high standard. 24 such workshops were held at provincial and district levels during the year 2014 and 2972 craftsmen have participated in those workshops.

3.4.2. Skills Development of Handicraftsmen and providing them with Technological Knowledge

Handicraft training workshops are held with the intension to educate the crafts persons and to provide them with the necessary knowledge and technology for the standardization of handicrafts and to introduce new designs thereby to enhance the quality of handicrafts. These workshops are held free of charge for benefit of handicraftsmen and one of the special features of these workshops is that courses are conducted full time for the duration of 3, 5 or 10 days etc in a specific field of handicraft. Accordingly, 39 Basic Technology Training workshops and 04 Intermediate Training Workshops were conducted during year 2014 and the total number of craftsmen received training thereat was 937.

3.5 Provincial / National Exhibitions & Award Ceremony


3.5.1. Provincial Handicrafts Exhibitions

3.5.2. "Shilpa – 2014" National Handicrafts Exhibition

Annual National Handicrafts Exhibition which is yet another programme conducted by the National Crafts Council with a view to appraising the craftsmanship of local handicraftsmen and to encouraging and promoting them was conducted on a grand scale from August 28th to 31st 2014 at the Sirimavo Bandaranayake Memorial Exhibition Centre.

Among the very special features of the event, the National Handicrafts Competition, National Handicrafts Exhibition, "Visithru" Exhibition where a collection of novel creations of talented and award winning handicraftsmen, "Visithma" Exhibition which comprised of gift items and souvenirs, presentation of more than 106 trade stalls comprising of handicrafts and artifacts, "CRAFT ALIVE" Fashion Show demonstrating new fashion designs in the field of handicrafts, the New Designs Exhibition organized by the National Design Centre, the Exhibition of new creations organized by the Palmyrah Development Board, "Shilpa Udana" special Loan Scheme introduced by the Regional Development Bank for the benefit of the handicraftsmen, "Divi Surekum" special Pension Scheme introduced by the National Savings Bank for the handicraftsmen were significant.

In comparison with previous years the attendance for the "Shilpa" National Handicraft Festival this year which included local and foreign enthusiasts, school children, crafts persons, self employed, consumers and officials, was encouraging and the event provided the craftsmen with a competitive market for their creations and also a higher appraisal at national level.

Accordingly, the total number of craft exhibits presented for the National Handicrafts Exhibition this year stood at one thousand eight hundred seventy eight (1878).

The National Handicrafts Exhibition which is held representing 54 fields of handicrafts under the classification of 19 basic fields of handicrafts, gives away two Gold awards for the traditional handicraft segment and the modern handicraft preserving the tradition segment, Silver awards, National awards with cash prizes and certificates for the first, second and third places.

Mr. O.K.G.S.K. Sanjeewana of Central province who presented the Lacquer handicraft "Dekum Banduna" under the Modern Handicrafts Category Preserving the Tradition of the Traditional Handicraft Segment and Mr. Mahinda Ranaweera of Central province who presented the "Viskam Dethin" under the Leather Handicrafts Category of the Traditional Handicraft Segment won the Gold medals at the "Shilpa – 2014" National Handicraft Exhibition.

Further more, a special Lifetime Achievement Award and another special award for two handicraftsmen who won Gold Awards for three consecutive years and a Special Jury Award to a handicraftsman for the presentation of a significant handicraft were awarded at this year's National Awards Ceremony.

3.9.2 "Visithru" New Creations Exhibition



3.12. Special Village Development Programme - 2014

Under this Special Village Development Programme – 2014, 11 such villages representing the three segments namely earthenware production, traditional handicrafts and entrepreneurship were developed at a cost of Rs. 37 million.

Development of workshops and common utility centres, construction of kernels, provision of electricity, donation of mobile clay milling machines, development of access roads, provision of tool kits and raw-materials and fixing of name boards at access roads were done under this programme in those special traditional handcraft villages to facilitate the handicraftsmen to carry out their work easily. Moreover, a production promotion programme was also implemented with a view to promoting their products with the collaboration of the National Design Centre.

Accounting Policies and Notes for the Year 2014

1. Basis of Preparation

Financial Statements have been prepared in accordance with the Sri Lanka Public Sector Accounting Standards. No Adjustments have been made for inflationary factors affecting the accounts and financial statements are prepared in Sri Lanka Rupees.

2. Government Grants

Recurrent Grant received from the Government during the year are recognized as revenue and capital grants are shown in the balance sheet.

3. Depreciation

Depreciation on tangible fixed assets has been provided at diminishing balance method at the following annual rates.

4. Valuation of Inventories

- Inventories are valued at the lower of cost and realizable value.
- The Crafts Training Section that operated under the Handicrafts Board of Sri Lanka has been taken over to the National Crafts Council with effect of dated 01/05/2009 in accordance with the Cabinet decision dated 23/12/2008 of Cabinet Paper No. 08/2322/349/015. As per the decision, 185 workers have been attached to the National Crafts Council with effect from 01/05/2009.But the relevant inventory Items were not endowed to the National Crafts Council legally up to now.
- Properties were not disposed from the assets of the National Crafts Council which demolished due to development of "Ape Gama" project. The necessary action will be taken regarding the demolished properties according to the financial regulation No. 108 and 109 in due course.

5. Statements of Financial Performance

The revenue of the institution represents the income from Government Grants and other miscellaneous income. All income has been recognizing on an accrual basis.


Report of the Auditor General on the Financial Statements of the National Crafts Council for the year ended 31 December 2014 in terms of Section 14(2) (c) of the Finance Act, No. 38 of 1971

The audit of financial statements of the National Crafts Council for the year ended 31 December 2014 comprising the statement of financial position as at 31 December 2014 and the statement of financial performance, statement of changes in equity and the cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 13(1) of the Finance Act, No. 38 of 1971 and Section 84 (3) of the National Crafts Council Affiliated Act, No.35 of 1982. My comments and observations which I consider should be published with the Annual Report of the Council in terms of Section 14(2)(c) of the Finance Act appear in this report. A detailed report in terms of Section 13(7) (a) of the Finance Act was furnished to the Chairman of the Council on 21 October 2015.

1.2 Management's Responsibility for Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements whether due to fraud or error.









1.3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent with International Standards of Supreme Audit Institutions (ISSAI-1000-1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatements of the financial statements, whether due to fraud or error. In making those risks assessments, the auditor considers internal control relevant to the Council's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Council's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of financial statements. Sub - sections (3) and (4) of Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

1.4 Basis for Qualified Opinion

My opinion is qualified based on the matters described in paragraph 2.2 of this report.



2. Financial Statements

2.1 Qualified Opinion

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the National Crafts Council as at 31 December 2014 and its financial performance for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.

2.2 Comments on Financial Statements.

2.2.1 Accounting Policies

Even though an asset should be depreciated on a systematic basis over its useful life since it is available for use, the depreciation policy on library books valued at Rs.718,228 had not been determined.


2.2.2 Sri Lanka Public Sector Accounting Standard No.07

Even though assets should be revalued once in every three or five years and shown the fair value, it had not been so done.

2.2.3 Accounting Deficiencies

The following observations are made.

(a) Even though non-current assets purchased under the Government grants had been depreciated annually, action had not been taken to account for the relevant amortization. The balance of Government grants as at the end of the year under review was Rs.95,047,571 whereas the net value of non-current assets represented thereon amounted to Rs.61,575,322.



- (b) Provisions had not been made for audit fees for the year under review while the outstanding audit fees payable according to the financial statements amounted to Rs. 1,593,605.
- (c) A sum of Rs.4,171,985 which should be shown under the work in progress had been brought to account under the lands and buildings.
- (d) As the internal money transfer entries had not been accurately brought to account, the Crafts Fund Account had been understated by a sum of Rs.1,100,000 whereas the payables had been overstated by the same amount.
- (e) A sum of Rs.4,161,485 received for the construction of buildings from the line Ministry during the year under review had been brought to account as other income instead of being accounted as capital grants.

2.2.4 Unexplained Differences

A difference amounting to Rs.2,022,607 was observed in comparing the assets registers pertaining to 07 asset accounts of the statement of financial performance of the year under review with the schedules.

2.2.5 Lack of Evidence for Audit

Confirmations of balances and Board of Survey Reports pertaining to liabilities totalling Rs.404,469 and materials and show room stocks valued at Rs.11,388,580 were not made available to audit.

2.3 Non-compliance with Laws, Rules, Regulations and Management Decisions

3. Financial Review

3.1 Financial Results

According to the financial statements presented for the year under review, the operations of the Council had resulted in a deficit of Rs.4,035,820 as compared with the corresponding deficit of Rs.30,791,896 for the preceding year, thus indicating an improvement of Rs.26,756,076 in the financial results as compared with the preceding year. The increase in the total income of the Council by 46 per cent as compared with the preceding year had mainly attributed to this improvement.

4. Operating Review

4.1 Management Inefficiencies

The following observations are made.

- (a) Action had not been taken to recover the arrears of rental amounting to Rs.143,000 recoverable from the rented stalls of the Sigiriya Crafts Village as at 09 December 2014.
- (b) Credit balances amounting to Rs.2,627,489 and debit balances amounting to Rs.152,252 shown in the bank reconciliation statement since the year 2011 had not been identified and brought to account.
- (c) A Crafts Museum comprising the great masterpieces that achieved winnings from the Crafts Exhibitions conducted annually within the "Ape Gama" by the National Crafts Council had been established within the premises of "Ape Gama" and a sum of Rs.659,072 had been spent on its maintenance activities during the year under review. Nevertheless, action had not been taken for the reimbursement of that amount from the Handicrafts Board.



4.2 Transactions of Contentious Nature

The buildings situated in the land vested in the National Crafts Council on 99 year lease basis by the Urban Development Authority, had been demolished in accordance with the decision of the Construction Committee for the Commonwealth Heads of Government Meeting held in the year 2013. Furthermore, the Laksala Showroom constructed adjacent to the National Crafts Council had also been demolished and the "Ape Gama" had been reconstructed with a 60 square feet belonging to the Council. Even though there was a contentious nature with regard to the ownership of this land as the "Ape Gama" is maintained by the Sri Lanka Handicrafts Board, action had not been taken to settle it.

4.3 Idle and Underutilized Assets

Even though the Sigiriya Crafts Village established by the Ministry of Rural Economic Development on a land of 03 acres in extent, comprises 04 buildings and 40 sales stalls at present, only one building and 09 trade stalls are being used. The building given to Laksala, conference hall, cafeteria, lavatories remained idle without being used and matters such as non-availability of water for use, decline of the income of the craftsmen due to lack of tourists visits had mainly affected the smooth functioning of the village.

4.4 Identified Losses

The building constructed at a cost of Rs.1,431,316 in the year 2012 for regularizing and interior decoration of the showroom of the National Crafts Council and the timber bridge constructed at a cost of Rs. 1,152,902 to enter the Crafts Village in the premises of Crafts Council had been demolished subsequently for another development work even before opening. As such, a loss amounting to Rs.2,584,218 had sustained.



4.5 Personnel Administration

The approved cadre of the National Crafts Council as at 31 December 2014 had been 262 while the actual cadre stood at 254. Fifteen vacancies existed in the approved cadre whereas excess cadre existed in the primary unskilled level had been 18.

5. Accountability and Good Governance


5.1 Annual Action Plan

Even though an Annual Action Plan for the year 2014 had been prepared, due attention had not been paid to achieve the objectives of certain sections.

The management had failed to achieve the objective of popularizing the Handicrafts Village Programme and Handicrafts Museum being the main programmes included in the Annual Action Plan for the year 2014. Further, despite the plans to provide 750 sets of equipment to the trainees during the year under review, only 200 out of that had been provided while the objectives of 03 sub programmes out of 28 active sub programmes had not been achieved.

5.2 Unresolved Audit Paragraphs

According to a Cabinet decision taken in the year 2009, although the Crafts Training Centers functioned island wide under the Sri Lanka Handicrafts Board, its properties and employees had been vested in the National Craft Council, the property had not been legally vested. According to the accounts of the Sri Lanka Handicrafts Board, assets valued at Rs. 46 million owned by the Centers had not been brought to account as the assets of the National Craft Council as per the Cabinet decision. It included three motor vehicles vested in the Sri Lanka Handicrafts Board. Even though a large sum of money had been spent on Board of Survey of inventory goods at Centers, action had not been taken to get transferred the ownership of those Centers to the Council.



6. Systems and Controls

Deficiencies observed during the course of audit were brought to the notice of the Chairman from time to time. Special attention is needed in respect of the following areas of control.

- (a) Control of Fixed Assets
- (b) Control of Advances
- (c) Accounting
- (d) Administration of Crafts Training Centres
