01. Introduction



The National Dangerous Drugs Control Board (NDDCB) is a Statutory Board established in terms of the National Dangerous Drugs Control Board Act No. 11 of 1984. The Board came into operation on 9th April 1984 within the Ministry of Defence, and Urban Development.

The Board is the principal national institution charged with the formulation and review of the national policy relating to the prevention, control, treatment and rehabilitation of drug abusers and given powers to advise and make recommendation to the Minister on such policy. Further, the Board assists various departments and institutions to achieve their tasks in relation to drug abuse, prevention and control, and conduct epidemiological studies and maintain databases. Further the Board monitor and help relevant agencies to fulfil obligations under the United Nations (UN) and Regional Conventions ratified by the government. To that end the Board provides technical and other assistance and co-ordinates with the government and the International Narcotics Control Board (INCB), and represents at the Commission on Narcotics Drugs (CND).

2. Vision and Mission

2.1 Our Vision

- To lead Sri Lanka to become the pioneer in managing the outcomes and impacts of drug related issues in South Asia
- Moving towards a drug abuse free Sri Lanka by year 2020

2.2 Our Mission:

- To create an environment where all sectors of the society and the public at large participate and contribute effectively together with all concerned agencies, towards eliminating the drug menace and related issues from the society.
- To create social ethos conducive to eradicate the drug dependence, illicit trafficking and peddling.
- To encourage the national political commitment and international co-operation towards creating a drug free society.
- To provide leadership in implementing the national drug policy while securing the information and resource base for its effective functioning, monitoring, evaluation and review where necessary.

3. Powers of the Board

Under the Section 07 of the National Dangerous Drugs Control Board Act the Board has power to,

- (a) Formulate and review a national policy relating to the prevention and control of the abuse of dangerous drugs and to advise and make recommendations to the Minister on such policy;
- (b) Call for such information and particulars from individuals, organizations, government departments and public corporation as may reasonable be necessary to exercise the powers of the Board;
- (c) Receive donations and grants from local and foreign sources for the purpose of exercising the powers of the Board.
- (d) Co-ordinate the activities of agencies engaged in the prevention and control of dangerous drugs.
- (e) Promote treatment and rehabilitation measures for drug dependant persons and conduct national drug abuse and preventive educational programmes for children and adults;
- (f) Conduct and undertake research studies into the prevalence, aetiology and legal , medical, social cultural and economic implications of the abuse of dangerous drugs.
- (g) Maintain liaison with national , regional and international organizations and agencies involved in drug control activities; and
- (h) Acquire, hold, take or give on lease or hire, mortgage, pledge and sell or otherwise dispose of, any movable or immovable property.

06. A General Review of the Current drug situation in Sri Lanka

The total number of drug related arrests was 67,025 in 2014. Comparing with the figures of the year 2013, it has been increased by 1.5% in the year 2014. Out of total drug related arrests, 35% was on heroin and 65% was on cannabis. Most of the drug related arrests has reported from the Western province and Colombo district contributes to 44% of the total drug arrests. The prevalence of drug related arrests was 329 per 100,000 populations in 2014. (Table I)

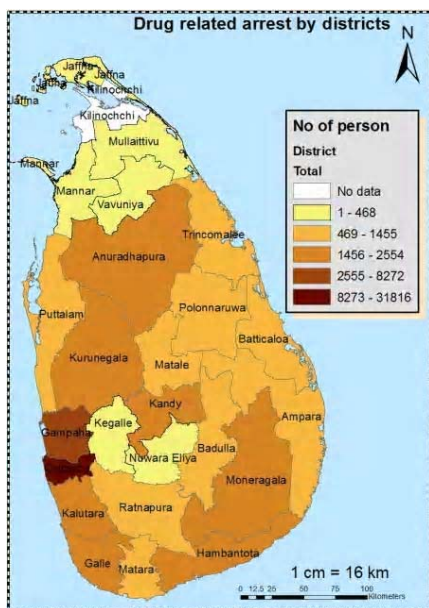
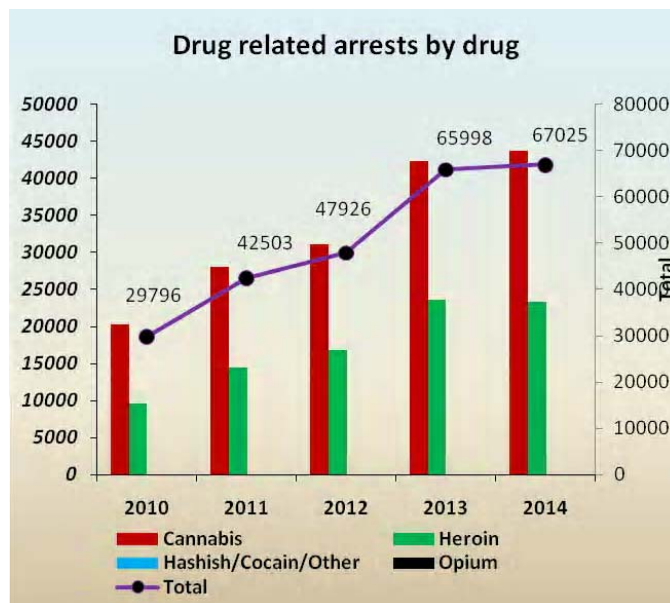

Cannabis

Cannabis is the only plant (drug) that is cultivated illicitly in Sri Lanka. It is mostly cultivated in dry Zones in Eastern, North Eastern and Southern Provinces. The estimated land area under cannabis cultivation is nearly 500 hectares. Little labor and other simple inputs are sufficient to give a good cannabis yield compared to other cash crops, and it has very few natural pests. Observations on seized cannabis cultivation imply that modern agricultural methods are being used for this as well. A more potent variety of cannabis with more flowering tops had become popular among the young drug users recently.

Drug related arrests; in the year 2014 majority was for cannabis. The highest number of cannabis arrests was reported from Colombo district. The Tangalle Police Division had seized the largest quantity of cannabis and was followed by the Special Task Force (STF) and Monaragala Police Division. It is revealed that the cannabis is growing in rural areas and is brought to Colombo and other provincial towns with a view to sell it at a good rate to earn more profit. Often public transports as well as three wheelers have been used for trafficking of cannabis in order to avoid detections. A gradual increase in cannabis related arrests has been noted amongst the drug users arrested in the recent past. The total quantity of cannabis seized island wide was 19,644kg. Fifty two percent (52%) cases have been reported from the Western province. The prevalence of cannabis related arrests was 215 per population of 100,000 in 2014. (Table IV)

The present trends indicate that the over last five years the incidence of abuse of cannabis has come to constitute substantial problem in Sri Lanka Society. In this trend reflected a significant increase of cannabis users in the country.

Cannabis without its narcotic content is used in the manufacture of Ayurveda (indigenous) medical preparations. Hence the Ayurveda medical practitioners and the Ayurvedic Drug Cooperation was the largest consumer of it. 121.900kg of cannabis was used for Ayurveda medicinal purposes in 2014. The

Ayurveda Drugs Corporation had consumed the total quantity of 121.900kg of cannabis for production of Madana Modaka, Suran Vidura Vatee, Kameshwari Modakaya, Ranahansa Rasayanaya and Buddharaja Kalkaya.

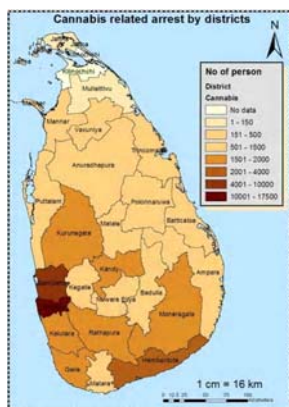
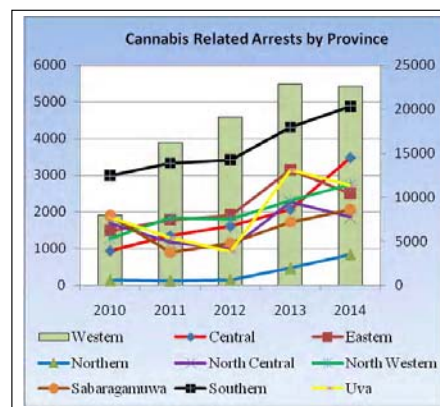

Heroin

Before 1980s, use of Heroin was restricted to a few locals who have been travelled abroad frequently, and to some foreigners. Users of Heroin became more common among other strata from early 80's. Thereafter a threat or rise of the number of heroin users was detected. Even though its use was initially confined to Colombo city and few provincial towns, a great risk always existed of spreading it in to remote towns and rural areas. It has also become a major health and social problem in the country, regardless of ethnic, religious and geographical boundaries.

Majority of the arrestees were drug users, who have been arrested for possession of heroin for personal use. The estimated quantity of street level supply of heroin in Sri Lanka is 985kg per annum or nearly 2.7 kilograms per day. This quantity is sufficient for 45,000 heroin dependents. Heroin was smuggled into the island by fishing boats or by couriers posing as tourist. Most of the heroin brought in to Sri Lanka from India and Pakistan. The drug is mainly smuggled via South India to the Western coast of Sri Lanka using fishing boats. In 2014, 313 kgs of heroin were seized and 23,331 persons were arrested. Heroin related arrests have decreased in year 2014 by 01% compared to the year 2013. The prevalence of heroin related arrests was 115 per population of 100,000 in year 2014.

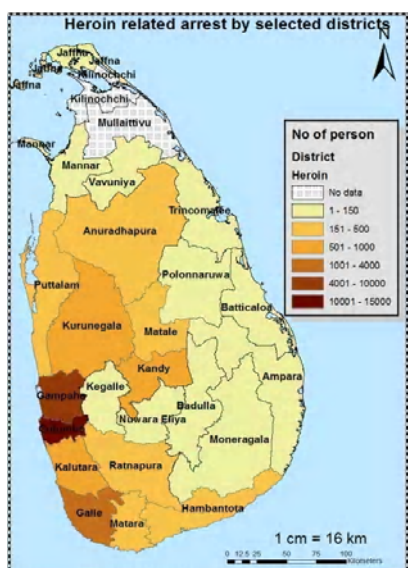
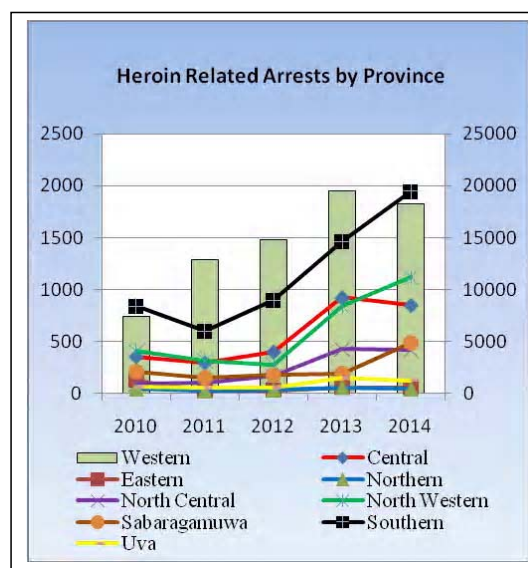

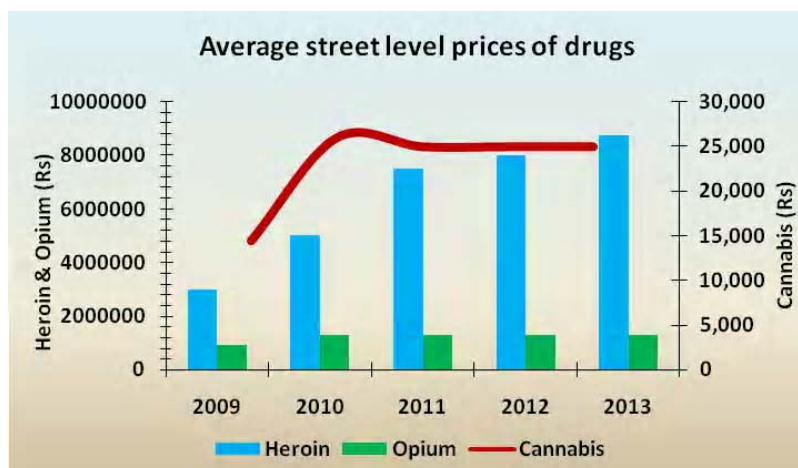
Opium

Opium is used in the Ayurveda (indigenous) medical pharmacopeia and the government makes it available to Ayurveda Medical Practitioners through Government Hospitals. Opium related arrests have not reported during the year 2014.

Price and Purity

The average street price per kilogram of heroin in 2014 was 9.5 million. (Approximately U.S. \$67,857) The average street price of heroin has increased by 9% for the local in 2014 compared to year 2013. The average street price of a kilogram of cannabis was Twenty Thousand Rupees. (Approximately U.S. \$ 143) for locals. The price of cannabis decreased for locals in 2014. Compared to the year 2013. The average street price of opium per kilogram for local was Rupees 1.5 million. (Approximately U.S. \$ 10,357)

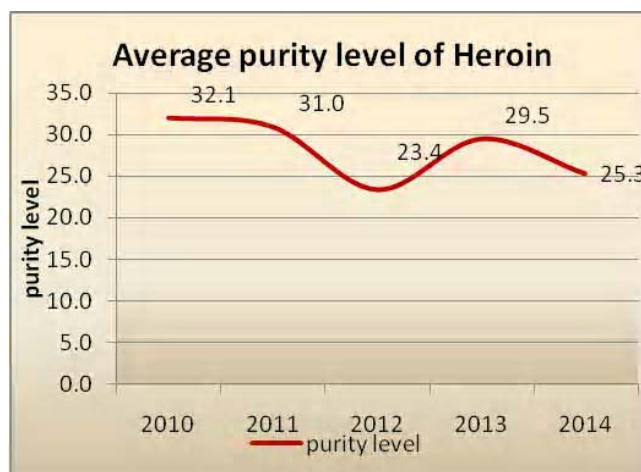

Average Purity Level of Heroin

The average di-acetyl morphine content of street level heroin in Sri Lanka was 25.32% in 2014. It has decreased by 14% compared to year 2013. Diazepam, Lactose, Loratadine, Acetaminophen and Caffeine are the commonly used adulterants of heroin. The National Narcotic Laboratory (NNL) of NDDCB holds the responsibility of analyzing street level heroin samples, and analysis of seized samples is done once a month unless in cases where routine analysis is required. According to the tested samples during the last five years, the average purity level of heroin has decreased by gradually in 2014. The average purity level of heroin was 30% in 2013 and it was 25% in 2014.

Method of Drug Administration

Among heroin users, inhalation is the preferred mode of intake. Cannabis and Hashish are mostly smoked. The opium users mostly chew it. Also many drug users smoke tobacco and consume alcohol.

Psychotropic Substances

At present, psychotropic substances abuse is at a considerable level in Sri Lanka. Dependence on one or more of these substances stems either from medical use, or from the use to evade withdrawal symptoms of drug users when heroin is not available in the market. Some of these are (willingly or unwillingly) incorporated

in seemingly innocuous medicinal preparations. Although these substances are prescription controlled, some seems to be freely available in the illicit market. Due to the few incidence reported in year 2014, the Ministry of Health has taken steps to control and monitor these substances with the guidance of the NDCCB. During the year 2014, 0.190kgs of Methamphetamine was seized and one person was arrested for psychotropic substances related offences.

Precursor Chemical

Precursor is nothing but a chemical out of which synthetic drugs can be manufactured through chemical processes. Precursors are generally used in industry and chemical manufacturer for licit purposes. The traffickers divert these precursor chemicals illegally for production of illicit drugs.

Sri Lanka does not manufacture precursor chemicals. Hence whichever substance required for pharmaceutical or industrial manufacturing processes must be imported. Most of the precursor chemicals imported to Sri Lanka used for industrial of pharmaceutical purposes. Major precursors imported in to the country during the last few years were acetic anhydride, acetone, ephedrine, ergometrine, hydrochloric acid, methyl ethyl ketone, piperonal, potassium permanganate, pseudoephedrine, sulphuric acid and toluene.

These precursor chemicals are substantial to produce synthetic heroin and cocaine and also can be produce other highly addictive synthetic drugs as Methaqualone, LSD, MDA/MDMA, Amphetamine, Methamphetamine and Phencyclidine tablets. Although Sri Lanka does not manufacture any precursors, a clandestine laboratory was seized in Kosgama, Awissawella in 2008.

Convention Against Illicit Traffic in Narcotic Drug and Psychotropic Substances, Act 1 of 2008 was enacted to cover 23 precursor chemicals from illicit usage and trafficking. This Act gives effect to the UN Convention Against Illicit Traffic in Narcotic Drugs and Psychotropic Substances 1988. The Precursor Control Authority was established on 25th of October 2010 as a subsidiary of NDCCB.

Drug Trafficking

Seizures of drugs by law enforcement agencies are one of the main indicators used to assess the level of illicit drug trafficking. Sri Lanka is a transit point for drug trafficking, and traffickers act as carriers of drugs from Pakistan and India to Europe and the West through Colombo or Male.

Throughout the past five years, heroin seizures and arrest information revealed that South West Asian heroin (Brown Sugar) are mainly smuggled from India and Pakistan and are mostly originating from the golden crescent region.

Treatment and Rehabilitation Services

The Government and non-Governmental Organizations are providing residential care treatment & rehabilitation service for drug dependants in Sri Lanka. Drug Dependants (treatment and rehabilitation) Act No. 54 of 2007 has been enacted to implement compulsory treatment facilities. There are four residential treatment centers under NDCCB at Colombo (Thalangama), Kandy, Galle, and Urapola (Nittabuwa).

The Programmes of these centers include individual and family counseling and detoxification treatment, physical exercises, and mental relaxation, indoor and outdoor activities, psychotherapy, education, vocational training.

The Prisoner Diversion Scheme (PDS) is an exclusive treatment programme designed for prisoners who imprisoned for drug related offences. This programme is Act. No. 54 of 2007, Colloborated with Department of Prison.

Imprisonment

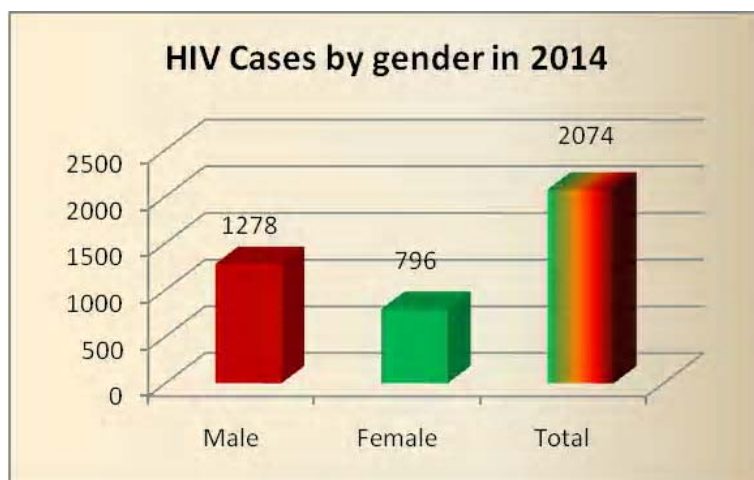
The total number of narcotic drugs related prison admissions was 11,990 in year 2014. Among them 3866 (32%) persons were arrested for Cannabis related offences and 8112(68%) persons were for heroin. Compared to the year 2013, It has been increased from 15% in 2014.

HIV and AIDS

Injecting drug use is one of the cause of HIV/AIDS transmission. Sharing needles and injecting equipment with infected blood facilitate may cause for this. The slight increase in the number of injecting drug users was reported recently. However, only one case of HIV/AIDS infection due to injecting drug use has been reported so far in Sri Lanka.

Law Enforcement

The Police Department including Police Narcotics Bureau (PNB), Department of Excise, Department of Coast Guard, Sri Lanka Customs and the Forces etc. conducted several drug law enforcement operations. The Drug Law Enforcement subcommittee of the Board co-ordinates with all the Law Enforcement agencies implements the National Policy of Drug Prevention, and respective laws, rules and regulations.

7. Corporate Governance

The Board was managed adhering to the guidelines given by the Department of Budget for good governance and no other specific guidelines formulated by the Board, and also follow the procedures laid down in the Establishment Code.

Sub –Committees

The Law Enforcement Sub-Committee assisted the Board in monitoring and implementing Laws related to drug prevention and supply reduction etc.

The Legislation Sub-committee assisted the Board to develop legislation and regulations in related to Prevention of Drugs.

The Board appointed an Audit and Management Committee in terms of the Public Enterprises Guidelines for Good Governances and the relevant regulation. The Committee met quarterly.

08. Segmental Review of Operations

8.1 Drugs Prevention, Education and Training

Schools Level Drug Preventive Education Programs

Preventive Education and Training (PET) Unit has successful in providing effective drug preventive education programs as that assists students to acquire knowledge, change their attitudes on drugs and ethos, and develop life skills. A range of activities has been developed to address numerous problems on drug abuse with students. Those activities are easy to understand to the target group, as those activities are evidence based.

Professional competencies are core of a good trainer or facilitator. Every facilitator of the Unit has an obligation to articulate to conduct an effective education program to the community. The recent program evaluation reports have indicated that how education programs are effective to the target community. These recent results reveals that past years education programs on students; both qualitatively and quantitatively have passed by the unit on all dimensions in this year.

Parallel to the universal prevention declaration, it was great that to say PET has followed all its guidelines in their programmes. Research indicates that some of the factors that make people vulnerable to use drugs differ according to age and identified risk and protective factors during infancy, childhood and early adolescence particularly relating to parenting hence these programmes makes enormous advantages.

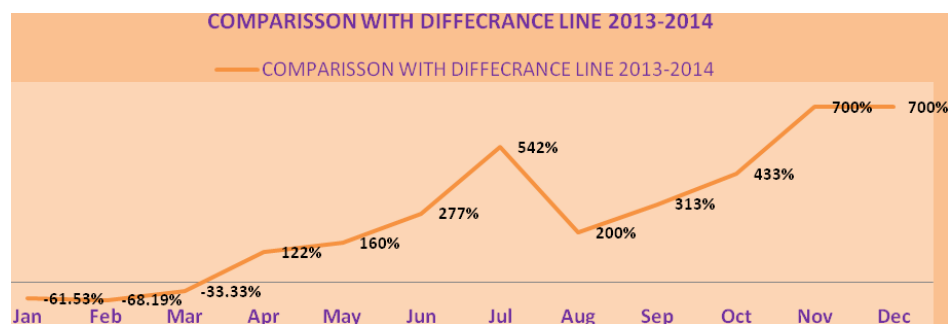

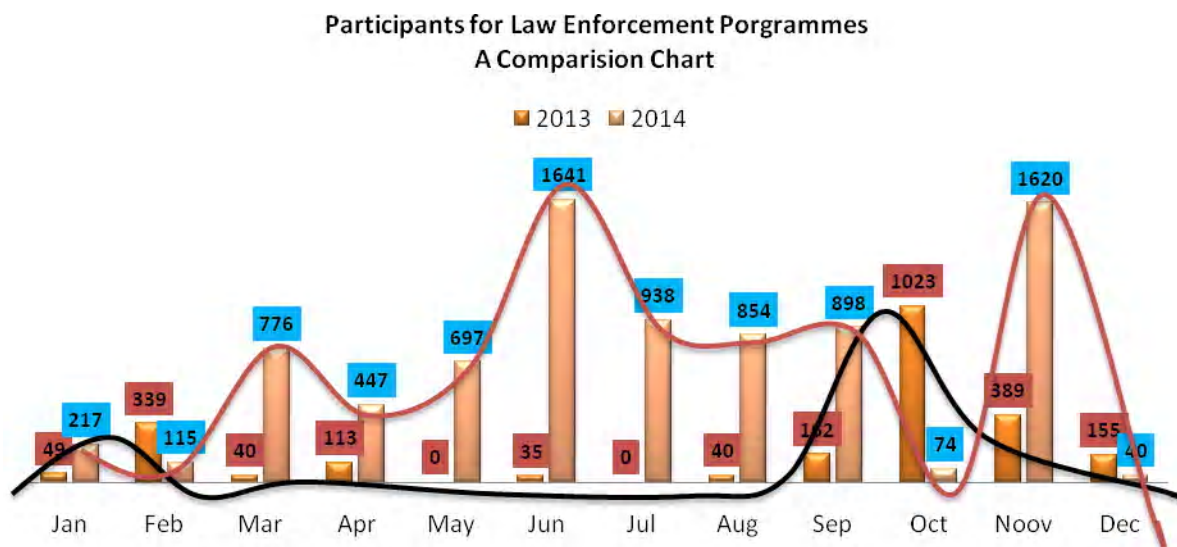

Handbook of Drug Abuse Information 2014 contains the data collected from Department of Excise, Department of customs, PNB and other relevant organizations.

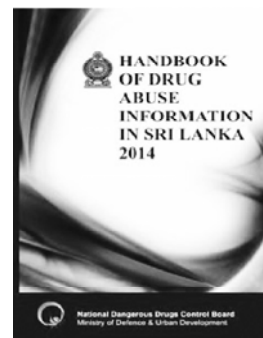

Analysed drug related arrested data obtained from Law Enforcement Agencies and compiled Statistical Report on current drug abuse situation are published in the report.

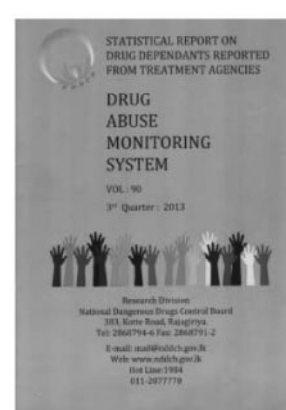


Drug Abuse Monitoring System (DAMS)

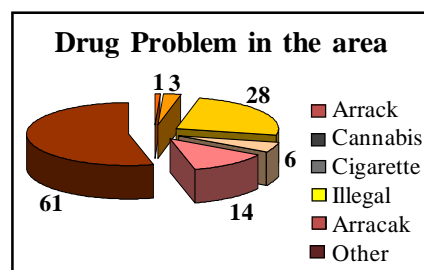
Rapid Assessment Survey on Drug Abuse Prevalence in Kuliypitiya Divisional Secretariat Divisions (DS)

The Research division has conducted a Survey on drug abuse in Kuliypitiya 113 DS division parallel to “Dayata Kirula” programme of the Government. The Grama Niladharis of the Kuliypitiya West and East were trained for data collection of the survey. The objectives of the survey were to study drug abuse situation Kuliypitiya DS division and to develop drug prevention/treatment and intervention programme for the high prevalence areas.

Quantitative and qualitative data were collected from the Key informants, government officers and the community leaders.

Findings of the study revealed that the illegal Arrack (Kassippu) was commonly used in that area. And it was identified as a Majority of the drug users were used kassippu and it was revealed that the youth commonly use alcohol.

It was revealed that there is a high risk situation among school children for drug use. It is very important for conducting drug awareness programmes for school children, directing drug users for the treatment and vocational training.

A Study of effectiveness on drug treatment of NDDCB treatment centers

The above survey has conducted to find out effectiveness of drug treatment programme of the NDDCB. The Board managed four treatment centers and provides 3 months drug treatment facilities to the drug users in the country.



Drug Prevalence Survey in Jaffna Divisional Secretariat Divisions

The research division annually conducts a Prevalence Surveys and Rapid Situation Analysis Surveys (RSAS) in District wise to assesses the current drug abuse situation in the country and provide information & recommendation to drug prevention programmes, outreach work and treatment & rehabilitation programmes.

The division has conducted a drug prevalence survey in Jaffna District. Therein 15 Divisional secretariat divisions and 13,050 Grama Niladari divisions were selected as a sample.



Drug prevalence survey among school children in Kurunegala District

Conducted a drug prevalence survey among school children with the support of zonal education office at Kurunegala district. Four training programmes were conducted for the teachers and principals in Kurunegala, Puttalam, Chillaw and Mahawa zonal for the data collection. This Study for used to identify, risk groups of school children, to identify what are the risk factors caused to drug use of school children, to commence drug prevention and education programme for identified schools.

Projects

The research division coordinated and conducted following two projects and summary of the project are given below.

1. Intervention programme for Injecting Drug Users
2. Continuing Community Based Treatment Centre for Female Drug Users

Intervention Programme for Injecting Drug Users (IDUs) in Slave Island - Project No. SESRL 1206186

A RSAS was conducted with 100 Injected Drug Users from the areas of Slave Island, Dehiwala, Dematagoda and Moratuwa.

As an intervention programme a Drop - in - center was established at Bodirajarama Temple in Slave Island to provide treatment facilities for IDUs. Completed the project during the year and an Assessment study was conducted to evaluate of the project.



Continuing Community Based Treatment Centre for Female Drug Users

Project No. SESRL 1206186

The NDDCB has opened a drop - in center in collaboration with WHO under the above project to provide basic treatment facilities for women, in May 2014 at the Western province Treatment and Rehabilitation center at Talangama. Treatment services and vocational trainings were conducted during the year.

WHO Funds

WHO has granted funds for continue community based treatment centers for female drug users and conduct health promotion Campaign (prevention & treatment) in high prevalence areas of drug abuse in the country to create the health concern among communities.

INCB Reports

Monthly, Quarterly and Annually reports as well as questionnaires on various aspects of drug abuse in Sri Lanka were transmitted to INCB, to fulfil the international drug treaty obligations. The research division of NDDCB is responsible to report to the INCB on Sri Lankan current situation of drug related issues.

In 2014 Research Division sent reports, questionnaires to the INCB, Medical Suppliers Division and Medical Technology and Supplier Division of Ministry of Health.

The research division in collaboration with Education and Counseling staff of the NDDCB conducts a “Certificate Course on Drug Counseling” for school leavers, Government officers and NGO’s and who has interested in this field. The objectives were to expand the knowledge and skills of students on drug abuse and management who are willing to be professional in drug counseling and to share information with them and to get their contribution to reduce drug problem in Sri Lanka. Six courses were conducted for year 2014 as follows and 182 students followed the course.



Publication

The research division published the “Empowerment” news letter quarterly. The purpose of this news letter is to sharing with Law enforcement agencies and relevant communities. Also this news letter provides activities and services of NDDCB to the Public. During the year of 2014 research division published 9th, 10th and 11th issues of this News letter.



Commemorate of the NDDCB 30th Anniversary

The NDDCB has completed its 30th year on 9th April 2014. The research division compiled a souvenir to commemorate this event and earn Rupees two hundred seventy five thousand and five hundred (Rs.275,500/-) for the Board.

History Book of NDDCB

The research division published a history book of NDDCB on its 30th anniversary, and published a Four years progress report namely, “Sive Wasaraka Gamanmaga” and launched it on 19th of May at the NDDCB Auditorium. This report was helpful to reduce the gap of history documentary /reports of the NDDCB.

Display drug prevention messages

The NDDCB with collaboration of the Ministry of transport displayed drug prevention messages in the 12 buses and 6 compartments of the train. The Research division created drug prevention messages and coordinated the event.

8.3 Treatment and Rehabilitation Services

Treatment and Rehabilitation Service is one of the significant services provided by the NDDCB. Centres have been taken measures to provide its continuous services to drug addicts more effectively in this year. Services have been qualitatively enhanced and value added by providing facilities for large number of drug dependents and their families in order to relieve them from many aspects of the drug problems. These programmes were helpful them to develop their skills to change their attitudes and strengths to improve spiritual progress.

There are four treatment and rehabilitation centers managed by the board;

1. Prevention Treatment and Rehabilitation centre , Central Province - Kandy
2. Prevention Treatment and Rehabilitation centre, Southern Province - Galle
3. Prevention Treatment and Rehabilitation centre, Navadiganthaya - Nittambuwa
4. Prevention Treatment and Rehabilitation centre, Western Province -Thalangama

Treatment centres continued their services at these centres for the drug addicts. Classification placed for admitting drug addicts to the centres as follows.

Admitting Drug Dependants for Residential Treatments

Admitting drug dependants for the residential treatment centres have been carried out according to the above mentioned classification. Clients were sent to the residential treatment centres mostly through counsellors and government institutions. Addition to that there were treatment seekers who admitted by their own.

According to the Drug Dependents Persons (Treatment and Rehabilitation) Act No. 54 of 2007 and the Presidents “Mathata Thitha” Programme, Hon. Defence Secretary Gotabaya Rajapakshes’s direct involvement the Rehabilitation task unit, Department of prisons, the NDDCB has jointly planned and introduced a rehabilitation centre in the Kandakadu for those who addict to drugs and sentenced by the courts to rehabilitate. From 24th August 2013 the clients sent by the court to our

treatment centres, sent to the Kandakadu treatment and rehabilitation Centre. But the clients below age of 21st admitted to our Yowun treatment and rehabilitation centre at Kandy.

Duration of the treatment programme

The common residential period is three months. However according to the client's progress estimation done by the counsellor and the staff, the period could be slightly longer than estimated.

Treatment Programme

All centres offer variable treatment programmes depending on client's recovery. It is done according to a plan; where every client is benefited. Special psychotherapy treatment methods are used. This treatment service enriched in many aspects as it provides services such as individual counselling, family counselling, vocational trainings, activities involved in developing interpersonal skills, improving self confidence etc.

Daily events

All centres offer common treatment programme depending on the client's recovery. programmes run throughout the day and it start at 5.30 a.m. to 10.00 p.m. The programme consists of meditations, in-door and out-door sport activities, individual and group activities, educational & professional programmes etc.

Spiritual Development Programme

In order to re-build the good spirit and virtues inside drug dependants, centres carried out spiritual development programmes directing every residential dependant to observe sil in any poya day attending them in listening "bana speeches", and taking them to religious places were the significant events taken place.

In addition to all that, all treatment centres involved in decorating "Bauddaloka Mawatha" with lanterns during the Vesak season and involved in various events such as making vesak cards, lanterns and arms giving activities. The competition of the Vesak Lanterns Commemorating Poson Poya, was held at Bauddloka Mawatha won by Galle and Kandy treatment and rehabilitation centres in this year.

In addition to all mentioned events, a special programme of observing sil for parents was also carried out once in every month.

Vocational Training Programmes

At Treatment Centres Vocational Training also given to the clients. Details of the programmes are depicted below. These programmes were held for clients as a treatment activity in each centre.

Counseling, Treatment and Rehabilitation Services.

The reported number of clients entered for treatment services was 5783 centres. The total number of treated reported from private treatment centers were 916 and 1352 were from out reach division and 1815 were reported from the prison programmes.

Western Province Treatment and Rehabilitation Centre - Thalangama

The capacity of the centre is 50 beds. The centre has a normal ward, a pay ward and a female ward. During the year counselling services have been provided to 560 clients of normal ward, 184 clients of pay ward and 30 clients of female ward. There were total of 774 clients.

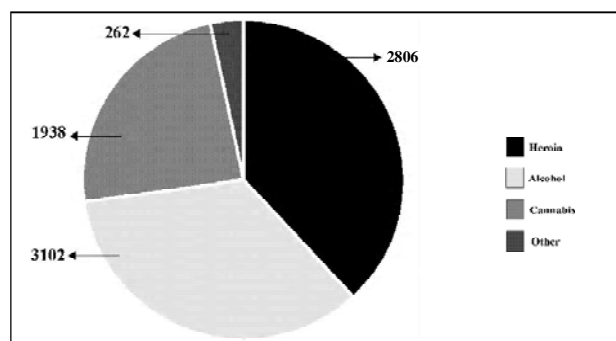

8.6 National Narcotics Laboratory (NNL)

Summary

The NNL has provided its services in accordance with the responsibility which has been entrusted for covering all the scientific aspects in order to develop effective drug control measures in Sri Lanka on the basis of the scientific research and analysis while successfully maintaining its performance in line with the International standards as reviewed by the International Proficiency Testing Scheme of the UNODC.

The results of the analysis of suspected drugs have been shared with other National institutions and agencies, and are being used for various investigations, analysis of drug trends; strategic analysis, policy making, regulatory needs, legislation and reducing health hazards. Moreover, biological specimens, such as urine, were analyzed in order to detect the presence of controlled drugs therein for individuals and institutions seeking “drug-free” certificates.

Training programs/sessions on scientific aspects of Drugs of Abuse and their identification were conducted for officers of Law Enforcement agencies with a view to enhancing their knowledge and the analytical capabilities that will help them in tracing the origin and effective monitoring of imports, exports and distribution of drugs and precursor chemicals under control, and for the officers of other agencies engaged in drug control activities.

In addition, the NNL has been upgraded to implement the programme of sports drugs analysis as an urgent response to the crisis in sports in Sri Lanka.

The activities are detailed in each Chapter of this report which were performed during the period in order to achieve the Goal of the National Narcotics Laboratory as stated in the Plan of Action i.e. **“To give scientific support to the NDDCB, Law enforcement authorities and other agencies involved in drug control activities and the community.”**

Identification and Analysis of Drugs of Abuse available in Sri Lanka

Research based scientific analysis are conducted as a routine analytical function for the identification and analysis of Drugs of Abuse available in Sri Lanka and the results of these analyses have a significant impact on the country’s law enforcement, crime prevention and health sector.

1.1 Research Project on “Street” Heroin

The “on-going” research project on the following was continued;

- Analysis on the price vs. purity relationship of heroin available on the “street”
- Source identification of Street samples of Heroin
- Identification of new adulterants in street samples of Heroin was continued

This is a project conducted in collaboration with the Police Narcotics Bureau (PNB) who make available to the Laboratory, the samples of heroin from all major areas of Sri Lanka on a monthly basis.

One hundred and fifty nine (159) ‘street’ samples, received, from different areas were analyzed during the year 2014 in respect of adulterants/diluents present and their Diacetylmorphine (DAM) contents. The details of the analysis are as follows;

Samples have been provided for ten months by the PNB and samples were not provided for the months of March and April. Price vs. purity data of Heroin samples sold at retail level on streets of the different cities of ten districts of Sri Lanka are provided below. According to this data the average purity of Heroin is 27.22 % and has shown 2.30 % decrease from the year 2013. The highest average purity of 48.02 % was recorded in the month of February and the lowest average purity was recorded as 8.59 % in the month of October.

1.1.1 Analysis of Alkaloidal Impurities and Diluents/Adulterants in the Samples of "Street" Heroin

Within the framework of this research project, "street" samples of heroin were analyzed to identify the quality of the sample, the area of origin and the link between each sample.

However, more meaningful conclusions could not be obtained as sufficient no of samples from the same area were not provided regularly and therefore this objective could not be fully achieved.

The main alkaloidal impurities which were present in trace quantities are indicated in the Table 04 and Table 05 were analysed by the Gas Chromatography Mass Spectrometer.

Confirmation and destruction of productions of concluded Court cases

At the request of PNB in the month of August, scientific staff of the NNL was participated for the scientific confirmation of the presence of Heroin and Cannabis in the productions of twenty (20) concluded Court Cases. There were sixteen (16) cases for Heroin and four (04) cases for Cannabis and in the month of November, at the request of PNB scientific staff of the NNL was participated for the scientific confirmation of the presence of Heroin and Cannabis in the productions of concluded Court Cases.

The productions, relevant to these cases were destroyed before the Honourable High Court Judge at the premises of the Supreme Courts Complex.

2.3 Provision of Scientific support to the transport sector of Sri Lanka for identification of metabolites of drugs of abuse in suspected cases of driving under the influence of alcohol/drugs and fatal traffic accident cases

The increase of the traffic-related deaths and accidents due to driving under the influence of drugs or alcohol has become a serious problem in Sri Lanka in the recent past. Drugs can cause behavioural impairment of the driver's ability to operate safely. That impairment of driving ability can be tested by analysing the biological specimen of drivers. With regard to this the NDDCB has taken immediate action to take more effective countermeasures to reduce the number of impaired driving accidents and the problem of driving under influence of drugs of abuse.

The proposal was prepared in this regard with the scientific recommendations for identification of metabolites of drugs of abuse in suspected cases of driving under the influence of alcohol/drugs and fatal traffic accident cases. This proposal has been forwarded to the Department of Motor Traffic for their view and comments for further action.

2.4 Provision of technical assistance and scientific recommendations for the establishment of Control mechanism for Import and Export of chemicals/drugs/substances controlled under Single Convention on Narcotic Drugs, 1961 and Convention on Psychotropic Substances, 1971

The NNL is responsible for providing scientific support with technical assistance and making scientific recommendations relating to control of drugs of abuse.

As such, scientific recommendations were provided at the meeting held on 11th September, 2014, at the Department of Import Export Control for which the Chairperson of the NDDCB was participated with regard to take measures on the following;

1. Assigning recommendation Authorities for Import Controlled Chemicals
2. New chemicals that should be included to the controlled list
3. Legal basis of controlling chemicals that are currently under list

Scientific information on the following topics was provided at the meeting;

- Need for control of import and export of chemicals/substances/ drugs in terms of the provisions of the Single Convention on Narcotic Drugs, 1961 and Convention on Psychotropic Substances, 1971
- Requirement of import/export authorisation for those who require licences from the NDDCB in accordance with the above Conventions, this Institution being the National Competent Authority for control of drugs of abuse in Sri Lanka.

Accordingly, a proposal was prepared in this regard with the scientific recommendations and observations.

Enhancement of the capacity of Control Activities of the Law Enforcement Authorities and other agencies involved in Drug Control

3.1 Training programs/sessions (Local)

Training programs/sessions on scientific aspects of Drugs of Abuse and their identification were conducted for officers of Law Enforcement agencies with a view to enhancing their knowledge and the analytical capabilities that will help them in tracing the origin and effective monitoring of imports, exports and distribution of drugs and precursor chemicals under control. Further, training sessions/programmes were also conducted for other agencies involved in drug control activities.

The two-day scientific training programmes on “Strengthening Drug Law Enforcement Capacity on Identification of Illicit Drugs and Precursor Chemical Control in Sri Lanka” was organized in collaboration with the Precursor Control Authority (PCA) and the training objectives were as follows;

1. To provide knowledge on an overview of illicit traffic of Narcotic Drugs, Psychotropic substances and Precursor Chemicals
2. To provide comprehensive knowledge on Narcotic Drugs, Psychotropic substances and Precursor Chemicals
3. To provide practical knowledge on identification of Narcotic Drugs, Psychotropic substances and Precursor Chemicals using field test kits
4. To update participants on new type of drugs

The details of the training programs conducted in the year 2014 are reflected in Table 8.

3.2 Training programs/sessions (International)

At the request of Police Special Task Force a training program was conducted for thirty officers of Maldivian Police Service in order to enhance their knowledge and the analytical capabilities.

3.3 Computer Based Training Programmes conducted for the Drug Law Enforcement Officers

Computer Based Training Programmes on Strengthening Drug Law Enforcement Capacities which is a new integrated global e-learning strategy, was organised by the NDDCB with the technical assistance provided by the UNODC in order to strengthen the drug law enforcement capacities in Sri Lanka.

The objective of the training programme is to strengthen the capacity of law enforcement activities by providing intensive knowledge on following subjects;

- Drug interdiction at sea, air and land border crossings
- Search techniques
- Controlled drug delivery
- Risk management
- Drug identification and drug testing

3.3.1 Implementation of activities

All the training programmes were managed by the NNL and were conducted by Mr. W.D.A. Amarasinghe, Scientific Officer who have been participated at the Training of Trainers for Computer Based Training programme conducted by the UNODC and has been nominated as the Training Manager to conduct Computer Based Training (CBT) Programmes at the NDDCB.

3.3.2 Training objectives: achievement, impact and relevance

Drug law enforcement training is central to the fight against illicit drugs desiring to bring about high calibre-training of drug law enforcement personnel throughout Sri Lanka as a matter of high priority, in terms of the Sri Lanka National Policy for Prevention and Control of Drug Abuse.

Further, standardization of training at a upgraded level with best practices, methods and techniques, enhanced specialised skills, improved operational performance in drug law enforcement activities is very important in meeting the challenge of the ever-changing pattern of illicit traffic in a more effective, cooperative and interactive way.

Therefore, CBT is particularly effective in imparting knowledge and raising awareness of specific issues on modules on above mentioned subjects in law enforcement agencies which are very essential for effective enforcement of law.

3.4 Precursor Control Authority (PCA)

As all the functions of the PCA described in the Section 19 and Section 21 of Chapter II of the Convention against Illicit Trafficking in Narcotic Drugs and Psychotropic Substances

Act, No. 1 of 2008 and the regulations made that under were monitored and the duties of the assigned staff attached to the PCA was overlooked.

3.5 Preparation of Leaflets /Banners on Laboratory Services

In order to promote awareness on scientific services of the NNL, leaflets and banners were designed specially to be presented at the “Dayata Kirula “ Exhibition for the implementation of Strategy 2 of Objective 3 of the Plan of Action 2014 i.e. Advertising & promoting awareness to the general public

Identification and Analysis Metabolites of Drugs of Abuse

In relation to this, biological specimens, such as urine, were analyzed in order to detect the presence of controlled drugs therein for individuals and institutions seeking “drug-free” certificates for a variety of reasons, such as employment etc. Such laboratory results are also useful for the diagnosis and prescribing medical treatment for the drug dependent persons and their rehabilitation process.

The details of the biological specimens analyzed during the period by the NNL in order to identify the presence or absence of metabolites of drugs controlled under the Poisons Opium and Dangerous Drugs Ordinance No. 17 of 1929 and Conventions against Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, No. 01 of 2008 are as follows;

Maintaining the internationally recognized Laboratory Accreditation Standard for the analysis of Drugs of Abuse

5.1 International Proficiency Testing Scheme

The NNL participated for the International Proficiency Testing Scheme conducted by the United Nations Drugs Control Program known as International Collaborative Exercise (ICE).

This exercise allow laboratories, from both developing and developed countries

- To continuously assess, improve and standardize their performance in drug testing on a truly global scale and taking corrective actions.
- To achieve uniform and harmonized results and reporting from all Laboratories.

UNODC provides participating laboratories with unknown test samples (seized materials and biological specimens) for identification and analysis and reference samples needed for the analysis.

International Collaborative Exercise (ICE) – 2013 and 2014

During the period the laboratory participated in the Round 2 International Collaborative Exercises (ICE), 2012 and Round 1 of the International Collaborative Exercises (ICE), 2013 and qualitative and quantitative analysis were performed to establish the presence or absence of narcotic substances in each round of the “seized material” group and in the “biological specimens” group.

5.2 Forensic Toxicology Proficiency Testing Scheme, National Forensic Service in Korea

With regard to the invitation made by the Forensic Toxicology Division of the National Forensic Service in Korea for the proficiency testing scheme called Korea Laboratory Accreditation Scheme (KOLAS), participation of the NNL was confirmed.

The purpose of this Proficiency Testing is to compare the capability of the laboratories performing analysis of illicit drugs, to find out problems, to enhance the quality of measurements and to assurance of results. This proficiency testing scheme is conducted for identification and quantification of drugs in hair samples are supported by the National Forensic Service in Korea. The samples are provided to all participants free of charge.

5.3 ISO 9001 Quality Management Certification

Obtaining of ISO 9001 Quality Management Certification has almost completed with a view to enhancing the scientific capability of the laboratory in the field of testing of Sports drugs and to maintain the Laboratory services with higher standards of practice.

5.4 Training of Laboratory Staff

The Scientific Officer of the NNL was participated for “10th International Training Course on Precursor Chemical Control for Asian Narcotics Law Enforcement Officers” conducted by the Colombo Plan Drug Advisory Programme in collaboration with the Office of the Narcotics Control Board (ONCB) in Bangkok. which was held in Thailand during the period from 24th February, 2014 – 3rd March, 2014.

Performance Enhancing Drug analysis; a New Development Scheme

The Program of Testing of Performance enhancing drug analysis has been proposed to conduct as a research project in collaboration with National Institute of Sports Medicine in order to monitor use and abuse of Performance enhancing drugs among Sportsmen and Sports-women in Sri Lanka.

6.1 Upgrading of the Laboratory

Analytical and Technical Processes indicated below are being continued in order to detect the Prohibited Substances or their Metabolites present in biological specimen and food supplements.

- * Development of Test Methods for the detection of substances present on the Prohibited List and for associated Metabolites or related substances
- * Validation of Test Methods

6.2 Biological Specimen Analysis

Thirty three biological samples sent by the National Institute of Sports Medicine were analysed for prohibited substances.



Report of the Auditor General on the Financial Statements of the National Dangerous Drugs Control Board for the year ended 31 December 2014 in terms of Section 14(2) (c) of the Finance Act, No.38 of 1971.

The audit of financial statements of the National Dangerous Drugs Control Board for the year ended 31 December 2014 comprising the balance sheet as at 31 December 2014 and the statement of income and cash flow statement for the year then ended and a summary of significant accounting policies and other explanatory information was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with Section 13(1) of the Finance Act, No.38 of 1971 and Section 12(4) of the National Dangerous Drugs Control Board Act, No. 11 of 1984. My comments and observations which I consider should be published with the Annual Report of the Board in terms of Section 14(2) (c) of the Finance Act appear in this report. A detailed report in terms of Section 13 (7) (a) of the Finance Act was issued to the Chairmen of the Board on 31 March 2015.

1.2 Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements, whether due to fraud or error.

1.3 Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Sri Lanka Auditing Standards consistent with International Standards of Supreme Audit Institutions (ISSAI 1000 - 1810). Those Standards require that I comply with ethical requirements and plan and perform the audit to



obtain reasonable assurance about whether the financial statements are free from material misstatements.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Board's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Board's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. Sub-sections (3) and (4) of the Section 13 of the Finance Act, No. 38 of 1971 give discretionary powers to the Auditor General to determine the scope and extent of the Audit.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

1.4 Basis for Qualified Opinion

My opinion is qualified based on the matters described in paragraph 2.2 of this report.

2. Financial Statements

2.1 Opinion

In my opinion, except for the effects of the matters described in paragraph 2.2 of this report, the financial statements give a true and fair view of the financial position of the National Dangerous Drugs Control Board as at 31 December 2014 and its financial performance and cash flows for the year then ended in accordance with Sri Lanka Public Sector Accounting Standards.



2.2 Comments on Financial Statements

2.2.1 Sri Lanka Public Sector Accounting Standards

The statement of changes in net assets/equity had not been prepared and submitted along with the financial statements for the year under review as required by Sri Lanka Public Sector Accounting Standards-01.

2.2.2 Accounting Deficiencies

The following observations are made.

- (a) Recurrent Grant amounting to Rs.1,590,000 received during the year under review for the activities of the Board had been accounted as grant received for Precursor Control Authority.
- (b) Accounts payable aggregating Rs.176,622 as at end of the year under review had not been brought to accounts.
- (c) Un reconciled balances of employee debtors amounting to Rs.179,392 and expenses incurred on behalf of Precursor Control Authority aggregating Rs.301,498 had been erroneously accounted as prior year adjustments.
- (d) As a practice, the capital grant received from the General Treasury is treated as Capital Reserve without being identified the intended purpose of the grants. As a result, the capital grant received to procure the property, plant and equipment had not been amortized according to the life times of such assets.

2.2.3 Un-reconciled Control Accounts

The debtor balances aggregating Rs. 9,416,116 shown in the Ledger Accounts had not been agreed with the detailed schedule for debtors amounting to Rs. 9,395,181 furnished for audit.



2.2.4 Accounts Receivable

The following observations are made.

- (a) The sundry advances aggregating Rs.1,906,010 shown in the financial statements had comprised with 16 balances valued at Rs.1,782,060 which remained unrecovered for more than 10 years.
- (b) Age analysis in respect of deposits amounting to Rs.356,813 had not been prepared and furnished for audit. Further, the Board had not possessed the receipts of deposits valued at Rs.295,313 made in 18 outside entities indicating that the possible risk on encashment of such deposits.
- (c) Confirmations had not been received directly from bank and submitted for audit purposes in respect of bank balances amounting to Rs.8,386,750 remained at the end of the year under review.

2.5 Non – compliance with Laws, Rules, Regulations and Management Decisions etc.

The following instances of non-compliances were observed in audit.

3 Financial Review

3.1 Financial Results

According to the financial statement presented, the operations of the Board for the year under review had resulted in a deficit of Rs.15,906,625 as compared with the corresponding deficit of Rs.6,446,755 for the preceding year, thus indicating a further deterioration of Rs. 9,459,870 in the financial results. The increase of depreciation by Rs. 5,060,685 due to revaluation of motor vehicles was the main reason attributed for the deterioration in the financial results for the year under review.

4. Operating Review

4.1 Performance

The following observations are made.

- (a) According to the progress report of the Research Unit of the Board for the year 2014, the persons arrested on drug related matters in recent past four years had been increased significantly as described below.

Further, according to the information published by the Police Narcotic Bureau, 73.57 kgs of Heroin, 24.60 kgs. of Cannabis and 0.19 kgs. of Hashish had been seized in 2014. It indicates that the need of strong policy measures against fast growing trend in drug addiction in urban and semi-urban areas in the country.

- (b) The Board had involved in rehabilitation of drug dependent persons through four Service Centres. The number of persons who obtained indoor treatments from the Service Centres and the particulars on expenditure for the year under review as compared with two preceding years are given below.

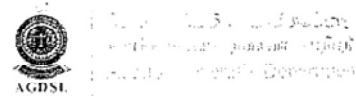
According to the above information, the indoor treatments had been provided for 917 persons during the year under review as compared with 1,192 persons in 2013. The Kandy Centre had treated only for 113 persons in 2014 as compared with other centers, thus indicated the higher average cost of Rs. 28,801 per person in 2014.

- (c) In addition to the indoor treatments, the Board had provided counseling services for the drug dependent persons. In this connection, counseling services had been provided for 1,700 persons in 2014 as compared with 2,021 persons in 2013.
- (d) In addition to the four Rehabilitation Centres managed by the Board, 12 other Rehabilitation Centres are also managed by other Non-Governmental Organizations. However, information relating to the persons treated by such Centres was not made available for audit due to non submission of periodical reports by those Treatment and Rehabilitation Centres to the Board.

4.2 Precursor Control Activities

The following observations are made.

- (a) According to Section 18 of the Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act, No 1 of 2008 and the provisions made under the Extraordinary Gazette No 7/1653 of 10 May 2010, the Minister shall appoint a person or a body of persons as the Precursor Control Authority, who shall be in charged with the responsibility of administrating the provisions of this part of the Act. Therefore, a separate entity for Precursor Control activities had been established and allowances aggregating Rs. 421,000 had been paid to the Chairman and other persons who involving in duties of the Authority. Nevertheless, no separate staff had been assigned instead temporary assignees and other staff of the Board to cover up the duties of the Authority. According to the explanation made by the Chairman of the Board at the discussion held with the officials of the Auditor General's Department on 10 April 2015, it was stated that action had been taken to clarify from the Attorney General whether the Precursor Control Authority is to be treated as a separate body or as a separate unit of the Board.



- (b) The main objective of the Precursor control Authority is to identify, control and stop the misuse of precursor chemicals that have been used to produce drugs artificially and circulated to abuse. However, no evidence had been made available regarding the preventing actions taken to identify, control and stops such activities by the Authority.
- (c) It was observed that, 108 license and 490 registration certificates had been issued by the Authority and a sum of Rs. 2,708,500 had been earned thereon during the year under review. The total expenses of the Authority amounted Rs. 2,705,342 and out of that Rs. 1,905,745 representing 70.44 per cent had been spent to meet the expenses such as salaries, allowances and the travelling of the Authority.

4.3 Management Inefficiencies

The following observations are made.

- (a) Instances of unauthorized exits of the drug abusers from the Treatment Centres were regularly reported and adequate action had not been taken to avoid it. According to the explanation of the Board, unauthorized exits of Treatment Centers by detainee are a regular feature and the Board is unable to take precautionary actions due to lack of financial allocation to maintain a security service.
- (b) According to the information received, 716 complaints had been received against the drugs abuses to the Board, through the dedicated telephone line from 09 April to 31 December 2014, and transferred such information to the Police Narcotic Bureau and the relevant Police Stations for further investigations. However, it was observed that only 124 complaints had been investigated by the respective agencies even as at 28 February 2015.

4.4 Idle and Underutilized Assets

The following observations are made in this connection.

- (a) The land at Urapola with an extend of 18 acres owned to the Board with a coconut cultivation and other crops had not been treated as a source of income of the Board.

Lower seasonal yields had been reported as per records maintained by the Board, thus indicating that the cultivation had not been properly maintained.

- (b) A Generator valued at Rs. 5,040,972 procured on 19 March 2014 had been located at the Head Office of the Board. According to the meter readings, the Generator had been used only 7 hours since its installation up to 10 March 2015, Further a separate log book had not been maintained for the maintenance purposes of the Generator.

4.5 Matters in Contentious Nature

The following observations are made.

- (a) Even though the security service for the office of the Board is provided by the officers belongs to Civil Defense Corporation, the security services for the residence of the ex-Chairperson is obtained separately from two security officers of government owned security firm by incurring an additional cost of Rs. 1,446,092 to the Board since 2012 up to 2014 without a proper approval.
- (b) The land at Homagama, Pitipana estate with an extend of 40 perches had been acquired from the Urban Development Authority under lease basis for 30 years in order to establish a Center for Injecting of Drug Users whilst 90 per cent of the lands owned to the Board located at Urapola and Handessa remained under-utilized by the Board without considering the possibility of utilize the such lands for the respective purposes.
- (c) The Board of Directors had decided at the meeting held on 26 September 2014 to Locate the LED Video Screen in front of the Head Office building of the Board at a cost of Rs.5,055,120. According to the Chairman of the Board, the main objective of locating a LED Video Screen at the Head Office premises is to display drug preventive messages to the general public using modern communication techniques. Apart from that the Board had expected to earn some income by displaying advertisements on this screen. However, it was observed that the screen is located at corner of the premises and not attractive enough to get public attention.



4.6 Legal Cases Filed Against the Board

The following observations are made.

- (a) As per the letter No.Gen/Dms/E3/05/04/006/1 dated 13 October 2008 of the Department of Management Services (DMS), the post of Executive Director of the Board had been upgraded as the post of Director General. According to the Scheme of Recruitment (SOR) approved by the Department of Management Services, the post of Executive Director was abolished. However, former Chairperson had issued a letter on 20 September 2013 stating that the present Director General of the Board had been demoted and returned to the post of Executive Director with effect from 01 July 2008. The Executive Director had filed a case against the Board at the Supreme Court for violation of Fundamental Rights.
- (b) The vacancy for the post of Assistant Director for Treatment Centers had been filled internally in November 2014 and a fundamental right case had been filed by an applicant against the Board on recruitment procedure adopted.

4.7 Human Resources Management

The following observations are made.

- (a) It was observed that the Board had run with vacancies in 06 key posts in senior and tertiary levels and 39 posts in secondary level. Even though the paper advertisements for recruiting suitable persons for the posts of Assistant Finance Director, Internal Auditor, Librarian and other staff had been published in several occasions during the year under review by incurring a sum of Rs.754,936 such vacancies had not been filled even at the end of the year under review.
- (b) It was observed that services from 35 persons had been obtained continuously on assignment basis without being taken action to fill the vacancies permanently.



4.8 **Financial Management**

Out of the advances aggregating Rs.389,760 granted in 41 instances in the year under review, a sum of Rs.151,205 representing 17 to 100 per cent of the advances had been settled by cash without being utilized for the intended purposes. Further, the unsettled balances of advances had remained in hand of the employees of the Board for a period of ranging from 14 to 150 days.

5. **Accountability and Good Governance**

5.1 **Action Plan**

The methodology to measure the actual performance on activities set out in the action plan had not been introduced and therefore, the action plan had not been periodically reviewed in proper manner.

5.3 **Procurement Plan**

The following observations are made, in this regard.

- (a) Capital items, such as Land, Vehicles and Computers procured at a cost of Rs.2,946,362 representing 97.34 per cent of the procurements made during the year under review had exceeded the estimates amount of Rs. 1,492,000 made in the Annual Procurement Plan.
- (b) Capital items procured at a cost of Rs. 14,161,253 were not included in the Annual Procurement Plan of 2014.
- (c) Government Procurement Procedures had not been followed for the procurement of computers and a vehicle valued at Rs. 2,472,938 and Rs.7,995,000 respectively.

5.4 **Internal Audit**

A separate Internal Audit Unit had not been established by the Board and the audit activities were carried out by the Internal Audit Division of the line Ministry. However, neither the Internal Audit Program nor the internal audit reports had been submitted to the Auditor General.


5.5 Budgetary Control

Variations at the ranging from 10 per cent to 100 per cent or more than that had been observed between the budgeted and actual figures for the year under review, thus indicating that the budget had not been made use of an effective instrument of management control.

Deficiencies in systems and controls observed during the course of audit were brought to the notice of the Chairman of the Board from time to time. Special attention is needed in respect of the following areas of control.

- (b) Utilization of Rehabilitation Centers
- (c) Control over Assets
- (d) Stock and Inventory Control
- (e) Cash Management
- (f) Maintenance of Vehicle
- (g) Control over Expenditure
- (h) Attendance and Staff Leaves

Reply for the Report of the Auditor General on the Financial Statement of the National Dangerous Drugs Control Board for the year ended 31st December 2014

2.2.1. Accounting Deficiencies

- In the revised Final Accounts this amount has been rectified.
- This amount has been adjusted in the revised Final Accounts

2.2.2. Un reconciled Control Accounts

Action is taken to reconcile these Accounts

2.2.4. Lack of Evidence for Audit

- (a) Action is taken to prepare a new Fixed Assets Register and update the same properly.
- (b) Action is being taken rectify these matters.

2.2.5. Matters not proved by the adequate authority

- (a) The Land situated at Homagama, Pitipana was acquired by the Board for the purpose of establishment of a Treatment Centre for the Injecting Drug Users. Providing Treatment & Rehabilitation facilities for the Injecting Drugs users is essential and also a responsibility of the Board. However this group cannot be accommodated with the normal drug users, and therefore there was an actual need for a separate place. Distribution of the service of the Board throughout the Country is also a nationally important fact.
- (b) The basic objective of locating a LED Video Screen at the Head Office premises was to give the drug preventive messages to the general public in an effective manner. In the modern world communication methodologies are changed very fast, and we have to select new methodologies to address the new generation. Apart from that the Board expects to earn money by displaying advertisements on this Screen.

2.3 Non compliance with Laws, Rules , Regulations and Management Decisions

1. Action was taken to direct the former Director of Treatment Centres to submit reports to the Board continuously. Thereafter he submitted few reports during the last month. However he has resigned from the Office of the Director of Treatment Centres and no one has been appointed for such Office up to date.
2. Action is being taken to recruit new employees for the post of Manager in keeping with the approved Scheme of Recruitment.
3. The Administrative Division has been directed to report losses on assets belong to the Board , to the Auditor General Department
4. Provision of group transport facility for the Assistant Directors was discontinued and now a common transport facility is provided for all the staff.
5. Action was taken to use these files effectively, after making some changes. However the payment has not yet been settled for the Printer.

4.2 Precursor Control Authority

As per the discussion had with the Officials of the Auditor General's Department by the Officials of the Board, action is taken to get a clarification from the Attorney General on the Precursor Control Authority.

4.5 Idle and underutilized assets

(b) At every time when the electricity supply was discontinued during the last year, the Generator was used. However it is necessary to consider the long-term benefits of the Generator.

4.6 Matter in Contentious nature

At the Board Meeting held on 25th April 2014, the Board had unanimously agreed that the Security Service should be provided to the former Chairperson. Approval, for the provision of Security Officers from Rakna Arakshaka Lanka Ltd to the Chairperson's residence, has also been granted by the Board. However the former Chairperson resigned from the Board during the month of January 2015.

4.8 Weaknesses in the Implementation of Projects by the Board


Projects funded by the United Nations Office on Drugs and Crime and World Health Organization have been successfully carried out.
