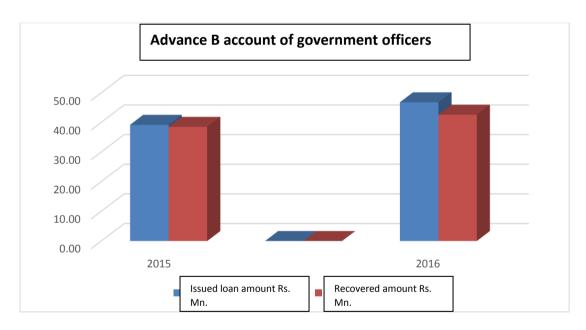


• Rs. Mn. 2.30 was received under General Deposit Accounts in 2016 and out of that, Rs.Mn. 2.25 was disbursed.

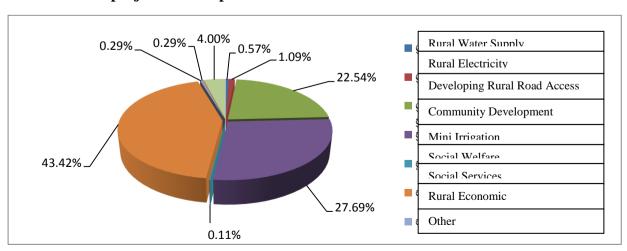
Development Projects implemented in 2016

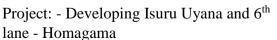
2. Rural Infrastructural Dev

7. Nutrition Program – 2016

This program was carried out with National Nutrition Secretariat of Presidential Secretariat, aimed at enhancing the nutrition status in the country.

Awareness programs were held at the District Secretariat and 13 Divisional Secretariats, for various types of groups such as preschool teachers, school teachers, rural community and field officers in order to achieve below targets through fulfilling nutrition requirements in rural levels identifying nutrition risk bearing families within the district. The cost was Rs, 747,199.75.

Desired Targets

- 01. To reduce stunting and underweight tendency by 40% and to discontinue further growth of overweight children aged less than 5 years from existing situation.
- 02. To reduce the tendency of low birth weight babies, underweight and overweight tendency among women by 30% from existing situation.
- 03. To reduce tendency of Anemia by 50%

Programs implemented by District Secretariat and Divisional Secretariat in the year.

- 01. Creating awareness on multilateral action plan of nutrition for rural nutrition committee.
- 02. Developing awareness among preschool teachers regarding nutrition and social empowering.
- 03. Creating awareness on nutrition and community empowerment among nutrition subject officers who work in divisional secretariats attaching to linear ministries and provincial councils to which the multilateral action plan belong.
- 04. Building awareness among health and nutrition subject teachers in school level.
- 05. Creating awareness of nutrition among staff of District Secretariat and Thimbirigasyaya Divisional Secretariat
- 06. Conducting awareness program for Tamil medium school teachers.
- 07. Conducting awareness program of nutrition for community and pregnant mothers Divisional Secretariat, Moratuwa.
- 08. Conducting awareness program for rural nutrition committee members and pregnant mothers Divisional Secretariat, Kaduwela.

- 09. Conducting awareness program on toxics hidden in luxury foods Divisional Secretariat, Maharagama.
- 10. Conducting awareness program regarding nutrition for mothers of preschool children and women Divisional Secretariat, Colombo.

Several meetings were held with active authorized institutions of development projects in 2016 and it was discussed regarding further actions of development projects and strategies for minimizing problems that may caused in implementing the actions at the meeting held on 17.05.2016. At the meeting held on 03.10.2016, officers were informed regarding the actions that could be taken to complete the projects on due dates discussing the issues arisen at that time and the solutions for them. It was also discussed the issues and necessary actions on completion of projects at the discussion held on 21.11.2016.

It was intended to conduct a post evaluation on development projects which were implemented for measuring the effectiveness of development projects carried out in previous years. A sample of development projects implemented in Grama Niladhari division level was selected as the first step of this evaluation. Several Grama Niladhari divisions were based on some projects when such projects covered more than one division. Accordingly, this survey was conducted in 208 Grama Niladhari divisions of 13 Divisional Secretariat divisions.

02. Methodology

This survey was conducted by development officers appointed in Grama Niladhari division level.

03. The fields selected for the study.

- 1. Roads
- 2. Water
- 3. Electricity
- 4. School buildings/ Dhamma school buildings / "Praja shala"/Maternity clinic / Other buildings
- 5. Minor irrigation
- 6. Providing goods for community/ Voluntary
- 7. Providing direct relief
- 8. Conducting training programs

Information gathered by evaluating on above fields was summarized. The strengths and the weaknesses identified in implemented development projects were submitted to the district committee meeting on 26.08.2016 and all parties discussed and decided to precede the projects so as to minimize the weaknesses and increase the strengths of upcoming projects.

Survey on Flood Disaster in 2016

The flood caused occurring more or less damages in 10 divisional secretariats such as Colombo, Kolonnawa, Kaduwela, Seethawaka, Homagama, Padukka, Sri Jayawardhanapura kotte and Thimbirigasyaya due to overflowing "Kelani" river in May 2016.

This disaster was mostly affected to Kolonnawa divisional secretariat and immediate actions should have been taken to gather information on damaged houses and properties in order to provide relief for the victims. Information was gathered using a questionnaire prepared by deploying officers worked in District Secretariat and Divisional Secretariats.

There was a requirement of gathering accurate information for the purpose of providing relief. Gathered information was computerized and a summarized report was prepared.

As per the District Secretary's instructions, the Planning Division was assigned the onerous responsibility of computerizing survey papers on person and property damages about 25,000. All officers held up their daily duties temporary except emergencies and engaged with the computerization of survey data within a short time period of two weeks dedicating their holidays as well. And printed books for 31 Grama Niladhari divisions were prepared and distributedseparately.

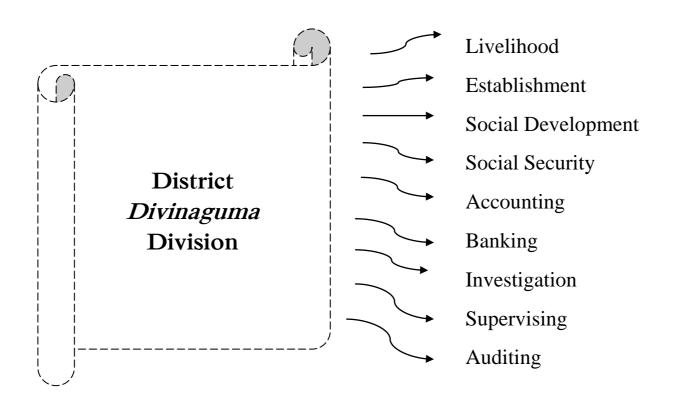

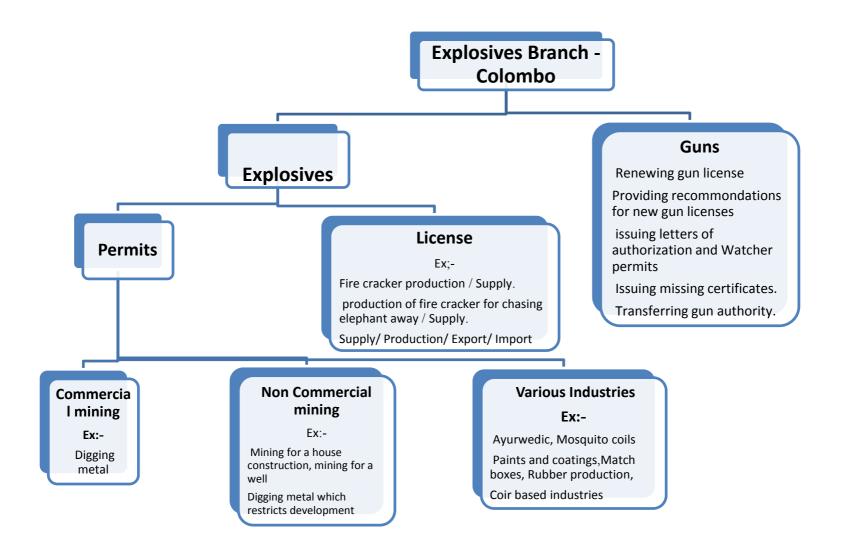

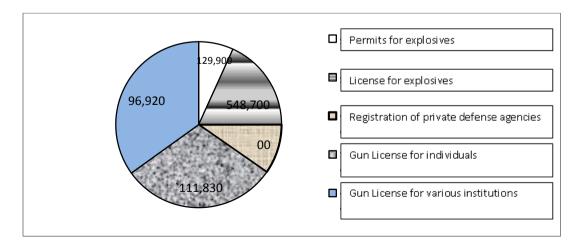

Special programs implemented in 2016

01. Elders' Dhamma school

With the objective of "Creating healthy elder generation filled with physical and mental fitness", this program was implemented in 2014 to fulfill below targets.

- 1. Improving physical and mental fitness of elders
- 2. Offering a practical understanding of ancient Buddhist cultural values.
- 3. Sharing the knowledge of Buddhist philosophic profile and Metaphysics (*Abhidharma*)
- 4. Practicing Buddha's teaching in day today life
- 5. Understanding and practicing on local food beverages, health security methods and life styles.
- 6. Improving the relationship between the villages and the temples.
- 7. Transmitting elder's experience to the future generation.

Education is delivered through lectures, workshops, and practical activities informally in elders' Dhamma School.

Dhamma schools are being operated as one in each divisional secretariat such as Colombo, Thimbirigasyaya, Rathmalana, Seethawaka, Dehiwala and Moratuwa.

02. "Daham Sarasaviya" Dhamma TeacherDiploma

This program is implemented to improve the knowledge of Dhamma school teachers.

This course covers subjects namely Buddhist Philosophy, Buddhist Culture, Psychology and Education Fundamentals, Balancing of Religious and philosophies, Buddhist social consciousness and Pali languages.

University of Sri Jayawardhanapura and Sri Lanka Buddhist and Pali University sponsored for this course.

Students who completed this course successfully will be given the opportunity to follow an external degree from aforesaid university.

This course is implemented by Sri Lanka Buddhist and Pali University for the academic year 2016/17 and 112 students are following the course.

A Diploma certificate is awarded to students who pass the final examination.

In 2015, 86 students sat for the examination and 79 of them passed successfully.

This course has made a huge enthusiasm on Pali Language within Dhamma school scope. Annually more teachers follow this course and obtain the certificates. 146 candidates sat for the final examination held in 2016.

3.13. Disaster Management

10 out of 13 Divisional Secretariats in Colombo district were affected by the flood occured on 15th May 2016. By far the worst affected divisions were Kolonnawa, Kaduwela, Homagama, Colombo, Sri Jayawardhanapura, Seethawaka and Thimbirigasyaya. 228871 people belonging to 54248 families in 246 Grama Niladhari divisions were distressed. It was reported that 6 persons died, 2792 houses were partially damaged and 20023 houses were fully damaged by the flood. Seethawaka Divisional Secretariat arranged accommodation facilities in 171 safety centers for the victims and provided cooked meals and sanitary facilities for them as well as for people in nearby houses under the supervision and the direction of Colombo District Secretariat by utilizing provisions of National Disaster Insurance Fund offered by National Disaster Relief Services Center of Disaster Management Ministry. In addition to cooked meals, dry rations were provided for the people whose houses were renovated. To fulfill this task, the financial provisions were provided through National Disaster Insurance Fund.

24 Grama Niladhari divisions were affected by the explosion at armory of Sri Lanka Army Camp which was established at Salawa, Kosgama in Seethawaka Divisional Secretariat on 05th June 2016 and 2055 houses were damaged. Seethawaka Divisional Secretariat provided cooked meals and sanitary facilities for 1318 people belonging to 351 families in 07 safety centers and nearby houses by utilizing financial provisions given by National Disaster Relief Services Center of Disaster Management Ministry under the supervision and the guidance of Colombo District Secretariat. Apart from providing cooked meals, the Divisional Secretariat took actions to supply dry rations for the people whose houses were renovated. In accordance with the valuations assessed by Department of Valuation, the payments have been made for immovable properties as below.
