Minister in charge of the co-operative subject. The chairperson of the commission will also be appointed by the Hon. Minister from one of these members. These appointees will hold office for a period of three (03) years since the date of the appointment. If a vacant position arises due to resignation, removal or death of a member, a suitable person will be appointed for the remaining period.


