Constitution and Administrative activities of the Co-operative Employees Commission

In terms of the section 04 of the Co-operative Employees Act, No 12 of 1972, the Cooperative Employees Commission consists of three members appointed by the Hon. Minister in charge of the Co-operative subject. The chairperson of the commission will also be appointed by the Hon. Minister from one of these 03 members. These appointees will hold office for a period of three (03) years since the date of the appointment. If a vacant position arises due to resignation, removal or death of a member, a suitable person will be appointed by the Hon. Minister for the remaining period.


As at the Year 2016 Mrs. R.M.C.G. Udugampola held the position of the Chairperson and Mr. I.M.G. Iriyagolla (Attorney-at-Law) and Mr. Bandula Wijesingha (Attorney-at-Law) took office as the members of the Commission.

Sri Lanka Administrative Service officer and the Deputy Director of the Ministry of Industry and Commerce Mrs. Pavithra Jayathissa held the position of acting Secretary of the Cooperative Employees commission.

In terms of section 9(2) of the Co-operative Employees Act, rest of the officers of the commission appoint from the combined services.

As per the section 12 of the Co-operative Employees Commission Act No 12 of 1972, the annual expenditure of the commission is to be allocated by the appropriation Act. Accordingly expenditure for the year 2016 had allocated under the head 302.






