

- Submission of particulars and observation needed for the attorney General regarding the cases referred by the district appellate and supreme courts by adding the officers attached to the Department of Cooperatives respondents. Action was taken according to the instruction given by the supreme court, appeal court and attorney general department

## 02. 9 Execution of Projects and Activities

#### **❖** Nena Shakthi Programe on Promotion of School Cooperative Societies

A series of seminars was conducted in some schools in North Western, Western, Eastern and Central provinces targeting G.C.E O/L exam 2017 under the Nena Shakthi Programme on Promotion of School Cooperative Societies and this Department funded to purchase books for the schools of the students who participated the above seminar. Therein Rs. 50,000.00 and Rs. 25,000.00 were funded to National Schools and other schools respectively. In addition to the programmes conducted targeting G.C.E O/L examination, there were seminars for grade five scholarship examination as well.

Arrangements were made in 2017 to achieve the key objective of "Nena Shakthi" programme is to establish school cooperative societies at national level. Among the initiatives taken in this regard, the model by law on registration of school cooperative societies was distributed among the schools that seminars were held to obtain basic information. Providing funds and furniture for the development of school cooperative society of Kuli/ St. Joseph Maha Vidyalaya as a national level cooperative society is another significant event taken place during the year.

#### Service for the Public

Many people were displaced due to the floods and landslides occurred in the middle of 2017 while a large number people suffered in various ways. We helped such people furnishing dried food, sleeping mattresses, sanitary equipment and kitchen utensils in Ratnapura in collaboration with the Ministry of Industry and Commerce as a social responsibility. Island wide cooperative societies helped such displaced and grieved people and it reveals the commitment of cooperative societies towards human needs.

#### **❖** 95<sup>th</sup> International Cooperative Day Celebration

Island wide Cooperative members celebrated  $95^{\text{th}}$  International Cooperative Day in 2017 with much enthusiasm and interest. On the sidelines of Cooperative Day celebration in 2017 cooperative members were evaluated through the events such as awarding cooperative societies and selecting Cooperative - Prince and Princess selected.  $95^{\text{th}}$  Cooperative Day was gloriously celebrated under the patronage of HE the President in Maligapitiya grounds, Kurunegala. Presenting Future Pan – 2020 of Cooperative Department to HE the President at this ceremony was a significant event.

#### \* 2020 Way Forward

2020 Way Forward was presented to HE the President on 01<sup>st</sup> July of this year to make a new approach for the Cooperative Movement of Sri Lanka and to deliver an more upgraded service for the public and to play the role of cooperative that have not been still touched by the cooperative movement under the guidance of the Ministry of Industry and Commerce. It is expected to update the legal framework and policies of cooperative movement, to incorporate the cooperative movement through a new system of information technology, to improve leadership skills of cooperative members giving training opportunities appropriate for today's modern world, and to execute environmental protection programmes, peace and reconciliation enhancement and programmes on diversification of cooperative products. The ultimate goal of these programmes is to transform the cooperative movement to the third wave of this country. Another significant event our department experienced in 2017 was stating to prepare the Way Forward 2020 making the foundation to achieve these objectives.

#### National Programme on Food Production (Ahara Nishpadana Jathika Sangramaya)

It was a fact to be concerned that the drought occurred in one part of the country while another part was severely affected by floods and landslides due to weather and climatic changes. Under these circumstances, most of the cultivations were destroyed and this was a challenge for the food production in Sri Lanka. Therein the contribution of the Department of Cooperative Development together with cooperative societies for the promotion of home gardens and distribution of seeds under National Programme on Food Production in order to redress the sufferings of the public was remarkable.

#### Project on Cooperative Villages

It was decided to implement a promotion programme targeting income generation accesses of Cooperative Council of Polonnaruwa district under the project on establishing Cooperative Villages. The top level organization of Multi-Purpose Cooperative Societies in Polonnaruwa District and other Cooperative Societies was Cooperative Board. The task of priority of this organization is the responsibilities assigned by this by law to improve knowledge, attitudes and skills of all the members and employees. This is the major training centre for around 150,000 members and 750 of this district. A Board of Directors has been appointed representing member societies it carries out the activities. National Cooperative Board of SriLanka is the major cooperative institute and these district cooperative boards represent its membership on behalf of the district. Hence, this institute could be utilized to train human resources in a large scale and since training seminar hall is useful for this purpose, this department funded to construct this building this year.

Further, funds were allocated this year to take initiatives for the construction of an auditorium for the Cooperative board of Polonnaruwa in order to contribute to maintain an effective economy making the cooperative community knowledgeable of new technologies and improved techniques, take measures to create internationally recognized cooperative policies and customs to make them cooperative members, make the appropriate ground to improve necessary skills to make youth representation for cooperative leadership, give required leadership necessary for improvement of good qualities in school children and children, to train cooperative employees within the improved subject areas that required to improve business and mobilizing female to improve their contribution for community leadership.

#### **\*** To uplift Industry and Producing Cooperative Societies

This Department made arrangements in 2017 to uplift Industry and Manufacturing Cooperative Societies with the objective of promoting cooperative movement. Accordingly, this department funded to renovate "Saseth Printers" of Cooperative Thrift and Loan Society Ltd. of the Department of Health and to purchase a machine to remove coconut shells for Dunagaha Coconut Manufacturers' Cooperative Society Ltd. under the programme of uplifting Manufacturing Cooperative Societies.

#### 02. 10 Planning

#### > Statistics Report

Statistics Report was prepared incorporating the information of societies / associations registered under this Department and the Provincial Departments and this report is important for the cooperative members and the Sri Lankan Community who is enthusiastic about the Cooperative Movement. Accordingly, preparation of statistics report is in progress this year incorporating the information of 2016.

#### > Action Plan

Action Plan 2017 of the Department of Cooperative Development was prepared at the beginning of the year integrating the role of each division with the objectives of planning and making efficient the functioning of this Department. Affairs of this Department were carried out in 2017 as per this plan.

#### 02. 11 Media Activities

Major role of the Media Division of the Department of Cooperative Development is to distribute information on Cooperative Movement to the general public of this country

#### Samupadeepani News Paer

Samupadeepani supplementary has been issued with newspaper from 2006 to achieve the said objective. Samupadeepani Sinhala Medium Supplementary consists of eight pages and Tamil Medium Supplementary consists of one page—are—published last Friday of every month with Dinamina and Thinakaran newspapers respectively in collaboration with United Newspaper—Ltd. Presenting—of comprehensive reports on the islandwide successful cooperative societies, publish of reports from the founding of the Cooperative Movement in Sri Lanka, and presenting of information on the World Cooperative movement are included in Samupadeepani.

#### 02. 12 Information Technology Unit

Cooperative Movement has been competing with public and private enterprises as a giant enterprise within Sri Lankan Economy approximately a period of century. However, due to the fact of difficulty in receiving economic and non-economic information of cooperative movement precisely within a short period of time, it has been neglected in taking economic decisions of the country.

An information Technology Unit was established in the Department of Cooperative Development in 2017 with the objective of establishing an effective Cooperative Movement by finding a solution for this shortcoming through carrying out the affairs of the Department of Cooperative Development through an Automated Management Information System and subsequently integrating Cooperative Movement with this information system.

Accordingly, approval was obtained for a cadre of 8 officers in Information and Communication Technology Service from the Department of Management Services to recruit in the service of this Department. Thereafter, approval of the Secretary to the Ministry was obtained in 2017 for a project proposal on functioning of the Cooperative Department through an Automated Cooperative System and integrating entire Cooperative Movement to Management Information System and University of Kelaniya was selected as the consultancy for this project with the approval of the Secretary.

The Department established an Information Technology Unit in addition to the above project in order to maintain an updated web site and appointed a committee representing an officer from each division and as per a committee decision, came into an agreement with Procons Infotech (pvt) Ltd for a period to maintain the website for a period of one year on the approval of the Commissioner of Cooperative Development. Further, internet facility has been provided to all the officers of the Department through Wifi technology incorporating with the public network project under its second stage.
