Message from the Director of Social Services

The Department of Social Services was established on 1st February, 1948 in accordance with the recommendation in the VII th Sessional Papers of the report of Sir Ivor Jennings Commission appointed for the purpose on 10th July, 1944. At the initiation, the main function of the Department was to provide the financial assistance to estate workers and poor families when they were affected from various diseases and disasters. These programmes, which had been existed at the primary stage, were updated upon the current needs and such reliefs were converted into the livelihood development of the person or family devoid of limiting to the dependent mentality.

Specially, in the present stage that we pass in Sri Lanka, because of the human activities or environmental issues, government will face many current social issues like various disabilities among persons, decrease of fertility, increase of non-communicable diseases, mental distress, suicides, poverty and drug addictions. This situation will make direct or indirect adverse effect to the progression of the person and whole society.

The main aim of the Department of Social Services is to make the communities, who have become marginalized or disadvantaged situation, the active partners of the development, while targeting them towards to arise independently. For this purpose, it was successfully done the implementation of various research, policy planning and development programmes from the grass root level to national level through the participatory development approaches in 2016.

Particularly, we must mention that we have achieved a successful progress in the development programmes which were implemented by the Department in 2016. The welfare programme for the persons with disabilities is one main programme implemented targeting persons with disabilities. Development of the professional skills of the disabled male and female youth, making them participation in the national level competitions while improving their sport and aesthetic skills, providence of the tool kits for the selfemployments' of the trainees who have successfully completed the training, providence of assistive devices, medical assistance, scholarships for the education which are required for the social adaptation in a manner of avoiding some physical weakness of them, supply of health facilities, issue of identity card for the persons with hearing disabilities, providence of sign language interpretation service, mediation to the required development affairs, having identified the disability situations occurred in the early child hood and providence of the residential care to the mentally retarded boy children who have lost the care from the parents, have successfully accomplished in this year. In addition to the above matters, providence of commodes, water and air mattress, providence of access facilities to the homes, set up and empowerment of Swashakhi Organizations for fulfilling all needs of the disabled people living in the grass root level, providence of the infrastructure facilities for improving the skill development centres, providence of the rehabilitation for the drug addicted persons, providence of the vocational training and socialization have also successfully performed.

In order to improve the efficiency, service motivation and improvement of the productivity of officers, who provide the services, were sent to local and foreign workshops, seminars

It is a historical victory that the Department of Social Services won the third place in the National Productivity Awards ceremony held in 2006. During the said awarding ceremony, 06 Institutions among 08 Vocational Training Institutions that are under the purview of the Department of Social Services were able to obtain the awards and certificates.

It is a pleasure that the Department was achieved the success of conducting sports and New Year Festivals, Cultural shows, Poson Bhakthi Gee festival and National White Cane Day in Ape Gama" premises in Battaramulla in line with the International White Cane Day.

It is clearly shown through the financial and physical progress of 2016; very successful results could be achieved from the programmes implemented for the disadvantaged and affected people as a whole. For the recurrent expenditure submitted for the year 2016, Rs. 446,335,000 was received from the General Treasury and Rs. 434, 928,448 was spent for fulfilling the service requirements. For capital expenditure Rs. 50,105,000 was allocated from the General Treasury and Rs. 48, 890,182 was incurred for the relevant activities. Accordingly 97.46% progress from the expected targets has been achieved in 2016.

I must mention here with gratitude that the officers and employees highly committed to the service when it was performed and I take this opportunity to offer my heartfelt felicitations on all members in the staff who have greatly contributed in achieving the mission of the Department.

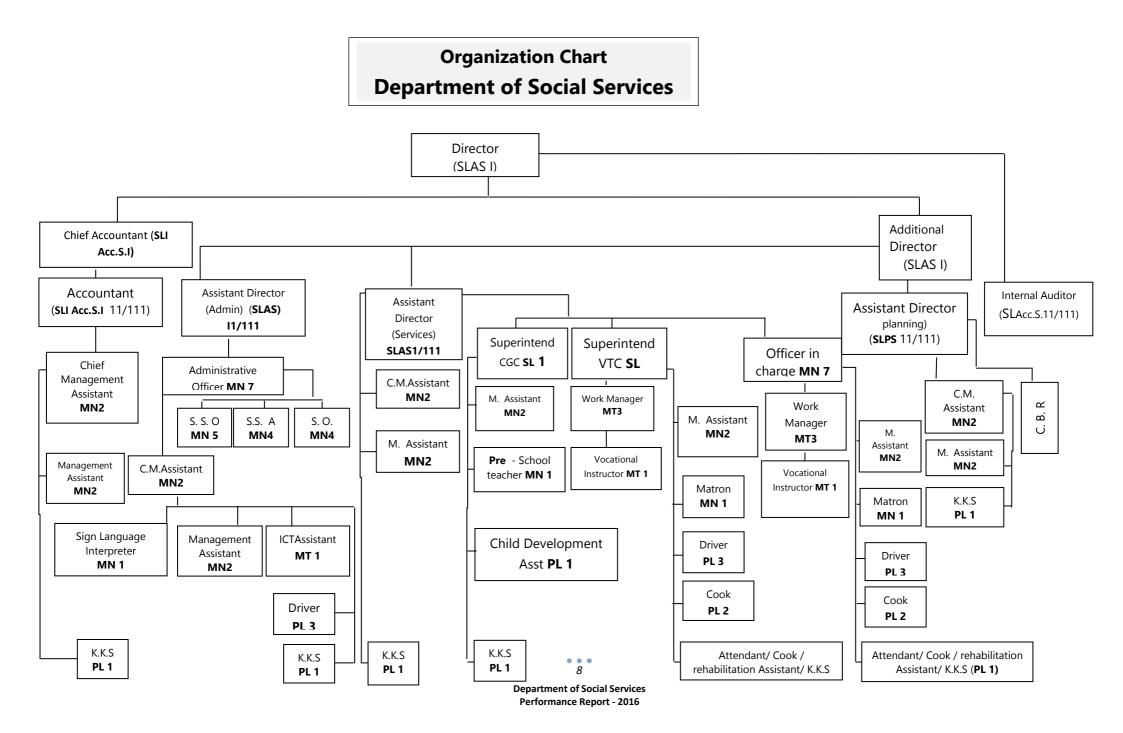

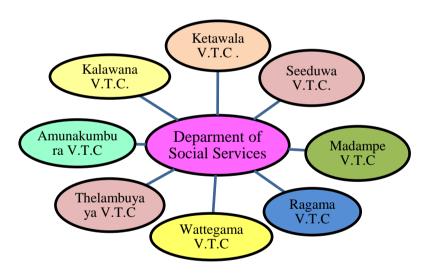

One of the main programme targeting the disabled people is the empowerment of the vocational skills of the male and female youth with disabilities. In view of the objective of providing the required vocational training for developing the livelihood means of the disabled youth, successful results were able to achieve within the programmes implemented in the year 2016.

This project is implemented in 08 Vocational Training Institutes naming Seeduwa, Amunukumbura, Ragama, Madampe, Ketawala, Wattegama, Vibhavi and Thelambuyaya, which are established in 06 districts of Colombo, Gampaha, Kandy, Puttalam, Rathnapura and Hambantota. The disabled young children between the ages 16 – 35 are eligible to follow these training courses. Training period is around one year and during this period they are provided with the required foods, accommodation facilities, health facilities and the training on free of charge. In addition to such facilities they are provided with an allowance to meet their daily expenses. Moreover they have an opportunity of improving their art skills and other activities and which is a fringe benefit of this training. The trainees, those who have successfully completed the training would be given the recognized certificates and tool kits for the self employments. They would be introduced the job opportunities in both government and private sector as per the training they have obtained and follow up activities of such trainees, those who have been associated with people in such way, would be done by the officers in their training institutes.

Specially, not only to improve the vocational skills of the persons with disabilities, but, it makes the required back ground to share the knowledge and training of the disabled people regarding the new technology, communication, art and sport with other people. In addition to the vocational training, providence of special identity cards to the persons with hearing disabilities, providence of allowances to the trainees, who are learning at the voluntary institutions, which provide the vocational trainings, providence of allowances to the pre-school teachers, who teach the children with hearing disabilities and low intelligence, granting maintenance aids and ad hoc aids to the voluntary social institutes which receive financial assistance from the Department of Social Services and providence of the sign language service to the persons with hearing and speaking disabilities are done by the Department subject to this project.

15 Department of Social Services Performance Report - 2016 The programmes for providing the required care for the mentally retarded boy children, who lost their parents and guardians, are implemented by the Puwakpitiya Jayaviru Sevana Children Home. In 2015 the maximum number of trainees was 56 and by September 2016 it was 75. It was able to include 23 trainees in this year due to construction of the new building. These children, those who have been residential for their whole life, are under care with kind and love devoid of making them isolated and they have been referred to the day to day activities.

• Jayaviru Sevana - (Puwakpitiya Care Home)

The programmes for providing the required care for the mentally restarted boy children, who lost their parents and guardians, are implemented by the Puwakpitiya Jayaviru Sevana Children Home. It was able to include new more 23 trainees in this year due to construction of the new building. These children, those who have been residential for their whole life, are under the care with love and affectionate devoid of making such children isolated and they have been referred to the day to day activities. By 31 December 2016, the total number of 72 children was obtained the training.

II. Child Guidance Project

Child Guidance Centre – Maharagama

A doubted situation arises if a growth defect or a stunted growth of a child is in the family or when a child is identified as having some disability, the child should be referred to the Child Guidance Centre. This is the institution, which is located in Nawinna, bears the state responsibility by means of raising parent's mental level, early intervening towards the development of the child, providing basic services and coordinating the heath, early child hood, education and welfare services.

Accordingly, the children, those who are benefitted with the services of this project, will interact to special educational units or normal schools following their proper development.

Objectives of the project

- Introduce a more effective methodology of early intervening in the children who are discovered to have or be at risk of developing a handicapping condition or other special need that may affect their development.
- Strength the service network including the institutes of various fields in connection with the service delivery for children with disabilities.
- Strength the early childhood education and inclusive education of the children with special needs.
- Provide counseling services for raising the mental level of parents and family members.
- Expand the project into other districts.

III Community Based Interactive Development National Programme for the Disabled Persons - C B I D

Objective

The objective of this programme is to empower the disabled persons with knowledge and skills enabling them to enjoy their rights and perform their duties and responsibilities in accordance with the National Policy on Disabilities. Under this programme, water and electricity supply, water mattress, air mattress, providence of access facilities to the houses, repair of houses and supply of roofing sheets, supply of commodes for sanitation purposes, providence of relief for the repair of tricycles and evaluation of assistive schools were performed for the low income disabled persons.

Activities

- Implementing programmes for empowering the persons with disabilities and their family members in knowledge, attitudes and activities.
- Training them by voluntary workers to perform their daily routine activities as an independent person at home, society, pre school, university and working place etc.
- Referring disabled children to access services including the education opportunities for them through the interactive educational system or specialized educational system.
- Empowering them by means of their economy, provide employment opportunities in collaboration with the Ministry of Labour and Private Sector as well as make them for prior preparation towards the employments.
- Taking actions to provide vocational training through vocational training institutes at regional or national level.
- Integrating disabled persons into programmes implemented by other Ministries and Departments such as Divi Neguma, Sports, Cultural programmes.
- Making them actively participation towards various religious, cultural and social programmes.

IV. Visually Handicapped Trust Fund

The positive commitment to the growth of new attitudes has been gradually arisen on the disabled persons in Sri Lanka following the declaration of 1981 as the International Year of Disabled Persons (IYDP). As a sequel to this direction, an Act of Parliament No. 09 of 1992 to establish a fund for visually impaired persons was passed by parliamentary of the Domestic Republic of Sri Lanka. This was published as a Gazette Notification on 6th March 1992. The Government of Sri Lanka has initiated various services in support of the disabled persons in Sri Lanka in line with this Act.

Chapter 3

The Project for Rehabilitation and Socialization of Drug addicts

Puwakpitiya Samadhi Home, which is maintained under the purview of the Department of Social Services, provides the services of rehabilitation and socialization of drug addicted persons. These addicts, who are entered to these Homes, are treated through the residential rehabilitation programmes, anti-toxic treatments, skills development and mental treatments and so on basically at the Samadhi Home. Samadhi Home has been upgraded as a treatment centre to rehabilitate drug addicts through psycho therapeutic & psychological counseling methods and medical scientific approach. For the purpose of mental and spiritual development of the trainees, who enter the Samadhi Home, there are programmes such as conduct of yoga and meditation programmes, engaging in agriculture and animal husbandry activities for making opportunity to spend the leisure time freely, improvement of the friendliness of the trainees and development of the cultural and art skills are implemented in Home. It has been planned to commence vocational training courses to empower their skills and capabilities.

The total number of beneficiates, who were detained in 2016, was 212 and new admissions were 167. During the year, 127 beneficiaries were made associated with people. When considering the age limits of the service gainers in year 2016, the oldest service gainers' age was 58 years. The youngest service gainer was a 12 years old child. It is specially, during the year, there were 47 service gainers, who were below 20 years old. According to the education level, there were not only the graduates and but also some other persons, who never attended the school. Among the service gainers in this year, two persons were graduates.
