1. Message

3.1 Borders of the District

Jaffna District is the northern end of the Northern Province of Sri Lanka, about 410 km away from Colombo. It consists of the peninsula and seven inhabited Islands. North, East and West boundaries of the District are Indian Ocean, South is Jaffna Lagoon and Kilinochchi District. The total land area including Island waters is 1,012.01Sq.km. Jaffna District is divided into four Sub divisions. They are Islands, Valikamam, Thenmaradchi and Vadamaradchi.

There are 1,084 ponds and 2,433 ditches scattered all over the District with connected channels to conserve rain water. Excess water easily drained into the sea/lagoon. The levels are Point Pedro 15.24m, Myliddy 10.8 m, Chankanai 3.04 m and Kokuvil 6.09 m respectively above the Sea level.

3.2 Historical Importance of Jaffna District

During the past historical periods kings were ruled this Jaffna Rajadanee from 13th century. This can be proved with the available sources. Nallur was their capital city and Ariya-kings and thereafter the kings of their places ruled Jaffna District. The important spots – Jamuna Eri, Sangiliyan Thoppu frontage Sangiliyan Entrance, Palace for king and queen are some of the valuable places still in Jaffna. The other distinguished places under British rule are Clock Tower, very popular schwas and the broad roads.

They point out the historical marks of the District. The Nallur Kandasamy Temple, Vannarpannai Vaitheeswaran Temple Perumal Temple, Large Fort are some of the examples of

Building structures which shows architecture and gives more information about Jaffna.

3.3 About Natural Resources of the District

Climate: Jaffna District falls under tropical zone. Peak rainfall is during the months from October to December. During North East Monsoon, there is the Scattered during April to May. The inter Monsoon rain is uncertain. In the year 2017, the rainfall was 1,231.10 mm, temperature between 25.05 - 30.75°C as normally and average temperature was 28.45°C.

Soil: The soil and water resource of the Jaffna Peninsula are both related to the limestone geology of the land. The soils are formed on the marine deposits and sentiments under the influence of sea waves and winds on lime stones. Tile limestone being a porous rock is the source of groundwater for the Peninsula. Well drained and high productive calcic Red Yellow latasol and Red Yellow latasol soil types are found in central areas (60,000Ha). Alkalin saline soil and Regasol are found in coastal areas (26000Ha) and alluvial soil is in Valukai Aru area (10000Ha). In certain areas coral lime stone is available. This different soil types offer scope for cultivation of exotic as well as local crops. Tile depth of soil varies from 90cm- 150cm.

Water: Jaffna peninsula has a source of Ground Water store in the Sub terrain layer of limestone. The limestone is the main aquifer. This aquifer can be found several isolated caves and caverns capable of storing ground water without evaporation losses. It is a excellent aquifer. The entire ground water is generated from percolated rainfall and it forms a freshwater lens beneath the peninsula. It is found



that the fresh water lens do not extend below the base of the lime stone. The fresh water lens is sustained by the buoyancy of fresh water in relation to sea water. Difference in density, (1.0,1.025) giving a ratio of 40:1. That is every meter of fresh water above the sea level requires a depth of fresh water lens of 40m when no mixing between fresh and seawater takes place. There is no sharp interface between fresh and seawater.

Ground water recharge has been viewed as a function of effective rainfall in the Jaffna Peninsula, this occurs only during the annual monsoon rainfall during the period September to January. After losses by direct run - off (about 10-15 percent), only 30 to 32 percent of the rainfall is left over for groundwater recharge. In the past three decades the quality of water in the region has deteriorated due to various reasons. Variability of the rainfall over the region has directly contributed to this as rainfall is the only source of recharge. The ground water in Jaffna peninsula is in danger due to salinity problem. A significant factor that has contributed to increase salinity in the well water has been the indiscriminate extraction of water from the underground aquifers. This has been exacerbated by the increase in population and the rapid rate of extraction using pumps both electric and kerosene driven for domestic and agricultural purpose. Because of low fresh water heads in the underground aquifers large amount withdrawals from wells cause heads to further decline and the fresh water salt water interface to rise resulting in salt intrusions in several areas in the peninsula. The Intensive agricultural pattern adopted in the last three decades also led to the increase of salinity in the water. Several wells once used to supply potable water are not in use now due to the increase of salinity.

3.4 Livelihood Patterns of the People of the District or Main Commercial and Economic Activities

The livelihood of Public of Jaffna District is mainly depends on Agriculture, Animal husbandry and Fishing. Some of them are adhere self employment and Home Industries and get income for their life.

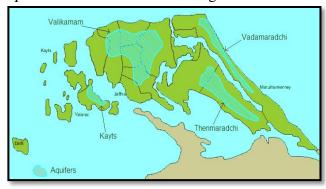

3.5 Irrigation System of the District

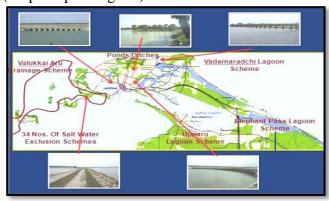
Jaffna peninsula unlike other parts of the island there are no streams or rivers in Jaffna Peninsula, where the land is largely flat. In addition, the topography does not permit construction of reservoirs. This makes ground water is the prime source of the Jaffna peninsula and hence, it largely depends on the annual rainfall received mostly during October to December monsoon rains. Ground water has been the "life blood "of the Jaffna peninsula, there are four aquifers (underground reservoirs) such as valikamam aquifer, Vadamarachchi aquifer and Kayts aquifer as shown in the below figure.



The Jaffna peninsula is blessed with 1,250mm of annual average rainfall over an area of about 1,000sq.km producing 1,250MCM of rainwater. Water supply requirement of Jaffna is only 51MCM, which amounts to less than 5% of the

rainfall. Up to about the nineteen sixties and seventies, even with a greater population than at present, people of Jaffna were able to sustainably meet their water requirement. Agriculture demand of Jaffna is approximately 150 MCM.30% of rainwater goes to sea without using and 50% of rain water loses due to the evaporation.

Fortunately we have potential surface water sources such as Ponds(minor Tanks), fresh water Lagoons, drainage scheme and Salt water exclusion schemes. There are over thousand ponds scattered all over the peninsula and conserve the precipitation to provide water for cultivation of small extents around the ponds and to recharge the aquifer. There are three lagoons which are internal lagoons (vadamarachchi lagoon and upparu lagoon) and external lagoon (Elephantpass lagoon)



The ponds are badly silted due to many years of usage and the capacities are reduced. A program to rehabilitate, improve and desilt the ponds will increase the water resources potential of the peninsula.

The Vadamaradchi Lagoon starts near Uduthurai & Pachilaipalli area and ends at the entrance to Thondamanaru sea mouth with surface areas of about 77 square km consists of 22 nos of flood protection bunds. The main features of Vadamaradchi lagoon are given below.

Catchment area

115 sq. miles

Lagoon water spread - 30 sq. miles.

Upparu Lagoon is a natural lagoon has an outlet structures called barrage, which is located across the sea outfall at Ariyalai between 195 & 196 mile post along Kandy – Jaffna road. Further a separation bund of 4.40km isolating the lagoon from ChemmanySalterns and Paddy fields. This barrage is used to regulate the flood water flow in to the sea and to prevent sea water intrusion in to the lagoon. The main features of Ariyalai Barrage are given below.

Valukkiyaru is a drainage scheme that drained the water from the western sect of the Valikamam area and is covered by four Divisional Secretariats for administration. It contains catchments of 57sq.km in Valikamam North, Valikamam South, Valikamam South West &Valikamam West associated to towns Tellipalai, Uduvil, Sandilipay&Chankanai respectively. This scheme was initiated in 1948, had been operating successfully until the early 80s and had gone into dilapidation since then owing to lack or care and conflict related activities. It has to be emphasized that most of the population were displaced from these areas during these periods primarily in 1985 and 2001, which had a significant impact on the deterioration of the system. Valukkaiaru main channel with the length of 14.5km drains the excess flood water to sea and it consists 08 tributary channels which connects ponds to the main channel and help to drain excess water.



Valukki yaru is a drainage scheme that drained the water from the western sect of the Valikamam area and is covered by four Divisional Secretariats for administration. It contains catchments of 57sq.km in Valikamam North, Valikamam South, Valikamam South West &Valikamam West associated to towns Tellipalai, Uduvil, Sandilipay&Chankanai respectively. This scheme was initiated in 1948, had been operating successfully until the early 80s and had gone into dilapidation since then owing to lack or care and conflict related activities. It has to be emphasized that most of the population were displaced from these areas during these periods primarily in 1985 and 2001, which had a significant impact on the deterioration of the system. Valukkaiaru main channel with the length of 14.5km drains the excess flood water to sea and it consists 08 tributary channels which connects ponds to the main channel and help to drain excess water.

SWE Schemes were built not only to prevent the seawater intrusion but also to facilitate to release flood water during floods. Salt Water Exclusion Schemes and flood protection bunds are essential for conservation of underground water and to convert the low-lying coastal area free from salinity and make the peripheral lands arable with increased productivity in the Manavari cultivation. There are 34 nos of SWE scheme bunds in the coastal area of Jaffna peninsula.

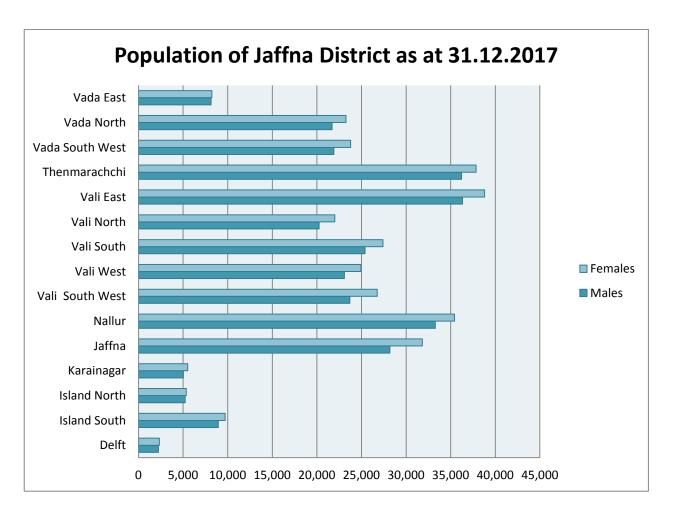

3.7 Rainfall Pattern of the District

The climate of Jaffna is determined by the monsoon that forms a wet and dry season in the District. The major rainy season occurs during the North East monsoons from October to December and the minor rainy season occurs during the South West monsoon in April and May. The period between the South West Monsoon and the North East Monsoon is the dry season extending from June to September. The average rainfall is 1300mm but is highly

variable, spanning a range of 630mm to 1780mm

A distinctive feature of the district is the underground formation of lime stone, in which ground water is stored at depths of 6 to 14 meters. The water is extracted through about 110,000 open dug wells for domestic and agricultural purposes. Surface water is scarce compare to other district, although, the Peninsula originally had two major lagoon schemes, 34 nos. of salt water exclusion schemes, drainage scheme and about thousand small ponds which retained the monsoon rain water which then percolated into the surrounding wells during the



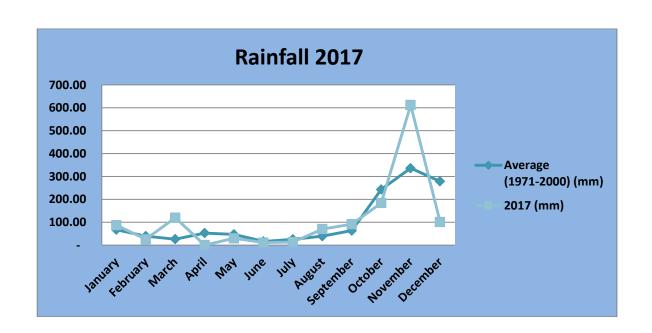


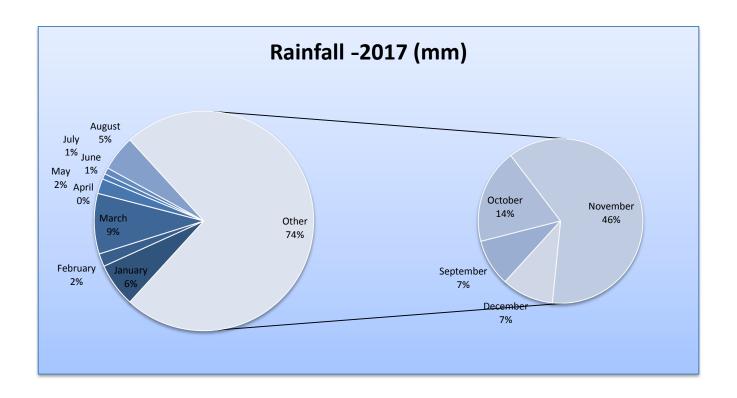
dry season. Now many of these schemes ponds have fallen into silted up and dilapidated condition due to poor maintenance. During the late seventies and early eighties the agricultural activities in the Jaffna Peninsula was at its peak. They lift the necessary water from the underground aquifer. In the earlier days either by their own manual effort or with the aid of animals, now water pumps are used for this purpose and water laboriously lifted from the underground source.

Jaffna depends on the underlying limestone aquifer for its water and the capacity of the aquifer was stretched to its limits. Some of the dug wells, the principal source for fresh water, went dry and many others became saline due to salt water intrusion.

Rain fall 2017

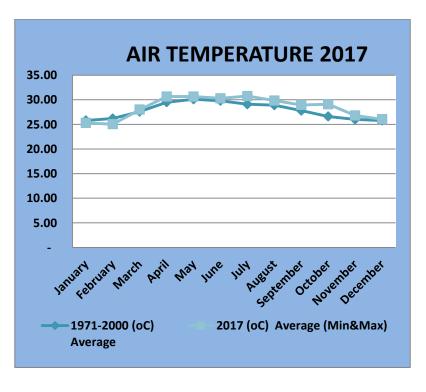

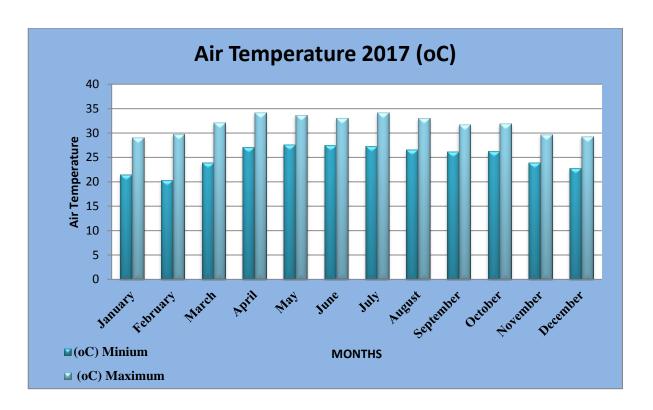

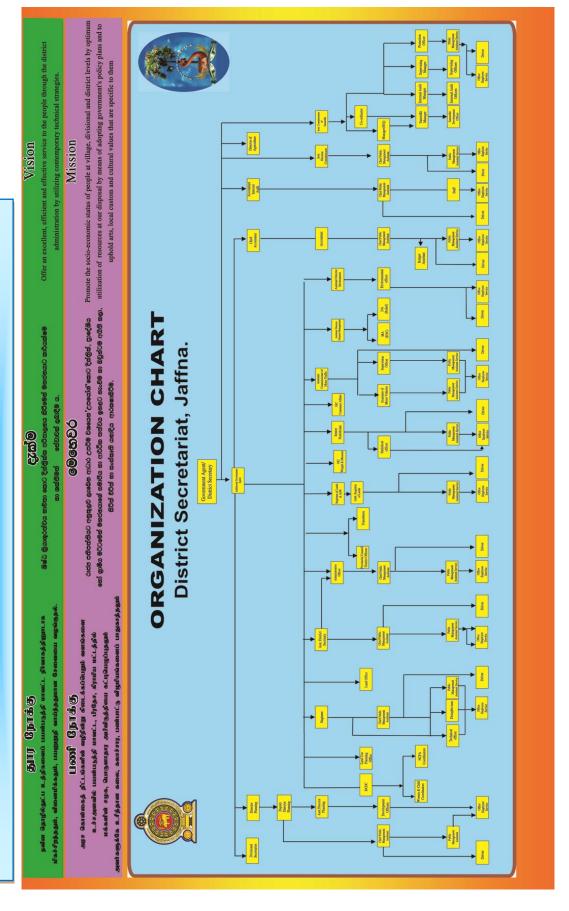

5.1.14 Activities of Department of Census and Statistical

Paddy Statistics – Maha Season 2016/17

Every yearly, we collect paddy statistics for Maha season. Paddy Statistics are collected by Grama Niladhari using P1 forms. Summary of P1 has been prepared by range officer (SO/SA). Finally district summary sent to Agriculture division, Department of Census and Statistics, Battaramulla. Aswedimized paddy land was 27,677.65 acres, sawn was 24,825.54 acres and cultivated area 20,312.16 acres.

Crop Estimation Survey on Paddy Maha 2016/17

Villages were assigned for CES on paddy. Our department staff (SO/SA) and agriculture department (AI) staff were participated for this survey. The survey has been done on Vadamaradchi South West, Vadamaradchi North, Valikamam South, Valikamam North, Thenmaradchi, Valikamam South West and Valikamam East.





Highland Crop Statistics – Maha and Yala Season

Yearly, we collected highland crop statistics for Maha and Yala season. The data collected by GN using HL Register. Permanent crops, Semi – Permanent Crops and Vegetables are collected.

Livestock Statistics

Yearly, we collected livestock statistics as at 30th June, 2017. These data were collected by Grama Niladhari using L1 forms. Division summaries were prepared by range officers. Final district summary was sent to head office. By this data collection, estimated milk and egg production per day respectively were 32967 liters and 106905 eggs.

➤ Annual Survey on Industries, Construction and Services

The above survey was conducted in annually. In 2017, 96 institutions were selected for this survey. Our field officers conducted for this survey in time.

Local Government Statistics

Yearly local government statistics were collected from 17 institutions such as Municipal Council, Urban council and Pradeshiya Sabha. The data contains General Information, Classification of Receipt, Analysis of Expenditure, Summary of Revenue and expenditure estimate.

> Slaughter Statistics

Yearly, slaughter statistics was collected from the 17 local authorities. Each local authority has one or more slaughter house.

Building Statistics

Monthly, the Building statistics was collected from 17 local authorities by our field staff.

► Locally Produced and Agriculture Products (LPAP)

The above statistics was called farm gate price. LPAP data were collected at farms, vegetable and fish markets by field staff in a month.

▶ International Comparison of Prices (ICP)

ICP has started on May 2017. It is one year data collections programme on prices. Data collected Weekly, Monthly, Quarterly and by annually by field staff. Jaffna town and Chunnakam markets are selected for this programme. These prices are comparing with other countries.

> Town Prices

Town price are collected weekly, bi – monthly, monthly and Quarterly at Jaffna Town.

Group 1A form was used to collect weekly. Group 1 form was used to collect twice a month.

Group II form was used to collect monthly. Group III form was used to collect quarterly. Each form has different items.





> F1 Updating

Every month, six or seven census blocks (F1) were updated for Labor Force Survey by field staff. 9/NHSP forms were used to transfer housing unit's data from updated F1. Households were selected from the 9/NHSP forms for Labor force survey.

Labor Force Survey

Every month, LFS were conducted at 60 or 70 housing units by field staff using Tablet (electronic equipment), which first time were used for LFS survey. 3rd week of a month may be reference period and survey conducted on fourth week of a month.

Time Use Survey

The above survey first time introduced in Sri Lanka. The survey was conducted only last quarter. Selected households as same as labor force survey conducted.

Survey on Tourism expenditure

5.1.20 Activities of Regional Consular Office – Jaffna

The first Regional Consular Office of the Ministry of Foreign Affairs was ceremonially inaugurated on 26th January 2017 and it is located in the New Administrative Building Complex of the District Secretariat, Jaffna in the Northern Province.

This office successfully provides the following services to the general public;

- Attest the documents for the acceptance of the international community
- Repatriate the grasping Sri Lankans in overseas
- Assist in order to obtain salary, compensation, legal and insurance dues which should be paid to Sri Lankan migrated workers
- Assist the burial of human remains of Sri Lankan deceased overseas in the overseas or repatriate the bodies of Srilankan in overseas.
- Assist / intervened to secure the release of fishing vessels and their crews that have been detained by foreign authorities
- Inform Sri Lankan citizens living abroad about the special security situation
- Assist Sri Lankan citizens in distress or other emergency
- Assist legal protected for the Sri Lankan citizens in detention or arrest.
- > over the rules of law and fair trials

While we successfully step into the 2nd year of the opening more than 4500 clients have visited our division from various parts of the island such as Jaffna, Kilinochchi, Mullaitivu, Vavuniya, Mannar, Anuradhapura, Trincomalee, Batticaloa, Colombo, Negombo, Kandy, Hatton and Badulla.

More than 10,360 documents were attested up to last December, 2017. Payments are being charged for the registration of 20 births overseas and clients were advised and instructed on further process of birth registration. More than 90 documents were verified externally from courts, universities, technical colleges etc.

Further, more than 1040 affidavits were verified from the Ministry of Justice during this period. 20 applications were received in order to repatriate the human remains of the deceased Sri Lankan abroad and necessary actions have been taken in this regard. 8 applications were received with regard to the compensation and processed for the necessary procedures. More than 55 complaints were placed at our division with regard to the repatriation among them 30 persons were repatriated and continuous actions have been taken in this regard to repatriate the rest.

In addition to the above, the current consular fees charges are revised with effect from 1st of January 2018 which has been notified by an extra ordinary gazette no. 2044/39 on 9th November 2017.

• Resettlement Grant

➤ Housing for Resettled families and Returnees from India

1614 houses were provided for resettled families and 60 houses provided for returnee refugees from India. These houses were constructed by owned driven method and Rs. 800,000.00 provided to each beneficiaries.

For the above housing program priority had been given to women headed families, missing person families due to war, rehabilitated families, death due to war and families under poverty line.









Keerimalai Housing programme

For relocating the landless families in welfare centers, 25 houses are being constructed with the supporting man power of Security Forces. For this construction Rs. 23.53 million released by Ministry of Resettlement.





> Late Mr.V.Sulaxan's Housing

With the approval and financial support of Ministry of Resettlement 20 perch of land purchased and a house is being constructed by Honorable Minister of Resettlement for Mr.V.Sulaxan, student, University of Jaffna, who shot death by the fire accident at Kokuvil. For the construction of this house Rs. 1.68 million released by the Ministry of Resettlement and man power is provided by Sri Lanka Forces.







Land purchase for Landless families in welfare centers

For relocating the landless IDPs in welfare centers, land lots. which identified beneficiaries were purchased and provided for their relocation. In this connection 156 land lots were purchased with the cost of Rs. 52.92 million. 113 houses had provided to the land purchased families.(105 houses in Tellipalai divisional Secretariat, 06 houses in Kopay divisional Secretariat, 01 house in Uduvil divisional Secretariat, 01 house in Sandilipay divisional Secretariats.

> Free Electricity Service Connection for Resettled families

Permanent electric connection was given to the 2050 displaced families and also permanent electric connection was given to the 247 families who got the temporary electric connection with the allocation of Rs.45.00 million by Ministry of Prison Reforms, Rehabilitation Resettlement and Hindu Religious Affairs.

Livelihood Assistance

> Livelihood for fishing community

For upgrading the living standard of fishing family in Jaffna District, Rs. 125 million allocated by Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religion Affairs in 2017. Around 150 varieties of fishing nets and rope were provided to the beneficiaries

in all Divisional Secretariat except Uduvil by North Sea Ltd.

Other Livelihood assistance

990 families in all Divisional Secretariat whom are Resettled families, Returnee refugees, Internally Displaced and Vulnerable had been assisted for livelihood with the maximum of Rs. 100,000.00 per family in 2017. For the above Rs. 75.9 million allocated by Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religion Affairs.





Renovation of partly damaged houses

As per the point system 395 families had been selected for the above in 15 Divisional Secretariat and Rs. 200,000.00 to 400,000.00 provided per family on the basis of the damaged. For this project Rs. 86.996 million allocated by Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religion Affairs.







Development of Education Sector

For upgrading the education sector in resettlement area, Ministry of Resettlement allocated Rs. 98.00 million in 2017. Under this programme 18 schools in Tellipalai, Kopay, Sandilipay, Chavakachcheri and Maruthankerny Divisional Secretariats had been renovated with the cost of Rs. 64.79 million and 08 schools in backward areas were selected and then renovated with the cost of Rs. 33.21 million.





> Infrastructure Development

Under the infrastructure development programme of Ministry of Resettlement Rs.97 million had been allocated and 19 roads reconstructed in 2017. In addition ware house of Nallur MPCS had been renovated with the cost of Rs. 2.7 million and preschools renovation, common hall renovation, cottage of cemeteries, bridges and flour working and aluminum fitting of the survey department done with the cost of 17.6 million.





Renovation of Tanks and ponds

Ministry of Resettlement allocated Rs. 91.7 million for Jaffna District. By using this allocation, 31 canals, bunds and sluices were renovated with the support of Irrigation department, 10 canals, bunds and sluices were renovated with the support of Agrarian Development Department and 5 small tanks were renovated with the support Divisional Secretariats.





Sanitation Project

Under the above programme Rs. 150.16 million released by Ministry of Resettlement in 2017. By using this allocation toilets were provided for 2498 beneficiaries and 134 special need toilets for disable were constructed in all Divisional Secretariat. While choosing the beneficiaries, priority was given to women headed families, disable headed families, missing person's families and rehabilitees.

Drinking Water supply project

Under the above programme Rs. 42.5 million released by Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religion Affairs in 2017. By using this allocation 314 drinking water supply projects were implemented in all Divisional Secretariats. Out of the 314 water projects 176 common well repairs, 120 agriculture wells, 01 tank, 10 water tank and 06 tube wells were constructed. In addition water pipe line for Keerimalai housing programme also provided.





Construction of Agraharam at Karainagar Sivan Kovil

For the above Rs. 10.00 million had been allocated by Ministry of Resettlement and 06 compartment of Agraharam is being constructed with the man power of Sri Lanka Forces. This is for providing accommodation to the Kovil poosakar and related to the temple.









Material supply for making prosthesis and orthotic

Under the above program, for assisting the disable persons due to war, Rs. 13.021 million worth of material provided for making prosthesis and orthotic to Jaffna Jaipur center for Disability Rehabilitation with the funding of Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religion Affairs. The supplier was selected through bidding.

Under the above scheme, Rs. 40.8 million released by the Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu religion Affairs and 51 brick houses (Jaffna – 23 houses, Velanai – 21 houses and Chavakachcheri – 07 houses) were provided to the protracted IDPs for their durable solution. For this housing Rs. 800,000.00 provided to each beneficiaries and houses were constructed by the owners.

> Infrastructure Development

Under the above scheme Rs. 38.54 million released by the Ministry of Prison Reforms, Rehabilitation, Resettlement and Hindu Religion Affairs of the Rs 7.25 million spent for reconstructing the roads, Rs.26.52 million spent for school development, Rs. 4.77 million Spent for water supply and remaining Rs. 3.48 million spent for renovating common hall and library.

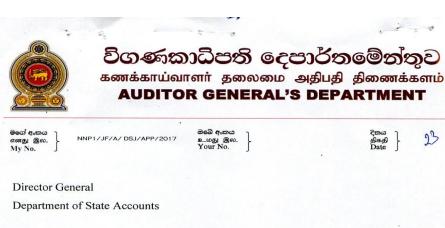

Report of the Auditor General on the Appropriation Account of Head 264 - District Secretariat, Jaffna for the year 2017

The Audit of the Appropriation Account of the Head 264 – District Secretariat, Jaffna for the year 2017 comprising the forms from Form DGSA 1 to DGSA 10 and a summary of information from Notes (i) to (iv) referred to in the State Accounts Circular No. 259/2017 dated13 December 2017 prepared and presented in accordance with Provisions in Articles 148,149,150 and 152 of the Constitution of the Democratic Socialist and Republic of Sri Lanka, the Appropriation Act, No 24 of 2016 as amended by the Appropriation (Amendment) Act, No 32 of 2017 and other Statutory Provisions, the Budget Estimates for the year 2017 and the Public Finance and Administration Regulations including the provision in the Financial Regulations of the Democratic Socialist and Republic of Sri Lanka, was carried out under my direction in pursuance of provision in Article 154(1) of the Constitution of the Democratic Socialist and Republic of Sri Lanka. My observations on the said Appropriation Account which should the published by the Director General of State Accounts in term of Financial Regulation 150 of the Democratic Socialist Republic of Sri Lanka appear in this report.

2. Scope of Audit

The audit involves performance of procedures to ascertain whether the utilization had been in accordance with the limits determined by Parliament by the Appropriation (Amendment) Act, No. 32 of 2017 and No. 24 of 2016 relating to the amounts and disclosures in the Appropriation Account and obtain audit evidence. The procedures selected depend on the auditor's judgment, including the assessment of risks of material misstatements of the Appropriation Account, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the District Secretariat, Jaffna for the preparation and fair presentation of the Appropriation Account in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal control of the District Secretariat, Jaffna. An audit also includes evaluating the reasonableness of estimates made by the management, as well as evaluating the overall presentation of the Appropriation Account.

3. Responsibility of the Chief Accounting Officer and the Accounting Officer for the Appropriation Account.

In terms of Financial Regulations 124 to 127 of the Democratic Socialist Republic of Sri Lanka read with Article 52 of the Constitution of the Democratic Socialist Republic of Sri Lanka, the Chief Accounting Officers are responsible to the Minister of Finance for the adequacy of the Financial Administration relating to all functions referred to in the said Financial Regulations while the responsibility for the supervision of the Financial Administration of the Ministry and the Department under the Ministry, subject to the direction of the Treasury, is devolved on the Chief Accounting Officers and the Accounting Officers. Accordingly the Chief Accounting Officer and the Accounting Officer are responsible for the maintenance, preparation and



fair presentation of the Appropriation Accounts accordance with the provisions in Articles 148,149,150 and 152 of the Constitution of the Democratic Socialist Republic of Sri Lanka, other statutory provisions and Public Financial and Administrative Regulations. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of Appropriation Account that is free from material misstatements whether due to fraud or error.

4. Audit Observations

Subject to the comments appearing in paragraph 4.1 to 4.9 the Appropriation Account of the Head 264 – District Secretariat, Jaffina for the year 2017 had been prepared satisfactorily

Following observations are made.

- (a) Original provision of Rs. 17,094,351 made under eighteen recurrent objects had been reduced by 12 per cent to 84 per cent in eighteen instances, while other six recurrent provisions had been increased by 5 per cent to 65 per cent and four Capital provision had been increased by 32 per cent to 127 per cent. Hence it was revealed that the expenditure estimate had been prepared without proper financial plan.
- (b) Satisfactory reasons had not been given for the transfer of savings aggregating Rs. 8,012,467 ranging from 16 per cent to 84 per cent between ten recurrent object codes. Further the explanations furnished for the savings could not be satisfactorily accepted in audit.
- (c) Savings totalling Rs. 14,373,497 had been exceeded in a range of 08 per cent to 84 per cent under eighteen recurrent objects due to the improper mechanism followed up in preparing the annual estimate of expenditure for the year under review.
- (d) Expenditure made on Installation of intercom system for the Divisional Secretariat, Vadamaradchy East Rs. 71,300 had been erroneously charged to vote No. 264-1-1-0-2002 instead of 264-1-1-0-2103
- (e) In certain instances considerable amount of original provision aggregating Rs. 38,396,000 of the object code 264-1-2-0-1506 and 264-1-2-0-1403 had been reduced by Rs. 1,973,956 in three instances and savings amount also increased by Rs. 2,587,956 due to improper financial plan had been followed.
- (f) Although the works relating to capital had not been commenced, a sum of Rs. 4,814,776 had been paid to the department of buildings (C) on 31 December 2017 for the construction of Elevator (Lift) and installation of Elevator for District secretariat, Jaffna and charged to the expenditure Head No 264-1-1-0-2104 without commence the work up to 30 April 2018. As a result capital expenditure had been overstated by Rs. 4,814,776



4.2 Comments on Other Accounts

4.2.1 Reconciliation Statement of Advances to Public Officers Accounts

Follow up Action on Recovery of Advances made to Public Officers

Following observations were made.

- (i) Meaningful action had not been taken either to recover the outstanding balance of Rs. 622,458 due to the vacation of post, retirement, transferred out of Ministry and interdicted officers. In this regard disciplinary action or to make adjustments in terms of the section 4 of the Chapter XXIV of the Establishment Code of Democratic Socialist Republic of Sri Lanka had not been taken.
- (ii) Proper action had not been taken to recover the outstanding balances of Rs. 264,164 from the responsible officers which were shown as unmoving balance in the accounts.
- (iii) Distress loan aggregating to Rs. 229,315 had been paid to 02 Number of officers who were not confirmed in the service.
- (iv) Distress loan aggregating to Rs. 110,446 had been over paid to 02 officers of the Divisional Secretariat, Jaffna without considering the limit (Rs. 250,000) in terms of Public Administration Circular No 30/2008 of 31 December 2008.

4.3 Comments on General Deposit Account

Following observations were made.

(a) Retention money Rs. 1,721,682 had been kept in the general deposit account without being taken action for more than two years in terms of Financial Regulation No 571.



- (b) Temporary deposits Rs. 1,453,693 which is payable to third parties had been kept in the General deposit Account over six months without being taken action.
- (c) Reimbursement of expenditure Rs. 2,781,072 had been kept in the General Deposit account over six months without being taken action.
- (d) Tender deposits Rs. 55,000 had been kept in the General Deposit account over one year without being taken action.

4.4 Bank Account

Following observations are made.

- (i) An unrealized receipts as at 31 December 2017 totaling Rs. 17,936,175 had been observed in the bank account of the District Secretariat, Jaffna. In this connection the reason for unrealized receipts could not be satisfactorily accepted in terms of Treasury operation Circular No. 04/2014 of 20 November 2014.
- (ii) Two hundred and twenty five numbers of cheques valued aggregating Rs. 64,639,266 had been drawn in the year of 2017 in favour of respective suppliers had been kept in the custody of the District Secretariat and Divisional secretariats without being obtained any good or services. However the services had not been obtained even up to 31 March 2018 and shown as un presented cheques in the bank reconciliation statements since 31 December 2017 up to now. Details are given below.

4.5 Liabilities

Liabilities as at 31 December 2017 had not been ascertained and brought to the appropriation accounts by the District secretariat and Divisional secretariats.

4.6 Losses

Following observation is made.

(i) Losses Rs. 2,403,388 due to various reasons from the period ranging 16 years to 30 years shown in the accounts. In this connection no action had been taken to write off in terms of Financial Regulations 113.



4.7 Non - Compliances with Laws, Rules and Regulations

The following non – compliances were observed.

- (a) A Register of Fixed Assets in terms of the Treasury Circular No.842 of 19 December 1978 and a Register of Fixed Assets on Computers, Accessories and Software in terms of the Treasury Circular No.1A1/2002/02 of 28 November 2002 had not been maintained properly and submitted for audit.
- (b) A Register of Liabilities in terms of Financial Regulation 214 had not been maintained.

4.8 Human Resource Management

- (a) Action had not been taken to fill 112 vacancies by the end of the year under review.
- (b) 315 Nos. of senior and secondary level officers had been allowed to work in excess cadre without being obtained approval from the Director General of Department of Management services.

- (a) Maintenance of Ledgers and Registers
- (b) Utilization of Vehicles
- (c) Advances to Public Officers
- (d) General Deposit Accounts
- (e) Budgetary Control
- (f) Preparation of Monthly Advance Programme by the Staff
- (g) Procurement procedure
