Preface

The key role of this Department is to maintain buffer stocks of rice as per its General Treasury has taken measures in 2017 to make necessary provisions based on the cabinet approval for revamping of 05 department stores with scientific ventilation system in order to accomplish the said task more effectively. Accordingly, stores No. 07, 08 and No. 01, 10, 13 were renovated during the year under review while the provisions were allocated to renovate two mechanically ventilated stores and a natural ventilated store, to provide mechanical ventilation for one store and to complete civil works of two stores scheduled to be operated in 2018. Thus, renovation of 05 stores of 22500 M.T. in capacity was an outstanding progressive task comes under the performance of the department.

The government imported 10000 MT of rice in 2016 for the benefit of the public who faced natural disasters; floods and landslides and this department provided store facilities to stock it. Further this department provided store facilities of 05 renovated stores and one common store with the capacity of 26500 MT in Veyangoda district grain store and a three common stores of 12500 MT in Orugodawatta Central grain store abide by the government decision to store rice imported to control skyrocketing price of rice due to the shortage of rice in the local market in consequence of poor harvest in Maha Season in 2016/2017 and it has stocked 8378 MT of rice in two stores of Vayangoda granary and continued the process of storing rice. It contributed national mission while achieving the objective of maintaining buffer stocks of rice.

Under these circumstances, the department dedicated to take over 05 stores of Orugodawatta Central Grain Store from the private business establishments they had been rented out and utilized for storing food. Hence, the department could re-



establish its authority with the store premises and it was a land of the department in 2017.

The department could credit annual revenue of Rs 5,734,943.27 to the public revenue by renting out the department stores and Dhanyagama houses to the public officers who are serving in that area at a minimum rental. The department was able to achieve such a progress as a result of giving priority to recover rental in arrears. Some residents of Dhanyagama Housing Complex who have been rented out houses had transferred their houses to other people and the department gave priority to legally remove them and recover rental in arrears and could solve number of such problems contribute its progress.

I make this an opportunity to extend my heartfelt gratitude to Hon. Rishard Badurdeen, Minister of the Line Ministry Mr. Chinthaka S.Lokuhetti Secretary to the Ministry who advised and granted necessary approvals to achieve all these targets and the staff of the Ministry and the staff of the department including the Accountants who committed with tireless efforts. I wish new avenues may be opened in the coming year to further precede the mission of the department.

It was decided at the 16th conference of said organization that Sri Lanka should maintain 8000 MT of rice buffer stock to be used at the emergency and disastrous situations of Regional Countries of South Asia.

02. Maintenance of 100,000 MT of rice buffer stock at the island wide Food Department warehouses as per the Cabinet Decision dated 27/08/2008

Food Department has been re structured with the view of maintaining 100,000 MT of rice buffer stock to be used when crisis occur as per the Cabinet Decision dated 27/08/2008

03. Ensure the availability of rice at Market

Equip the consumer with the opportunity of purchasing rice by releasing rice stocks when necessary to the market with the objective of controlling the fluctuation of the price of rice due to the rice scarcity at the market.

04. Effective Co-ordination with the stake holders for the better management of department resources


Contribute state revenue by renting out excessive number of warehouses and houses in order to utilize them effectively on the basis of the estimates of chief valuer.

(04) Administrative Structure and Staff

The administrative and maintenance programmes carried out by The Food Commissioner were in progress.

All the accounts activities of the department were carried by the Accountant himself for the year 2017.

The Trincomalee Housing scheme that consists of 366 houses was managed by Officer In charge of Trincomalee. The store complex at Veyangoda was managed by Officer In charge of Veyangoda stores.

The activities of Legal division of the Ministry were carried out by legal consultant of the Ministry of Rural Economic Affairs (on acting basis) on the approval of Secretary to the Ministry of Industry and Commerce.

By 31st of December 2017 there were 103 employees out of the approved cadre of 227 as 24 Management Assistants of I, II and III grades out of the approved number of 82, 50 Department Employees of miscellaneous positions out of the approved number of 83 were employed in the Food Department.

5% of the total number of cadre served as at 01.01.2017 was retired. Further, it is noteworthy to mention that a new Assistant Food Commissioner was appointed in 2017 to fill the vacancy of the transferred Assistant Food Commissioner.

(05) Auditing and Disciplinary activities

Auditing

Auditor General's Department has established an Auditing Division at the Food Department premises. The regular auditing and auditing of final accounts are carried out by its staff.

The auditing activities of the department are conducted by the Internal Audit Division of the Ministry of Industry and Commerce and the department took measures to send answers for the audit queries sent by the Auditor General and the auditing office at the Food Department with copies to the Ministry and the parties concerned directly.

Accordingly, the Department received 31 Audit Queries by 31st December 2017 and managed to reply 29 and replied for the remaining two in 2018. Further, Audit and Management meetings are chaired by the Secretary to the Ministry and the officers of the department participated the all 4 committees conducted in 2017.







(08). Review of Accounts Activities

The cooperative plan and the action plan of the Food Department had been designed giving priority to achieve the government policy of food security. The annual estimate of 2017 was made to achieve that task.

The annual estimate did not make provisions for certain required objects indicated in the estimate prepared by the department.

Further, expenditure controlling plans that could be controlled were implemented for the objects that provisions have been granted. Transfer of F.R 66 could achieve the procurement plan made at the beginning of the year and additional requirements of the department.

Recurrent Expenditure

Minimum and controlled expenditure policy carried out by the department even in 2017 eased it not to exceed provisions made under the recurrent expenditure by the annual estimate and the surplus of provisions occurred in certain provisions due to the control of the expenditure was transferred to necessary objects after obtaining necessary approval in terms of F.R. 66

The department could be free from the risk of being inconsistent to the accounting rules and regulations and instructions by not exceeding the limits of provisions and having the ability of revising the provisions to the required extent.

Capital Expenditure

The provisions made by annual estimate on capital object were used to the highest level.

Liquidation Accounts

Between the two liquidation accounts of the department, the Advance Account of Kitchen and Bakery has been settled and completed while the other liquidation account; Food Distribution Advance Account is with less possibility of liquidation because of the inability of realization, since its assets are used in the functioning of the Food Department. Writing off the debtors' balances were done as per the approval and working losses were also written off according to the receipt of annual provisions. It is tabulated below.

(12). Process and Progress

Improvement of Income

- 1. Rent/lease out the department stores which are not operated by the department to other institutes and renting out department houses was the major sources of income and among them the revenue received from Rank Container Terminal Pvt. Ltd. and Dhanyagama Prima Houses are outstanding.
- 2. Accordingly, The department has contributed to improve state revenue by crediting Rs. 101,130,285.86 of income from stores and Rs 5,734,943.27 income from houses to state revenue.
- 3. The department took measures to recover Rs.422, 001.38 from the due amount for the goods given to co-operative societies for distribution of food under the Food Stamp System of the Food Distribution Advance Account which is being operated under the department.
 - The department could recover due surcharge balance of Rs. 991,807.90 under the said account.
 - The assets and liabilities of the Kitchen and Bakery Advance Account have been settled and closed.
