Foreword

Annual performance Report – 2017 of the Ministry of Disaster Management is prepared based on instruction given by the Circular No .402 of the Department of Public Finance.

Part I of this report describes General information, overall financial and physical performance of the activities of the Ministry during the period from January to December in 2017. Part II of the report describes performance of activities of the National Disaster Relief Services Center which is under the supervision of the Ministry in 2017.

Introduction

The major factor that contributed for the subject of Disaster Management to become so important was the Tsunami Disaster which occurred on 26th December, 2004 making more than 35000 people lose their lives, and it was an experience never encountered by Sri Lankans. Around 500,000 people internally displaced due to the situation.

The loss of human lives, the economic impact and the social impact caused by this highlighted the necessity of a systematic methodology and a legal framework for disaster management, which remained as a social welfare activity until then. Accordingly a Parliamentary Select Committee was established in order to define an institutional and legal structure which was required to face this type of disasters.

Upon the recommendations of the aforesaid Select Committee, the Disaster Management Act No. 13 of 2005 was passed by Parliament. Subsequently the National Council for Disaster Management and the Disaster Management Centre were established as per the Disaster Management Act No. 13 of 2005. In order to further strengthen the aforesaid institutions a Cabinet Ministry was set up for the subject of Disaster Management and Human Rights as per the Extraordinary Gazette Notification issued on 20th February, 2006 and the Ministry was renamed as the Ministry of Disaster Management as per the Gazette Notification issued on 30th April, 2010.

All agencies, National Disaster Relief Services Center, Department of Meteorology, National Building Research Organization and Disaster Management Center under the purview of this Ministry implement the assigned tasks and particular policy activities of the Ministry pre disaster during disaster and post disaster situation in an effective manner. Therefore, protect the human lives, properties and services, ensure the safety of the community towards a resilient society and implement the post disaster programes.

Mission

To facilitate the prosperity and dignity of human life through effective prevention and mitigation of disaster caused by natural and human induced hazards in Sri Lanka.

 - ➤ Coordination and management of activities in relation to mitigation, response, recovery and relief in natural and man-made disaster
 - Formulation of the National Disaster Management Plan and the National Emergency Operation Plan based on national policies.
 - ➤ Initiation and co-ordination of foreign aided projects for disaster mitigation, response and recovery.
 - ➤ Liaison with Ministries, Government institutes and agencies, private institutes, and local and foreign non governmental organizations to ensure timely execution of above activities
 - Promotion of housing construction with technological standards to withstand environmental hazards
 - ➤ Encouraging research and development into appropriate technology for housing and construction sectors.
 - ➤ Meteorological surveys and researches.
 - Forecasting of natural disasters and sensitizing relevant sectors regarding them.
 - ➤ Co-ordination of the awareness programmes on natural and man made disasters.
 - ➤ Implementation of measures for rescue operations during natural and man made disaster
 - ➤ Co-ordination of international humanitarian relief service programmes.

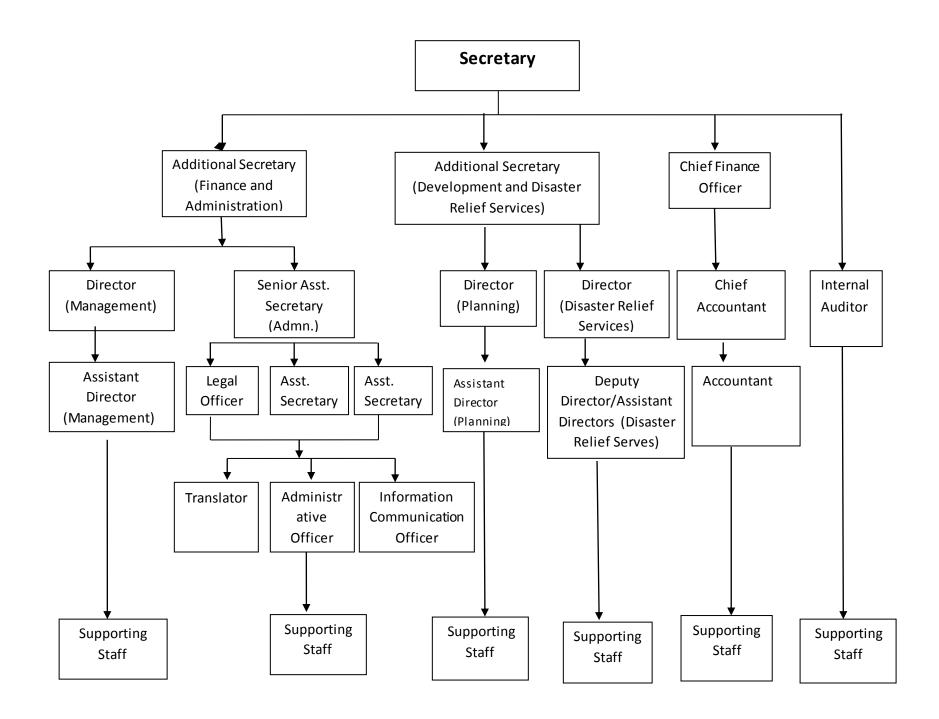

> Transfers/ Retirements

11 employees in the Ministry got transfers and 08 employees have been transferred to the Ministry from January 2017 to December 2017. Two officers retired. 08 Development Officers who were recruited in 2005 were absorbed into the Development Officers' Service.

> Amendments to the Acts

Disaster Management (Amendment) Act which was drafted by the Legal Draftsman was sent to the Ministry and after getting the observations from the institutions under the Ministry, the observations of the Ministry are to be sent to the Legal Draftsman. The legal draftsman drafted the National Building Research Organization Bill and after the approval of the Ministry was given to the Bill it has been sent to the Department of Legal Draftsman to check whether it is consistent with the Constitution.

> Legal Affairs

During the year 2017, 08 cases that made the ministry and the institutions under the ministry respondents were heard in the Supreme Court, Appeal Court and the Human Rights Commission and 24 appearances were made before the Court and the Human Rights Commission.

> International Affairs/Foreign relations – SENDAI Framework

National Disaster Mitigation Programme for Sri Lanka was prepared according to the SENDAI framework and it was sent to the stakeholder institutions and ideas and proposals were obtained in this regard. Ideas and proposals for this programme were obtained in the seminar held for District Secretaries in January 2016 and the final draft is being prepared and the agreement of the stakeholder institutions for the national targets prepared accordingly are being obtained at present.

The Ministry of Disaster Management has planned to conduct programmes to raise awareness among the institutions under the Ministry, the relevant stakeholder institutions related to the disaster management activities, teachers, school children and the general public. Action has been taken to raise awareness among all the sections to focus the attention to disaster mitigation within the whole developmental process. The Ministry of Disaster Management has given priority to prepare base line data on the present situation of Sri Lanka with the support of all the stakeholders to facilitate the progress review of the implementation of the programme prepared according to the SENDAI framework for disaster management. Further all the member countries have agreed to report basic data of national programmes related to SEDAI Framework from the next year.

> Training

Local Training

34 officers participated in various long term training programmes conducted by Sri Lanka Institute for Development and Administration under the skills development of the officers in the Ministry. Further, about 58 officers were participated in high quality programmes

conducted by institutions under other Ministries and 26 officers were directed for special trainings with the support of the National Institute for Labour Studies.

Two instructors from the Department of Official Languages conduct classes to teach Tamil and English.

Foreign Training

09 officers participated in 17 foreign seminars, meetings representing the Ministry. 10 officers participated in 13 training programmes. One lady officer has gone abroad for a two year post graduate course.

> Meetings of the National Council for Disaster Management and its Functions.

The National Council for Disaster Management met twice under sudden disaster situations in 2017. The decisions were taken according to the situation.

> Public Complaints

Through the public complaints service (electronic) "Tell the President" which was implemented with effect from 08.01.2017 the Ministry has directly received 813 complaints. The Ministry received 115 direct complaints and 83 should be submitted to the National Building Research Organization, 608 complaints were for National Disaster Relief Service Centre and 115 complaints for the Disaster Management Centre and 07 complaints were for the Department of Meteorology. The total number of complaints is 1625. Necessary actions were taken to take further action in this regard.

Board of Surveys

Board of Survey for the year 2017 was conducted and necessary action will be taken in the future.

02. Planning and Development Activities

Planning and Development Division carries out the coordinating and monitoring activities of the programmes and the projects on local and foreign funded implemented by the Ministry and its affiliated institutions like Department of Meteorology, Disaster Management Centre, National Building Research Organization and National Disaster Relief Service Centre and the following tasks are performed accordingly.

- 01. The financial activities and the physical progress of the affiliated institutions including the Ministry were reported monthly, quarterly and annually under 8 formats based on the Performance Based Budgeting System introduced by the Department of National Budget from 2017. This helps to utilize the allocations allocated for the relevant year efficiently and monitor the actual progress of each project. Further the maximum utilization of the allocations and minimizing the continuation projects and other activities are expected.
- 02. According to an agreement signed with the UN on 22 April 2016, the Ministry of Mahaweli Development and Environment prepared a report including strategic policies and implementation plans under the Sri Lanka's contribution for minimizing global climatic changes and this Ministry has identified 5 Nationally Determined Contributions (NDCs) decided under the Loss and Damages section and an action plan has been prepared for that. Accordingly, several planning and operational committee meetings were conducted including the relevant stakeholder institutions. Steps have been taken to gather information regarding 64 extreme weather events that occurred from 2000 to 2015.
- 03. 5 new project proposals submitted by the National Building Research Organization to be implemented in 2018 have been submitted to the Department of National Planning for their approval. The expected cost for that is Rs. 22750 mn. Disaster Management Centre has submitted 13 project proposals and the expected cost is Rs. 7365.1 mn. Disaster Relief Service Centre has submitted 1 project proposal and its cost is Rs. 323 mn.
- 04. According to 241 of Public Accounts Circular 402 the annual performance report for the year 2016 was prepared and submitted to the Parliament and action was taken to table it on 16.05.2017.
- 05. The progress report for the year 2017 including the progress of the Ministry and the affiliated institutions which is needed for the budget discussion was prepared and submitted to the Office of the Leader of the House.
- 06. The annual action plan for the year 2017 was prepared by taking into consideration the allocations made for the Ministry according to the budget of the government and sent to the Ministry of National Policies and Economic Affairs with copies to the

- other institutions and the action plan for the year 2018 was also prepared and directed to the relevant divisions and institutions.
- 07. The progress of the Ministry and the affiliated institutions were prepared quarterly according to the action plan prepared for the year 2017 and directed to the relevant institutions.
- 08. The progress up to the third quarter was prepared including the progress of all the projects implemented by the Ministry and its affiliated institutions was directed to the Presidential Secretariat. In addition to that its progress was directed to the Department of Project Management and Monitoring. The progress review meeting to discuss the progress of the final quarter was held in December 2017.
- 09. 07 progress review meetings for the year 2017 were conducted with the leadership of the Hon. Minister and the Secretary and the expected aims were achieved through discussions of problems and follow up programmes of the other development programmes and projects during the implementation.
- 10. As per the facts that were discussed in the Parliamentary subcommittee on economic affairs and the decisions taken, the progress obtained from the institutions that were given responsibilities under the Ministry was sent to the Department of Project Management and Monitoring.
- 11. According to the vision of the Ministry of National Policies and Economic Affairs to "Make the country prosperous" 2025 the policy of this Ministry was prepared and directed to the relevant Ministry. Further action will be taken in the future.
- 12. The facts that were discussed in the Parliamentary subcommittee on economic management and the progress of the implementation of the decisions taken there were directed to the Department of Project Management and Monitoring.
- 13. Since the Disaster Management Centre and the National Building Research Organization are state owned enterprises the progress of those institutions should be reported to the Department of Project Management and Monitoring.

Asian Development Bank Disaster Relief Grant Programme

A project was implemented from June 2016 to June 2017 under the Asian Development Bank Relief Service grant to restore the people in the affected districts due to the heavy floods and landslides that occurred in May 2016. Under this project activities like improving the small scale infrastructure facilities that were damaged due to the

landslides and provision of necessary sanitary facilities to remove waste and debris collected due to the landslides were done. In addition to that the construction of new houses for 11 low income earning families and construction of new houses for 11 houses that were damaged due to the floods and supply of drinking water and sanitary facilities for those people were carried out.

Three safety centers have been built in Kegalle, Gampaha and Badulla districts and disaster victims can take shelter temporarily in those safety centers during a disaster. In addition to that the expenses made for cooked meals that was supplied to the people during the disaster and the expenses made for the transportation of people were settled from this grant. 12 tractor bowsers and 300 water tanks have been given to be used during an emergency.

The total amount of money that was spent for the whole project was Rs. 294.94 million and by June 2017 the project was completed and the completion report was prepared and sent to the Sri Lanka Office of Asian Development Bank.











Sri Lanka Comprehensive Disaster Management Programme (2014-2018)

A project to accommodate global environmental and disaster risk management agreements into the sustainable developmental process in Sri Lanka by developing information technology. (Data project)

The Ministry of Disaster Management and the United Nations Development Programme signed an agreement in October 2017 with the consent of the Ministries of Mahaweli Development and Environment, Land and Digital Technology to implement the project to accommodate global environmental and disaster risk management agreements into the sustainable developmental process in Sri Lanka by developing information technology. By 2017 the programme management unit established under the Ministry is taking action to



fulfill the aims of this project. Accordingly, a policy has now been prepared to share disaster management and environmental data and it has been planned to submit it to the cabinet as a joint effort of the Ministries of Disaster Management, Development Mahaweli Environment. In 2017 a series of training programmes were conducted on Data Management for the officers in the stakeholder institutions that work under the project. programme was conducted with the University of Peradeniya and it was

conducted under two categories. Under the first category a training programme was conducted on Data Management for the executive officers and practical problems in the process of sharing data and information were identified. Under the second category the technical officers who collect, analyze, store and protect data were trained. Action is being taken to provide the necessary computer components to the relevant stakeholder institutions to enter the data into an electronic system and the relevant components have been purchased by now.

Further action has been taken to establish a Meta Data store (electronic) for the environment and disaster management sector and through this general public get the opportunity to access information on data stores, the time period during which data was collected, the areas that have been covered, sharing methods and the data modes (electronic, printed). By facilitating the ability to obtain data on environment and disaster management from a single web site it is expected to create an interest among all sectors about the use of data and information.



Media personnel and media institutions play a pivotal role in disaster management and with the intention of developing it further the media personnel were made aware of the existing opportunities and how to present correct data in disaster reporting. It is expected that in the future the media will raise awareness on physical, human, financial and economic losses due to the disasters.

A study is being conducted to identify problems in the process of providing information and data generated by the local level offices to the national level institutions and to find out solutions for that. Based on the results of that study it has been planned to implement a methodology to solve those problems. It is expected to implement those programmes in Gampaha and Badulla districts as a pilot project.

Climate change adaptation project

This project was commenced from May 2014 with the "Divineguma" Department that came under the Ministry of Economic Development under the United Nations Development Programme. After that as per the cabinet decision no. 15/0519/609-1 and dated 30 April 2014 this project was handed over to the Ministry of Disaster Management and upto now the Programme Management Unit of this Ministry implements programmes to minimize climate change hazards and risks in line with the vision and mission of the Ministry mainly in Kurunegala, Puttalam and Ratnapura Districts. The following tasks were completed successfully.

- ✓ 60 village development programmes were prepared for 60 high risk villages in Kurunegala, Puttalam and Ratnapura Districts.
- ✓ Capacity building programmes were conducted in the North Western Province and the Ratnapura District for Government Officers targeting the agricultural field.
- ✓ 34 minor tanks that belong to cascade system in Mahanneriya near the Mee Oya river basin in the District of Kurunegala were repaired with the support of the Department of Agrarian Services.
- ✓ Farmer fairs to sell agricultural products and 10 Centre's to collect agricultural foods have been established by now.

- Check the extent to which the assets of the institution have been protected from all types of losses and damages.
- Check whether instructions given in the Establishment Code, Financial Regulations and Public Administration Circulars and the circulars issued by the General Treasury are followed.
- Check the success of the internal administrative system to prevent waste, corruption and unnecessary expenditure and to reveal such things.
- Check whether the accounting procedure and property and assets of the institution are used properly.
- Conduct special investigations when necessary.

National Disaster Relief Services Centre

Part 11

National Disaster Relief Service Centre

1. Introduction

National Disaster Relief Service Centre was established in 1996 as the National Disaster Management Centre under the Ministry of Social Services and Welfare. It came under the Ministry of Disaster and Relief Services by the gazette notification no. 1422/22 and dated 08.12.2005 to plan and implement relief, rehabilitation and reconstruction activities. It was named as the National Disaster Relief Services Centre by the gazette notification no. 1482/9 and dated 09.01.2007 and it was assigned to the Ministry of Resettlement and Disaster Relief Services. As per the gazette notification no. 1651/220 and dated 30.04.2004 it functions under the Ministry of Disaster Management.

National Disaster Relief Services Centre is situated in Colombo 07, Vidya Mawatha and functions under the advice and guidance of the Hon. Minister of the Ministry and the Secretary of the Ministry of Disaster Management. Its projects and programmes are implemented through the relevant District Secretariats and Divisional Secretariats according to the advice given by the Ministry of Disaster Management. At the same time under the monitoring of the relevant District Secretaries Development Assistants (Disaster Management) Development Officers (Disaster Relief Services) work as Disaster Relief Coordinators.

2. Vision

Towards safer Sri Lanka through superb post disaster relief services

3. Mission

To protect human life, properties and environment from both natural and man-made disasters through disaster relief activities.

4. Objective

To contribute the national objective of sustainable development through minimized human suffering and loss and strengthening national capacities for disaster relief.

5. Activities

- Prepare and implement programmes and projects to provide emergency relief to the disaster victims.
- Provide relief to reconstruct houses damaged due to disasters.
- Provide guidelines to build disaster resilient houses to resettle people in disaster high risk areas and implement it.
- Implement National Natural Disaster Insurance Scheme.
- Manage local and international level relief.
- Raise awareness among people and public officers to face post disaster situations.
- Conduct training and awareness programmes for the officers engage in post disaster activities.
- Implement foreign aid projects.

7. Progress of the programmes that have been implemented in 2017 by the National Disaster Relief Service Centre (NDRSC).

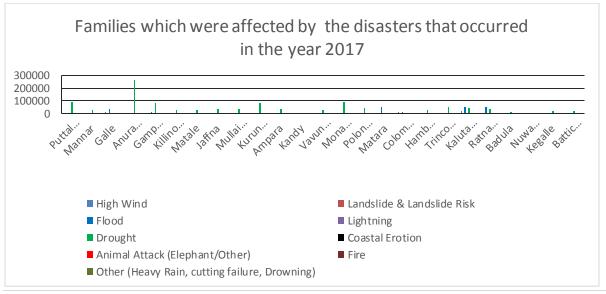
NDRSC plans, implements and monitors the disaster relief activities. Such activities are carried out according to the National Budget Circular 03/2016, National Natural Disaster Insurance Policy and the Cabinet approvals obtained from time to time and instructions from circulars. In the year 2017 the island faced a number of disasters and the NDRSC played a major role in post disaster response activities. The landslide occurred in Meethotamulla solid waste disposal site in April 2017, floods and landslides that occurred in May 2017, drought that occurred in many parts of the country from January 2017, cyclones that occurred in November 2017 are the major disasters. The activities performed by the NDRSC during those disasters are as follows.

- Report disaster incidents and prepare disaster situation reports
- Provide immediate disaster relief
- Provide insurance compensation under the national natural disaster insurance programme
- Obtain local and foreign aid and distribute them among victims
- Purchase disaster relief material and distribute them
- Implement foreign aid projects
- Implement resettlement programmes construct new houses

7.1 Provide immediate relief to the appropriate beneficiaries through an efficient disaster relief service.

NDRSC releases provisions to provide immediate relief to the victims of natural and manmade disasters and using such provisions the relevant Divisional Secretariat Divisions fulfill the basic needs of the people. From the initial stage of a disaster to the final phase, provision of cooked meals, dry rations, drinking water, other relief material, aid for funerals and all other facilities needed for camp management are done according to the circulars.

The number of people affected from disasters that occurred in this country upto 31st of December 2017 are shown in the table below. Accordingly, from the beginning of the year 2017 we experienced a drought, lands lide at Meethotamulla garbage disposal site, floods and lands lides in May, and many other disasters and 1,415,650 families were provided with relief and it was done under the monitoring of the NDRSC.

7.2 Implement National Natural Disaster Insurance Scheme

National Natural Disaster Insurance scheme which was presented as a budget proposal was implemented throughout the island by the National Insurance Trust Fund and National Disaster Relief Service Centre with effect from 01 April 2016. This insurance policy covers Tsunami, earthquakes, floods, landslides, cyclones and storms (drought is not covered) and the victims are provided with cooked meals, dry rations, insurance covers for deaths, insurance compensation for damaged houses, furniture, small and medium scale industries and equipment, machinery and assessed value of stocks that belong to those industries. The contribution of the government for the annual insurance installment for 2017 was 500 million. Under the National Natural Disaster Insurance Scheme Rs. 15 billion worth insurance coverage is given and out of that Rs. 2.5 billion are allocated annually to provide immediate disaster relief. Under the property damage caused by the natural disasters there is an annual insurance cover of Rs. 12.5 billion for the damages caused to the small and medium scale industries' building damages.

7.2.1 Provide immediate relief to natural disaster victims.

To provide immediate relief to the disaster victims, national natural disaster insurance scheme has introduced an insurance cover of Rs. 2.5 million. Under the system that existed up to now the compensation paid as funeral aid for the loss of a life was Rs. 15,000/- but now there is an insurance cover of Rs. 100,000/- for a death. For the following natural disasters compensation is paid under the national natural disaster insurance scheme as per the provisions made to provide immediate relief in national budget circular 03/2016,03/2016(1).

Tsunami or earthquakes - Rs. 500.00 mm

High floods, storms or such natural disasters - Rs. 100.00 mm

Minor floods, wind or similar natural disasters - Rs. 50.00 mm

Landslides - Rs. 25.00 mm

Accordingly, to provide immediate relief to the victims of natural disasters under the national natural disaster insurance scheme, the NDRSC has provided cooked meals, dry rations, drinking water and compensation for loss of lives at a cost of Rs. 140.2 million as at 31.12.2017.

7.2.2. Provide compensation for damaged houses, small and medium scale enterprises and furniture.

Under this insurance policy an insurance cover of maximum Rs. 2.5 million has been introduced based on the damage assess estimate for the houses and small and medium scale enterprises damaged from natural disasters. (In earlier situations under the methodology to provide relief Rs. 100,000/- was given for a fully damaged house and Rs. 50,000/- for a partially damaged house for persons who have a maximum monthly income of Rs. 5,000/- but under this policy compensation is paid without considering the income limit. Small and medium scale enterprises that do not have another insurance cover and do not exceed the annual income of Rs.10 million are entitled to get benefit from this scheme.

Get compensation for the damaged property due to the floods and landslides that occur in May 2017

An advance of Rs. 10,000/- was given to the home owners to repair their houses immediately until the applications are submitted after completing the damage assessment to provide compensation for the damaged houses due to the floods and landslides that occurred in May 2017.

Accordingly, in order to minimize loss of lives caused by landslides, resettling of families living in high risk zones in alternative lands is done under the supervision of the District Secretary with the following three options, and the required funds and the necessary guidance are provided by the National Disaster Relief Services Centre:

- providing a sum of Rs. 1.6 mn for the purchase of a land with a house;
- for the purchase of a land and construction of a house, providing a sum of Rs. 0.4 mn for the land and 1.2 mn for the construction of the house; and
- providing a sum of Rs. 1.2 mn for the construction of a house in a state land.

The number of houses located in high risk zones as identified by the National Building Research Organization as at 31.05.2017 is shown in the following table.

7.4 Programmes implemented for the victims of the drought in 2017

A total of 3,944,176 people in 24 districts were affected by the drought situation that affected the country in 2017, and a number of programmes were implemented by the National Disaster Relief Services Center to provide relief to the victims of the drought. A total of Rs. 5,515.04 million was spent on activities such as releasing of funds to District Secretariats to provide drinking water, providing tractors and bowsers for transporting water, providing dry rations, paying compensation for damages to cultivations, and distributing rice among the affected people.

Releasing funds to District Secretariats to provide drinking water

In order to fulfill the drinking water requirements of the drought-affected people, National Disaster Relief Services Centre, in year 2017, provided the District Secretaries with 6,160 water tanks and 157 water bowsers that included 121 tractor-bowsers and 36 lorry bowsers required for transporting and storing water. These bowsers included 16 lorry bowsers that were received from India and Korea as disaster aid, and 20 lorry bowsers and 125 tractors that were purchased by the National Disaster Relief Services Centre.

A sum of Rs. 115.7 million was provided to the 23 districts that were affected by the drought. Using these funds, the District Secretariats, together with the Pradeshiya Sabhas and the National Water Supplies and Drainage Board, made arrangements to provide drinking water to the affected people.

7.4.1 Providing dry rations to families whose agricultural activities were affected due to the drought

In terms of the draular No. NDRSC/2017/01 dated 02.08.2017 issued under the decision taken on the Cabinet Memorandum presented by H.E. the President in order to ensure the protection of the living condition of the agricultural families and agricultural labourers who have been affected by the drought, dry rations worth Rs. 4,000 per month, i.e. Rs. 2,000/- for each two-week period, was provided to families with less than three members, and dry rations worth Rs. 5,000 per month, i.e. Rs. 2,500/- for each two-week period, was provided to families with three or more than three members.

Four installments of this dry-ration assistance were provided to the recipients since August. A sum of Rs. 3.4 million is spent on providing this assistance. Provisions amounting to Rs. 6,500 million were granted by the Ministry of Finance for this programme, and as at 31.12.2017, provisions amounting to Rs. 6,116.16 million were distributed among 19 districts to provide the four installments

of this assistance. An amount of Rs. 5,025.9 million is reported to have been spent on this programme by 31.12.2017.

7.4.2 Drought assistance for cultivations

This drought assistance for cultivations was given to the members of families whose cultivations were destroyed or abandoned as adequate water was not available in the Maha season in order to protect the livelihood of the members of those families, and accordingly, a financial assistance of Rs. 10,000.00 was given following the Cabinet decision given on 04.04.2017 for the joint Cabinet memorandum No. 17/0736/728/010 dated 03.04.2017 entitled 'Providing Relief to Famer Families Affected by the Drought in the Maha Season' that was submitted jointly by the Ministry of Agriculture and the Ministry of Disaster Management.

Accordingly a total of Rs. 5,233,360,000.00, i.e. Rs.10,000.00 for each family, was given by the Agriculture and Agrarian Insurance Board to 523,336 farmer families in 24 districts.

7.4.3. Food for work programme

"Food for Work" programme is implemented with the participation of the members of families affected by the disaster situation in order to protect the livelihoods of the families who are engaged in agricultural activities (such as cultivations, animal husbandry, fresh water fishing) for which the drought assistance for cultivations is not provided and could not do their agricultural activities as their cultivations were destroyed or abandoned since adequate water was not available due to the extremely dry weather condition. Under this programme development activities that can be implemented using more labour were implemented in the areas where there was very dry weather and each of the families that participated in those activities were provided with 50 kg of rice.

A stock of 10,000 metric tons of rice was received from the Government of Pakistan, 100 metric tons of rice was received from the Government of India, and 2,752 metric tons of rice was received from the Government of China, and altogether 11,966.75 metric tons of rice were distributed among 267,506 families — 50 kg for each family — in the districts of Moneragala, Anuradhapura, Puttalam, Kurunegala, Mannar, Vavuniya, Jaffna, Mullativu, and Killinochchi.

7.5 Providing relief to people who were affected by the explosion in the armory in Salawa Army Camp

Although lives of the civilians were not lost due to the explosion that occurred around 5.45 p.m. on 05.06.2016 at the Salawa Army Camp in Kosgama in Seethawaka Divisional Secretary's Division, houses, shops, moveable and immovable property and other assets in the surrounding areas were damaged. According to the information that had been collected by the Seethawaka Divisional Secretariat, the number of houses and business places that were completely destroyed was 161 and the number of those that were partly damaged was 345. Apart from that 1,322 minor damages to houses were reported, too. Contribution of the Department of Valuation was given for assessing the damages for paying compensation, and all other activities of providing relief were fulfilled under the supervision of the Ministry of Disaster Management with the support of the government institutes such as Colombo District Secretariat, Seethawaka Divisional Secretariat, Sri Lanka Army, Police Department, and the Pradeshiya Sabha.

Accordingly, using the allocation of Rs. 1,287.07 million that was received from the Treasury, action was taken in year 2016 to provide immediate relief to the victims, to provide funeral aid, to pay compensation for 1,949 houses and business places of which the damages had been assessed, to pay compensation for 684 household items/equipment that had been damaged, to provide an allowance of Rs.10,000 each to 238 self-employed persons, and to pay compensation to 147 farmers for damages to agricultural works and animals. Moreover, appeals requesting compensation are being received further, and provisions have been granted for them, too, according to assessed values.

Provisions were granted by the Treasury for paying further compensation in year 2017, and the progress of providing relief to the affected people utilizing those funds are shown in the following table. Accordingly, a total of Rs. 1,289 had been allocated by the Treasury for providing relief to the people who were affected by this disaster.

7.6 Providing relief to the victims of the collapse of the garbage dump in Meetotamulla

The right hand side of the garbage dump in the Dahampura Grama Niladhari Division in the Kolonnawa Divisional Secretary's Division collapsed around 3.00 p.m. on 14.04.2017. Thirty three (33) persons were killed in this emergency disaster while 111 houses were damaged. The number of vulnerable houses that were removed from the area was 163. Action was taken to remove the victims from the area, to take them to safety Centre's, and to provide them with cooked meals and other necessary relief items. Further, provisions were granted for developing two buildings of Meetotamulla Paddy Storage Complex as a welfare centre, and one of those two buildings was developed to accommodate 25 families while the other could accommodate 10 families.

Providing relief to the victims of this disaster was done as per Cabinet approvals No. @@17/0849/715/012, @@17/0849/715/012-II, @@17/0849/715/012-II, and @17/0849/715/012-IV. By now action has been taken to construct and handover 170 houses to householders whose houses were damaged and to those whose houses were removed from the vulnerability zone – 98 houses under the first and the second phases and 72 houses under the third phase – and provisions have also been granted to pay compensation for the houses based on the assessed values.

Necessary provisions were released to pay compensation of one million rupees each to the next of kins of 31 persons who were killed in this disaster. Accordingly, the government spent a total of Rs. 812,961,000.00 million for providing relief to the people who were affected by this disaster.

7.7 Providing relief to the victims of the landslide that occurred in May 2016 in the Kegalle District and to the people who were affected by landslide risk and flood disasters

On 16th May 2016, a landslide occurred in Ramasara Kanda in Aranayake in the Kegalle District killing 31 persons and 99 persons went missing in this landslide. Due to the heavy rainfall that was reported from the Kegalle District during these days, there occurred flood and landslide disasters in 11 Divisional Secretary's Divisions, and 21,234 persons belonging to 5,804 families were affected by these disasters. (According to the records on disaster situations in May 2016 available with the National Disaster Relief Services Centre.)

National Disaster Relief Services Centre, with the coordination of the District Secretariat, Kegalle, made arrangements to provide immediate relief to the people affected by those disasters through the relevant Divisional Secretaries. As at 31.12.2017, there were 61 tents that were being used as temporary welfare centres. In year 2017, provisions of Rs. 3.15 million were granted for providing cooked food and dry rations to those affected people.

According to the landslide risk surveys that were carried out in the Kegalle district in years 2016 and 2017 by National Building Research Organization, about 1,956 completely damaged houses were identified in the high risk zones, and it was recommended that the families living in those houses should be relocated.

Construction of Sri Lanka China Friendship Village

Government of Sri Lanka received financial assistance as well as material assistance for providing relief to the people who were affected by the disaster situation that occurred in a number of districts in May 2016, and construction work of 60 houses has been completed utilizing the funds amounting to \$1.5 million that were received from China. It has been planned to hand over those houses to the beneficiaries in January 2018.







7.8 Management of the aid that is received locally and from other countries

National Disaster Relief Services Centre is the body that handles clearance of foreign aid on behalf of the Ministry of Disaster Management. National Disaster Relief Services Centre had to obtain assistance from foreign countries and organizations with the coordination of the Ministry of Foreign Affairs in providing relief to the people affected by the disaster situation in 2017.

Japan, Korea, China, Pakistan, Indonesia, India, Australia, and Russia are among the key countries that provided disaster relief materials, and a number of international organizations, too, extended aid for the victims. World Food Organization, United Nations Child Fund, and International Committee of the Red Cross were among those organizations.

Consular General's Office in Dubai, Sri Lankan High Commissioner's Office in the United Kingdom, Sri Lankan High Commissioner's Office in Kenya, and the Sri Lankan High Commissioner's Office in Malaysia were the key foreign diplomatic missions that provided disaster relief aid. Further, Shanghai Intelligent of China, Kirloskar Brothers of India, Sakura Foundation of Japan, and Japan-Sri Lanka Parliamentarian League, too, extended aid.

7.10 Future plans

- 1. "Disaster Relief Services Preparedness and Response Plan" was prepared in preparation of providing disaster relief services at Divisional Secretariat Division level in order to face future disaster situations.
 - This plan was prepared for 06 districts (Ampara, Anuradhapura, Polonnaruwa, Baticaloa, Badulla, and Trincomalee) which had been expected to be affected by the Northeastern Monsoon in year 2017, and it has been planned to implement this programme for the other districts in year 2018.
- 2. Launching and updating of a computer data system that contains information about the "Disaster Relief Services Preparedness and Response Plan".
- 3. Updating the Sahana relief software that has been developed with the involvement of ICTA (Information Communication Technology Agency) for coordinating the information related to disaster relief services, or developing some other software similar to that. It has been planned to obtain through this software the information necessary for providing relief at Divisional Secretariat Division level, to grant the required provisions as well as to carry out other relief activities by the National Disaster Relief Services Centre.
- 4. It has been planned to introduce a Bar Code System for the currently installed computer data system used for managing the stocks at National Disaster Relief Services Centre Warehouse No. 07 at Orugodawatta. Further, it has also been planned to install a packing system and a system of shelves, and it is expected to obtain the contribution of the private sector for this as a social service project of the private sector.
- 5. It has been planned to take necessary action to increase the efficiency of providing insurance compensation under the National Natural Disaster Insurance Scheme implemented by the National Disaster Relief Services Centre. Under this, it has been planned to develop the data system for assessing the damages caused by emergency disasters, and to conduct capacity building programmes for Disaster Relief Service Officers and for Technical Officers who are engaged in assessing the damages to houses. Further, it is also expected to revise for year 2018 the criteria that are used for assessing damages to houses.
- 6. Attaching another Disaster Relief Service Officer to Divisional Secretariats and District Secretariats in high disaster risk areas of the country in addition to the Disaster Relief Service Officer currently attached.
- 7. Implementing the programme to relocate 15,025 families living in high landslide-prone areas of the country as per Cabinet decision No.අමප/17//1216/715/017 dated 05.07.2017 and අමප/17/2340/715/017-I dated 01.11.2017 and plans have been made to provide the necessary guidelines and financial provisions to District Secretaries.
