Introduction

Ministry of Social Empowerment and Welfare was established in accordance with the Gazette Extraordinary of the Democratic Socialist Republic of Sri Lanka, dated 21.09.2015 by setting up its mission on the providence of efficient, productive and friendly Socio – economic service to improve the living standards of the marginalized and under privileged groups of people.

This Ministry, to be the most respected model Ministry in the South East Asia in creating poverty free, right protected Sri Lanka by 2030, renders an immense service together with its above vision among several key target groups which are benefitted with the services rendered by Ministry and they are;

- Persons with Disabilities (8.7% among the total population)
- Senior citizens over 60 years of age (12.4% among the total population)
- Single Parent Families (11.8% among the total number of families)
- Low-income families (6.7%)

Department/ Institute/ Sectors Under the purview of the Ministry commit a lot for the social and economic development.

Department of Divineguma Development is the massive Development movement which provides the strength for enforcing the national policy of certifying the eradication of poverty and social equality towards the promotion of economic development process.

The Department of Social Services commits to undertake the tasks of skill development of the persons with disabilities and make them independent citizens and early intervention in cases of children with special needs.

The National Secretariat for Elders provides necessary contributions to elders in Sri Lanka through various programmes for creating freedom, protection, self-achievement, participation and dignity for them as well as to offer due rights for the elders.

For the purpose of satisfying the country's requirement of professionals in Social Work and Social Welfare, the National Institute of Social Development is engaged in providing the education in Social Work as its key academic discipline.

The Single Parent Families Development Programme is being implemented under the Ministry for the purpose of assisting the poor Sri Lankan citizens who become single parents due to various reasons.

Rural Development Training & Research Institute makes a significant contribution to empower the community and maximize their active participation in the sustainable rural development, through research, training and compilation of information.

Sri Lanka Social Security Board provides the pension and social security benefits to all employees who need the coverage of the government pension including the self – employed persons, senior citizens, dis advantaged persons, single parents, foreign employees and artists.

- Printing publications and leaflets in Sinhala and Tamil medium to make aware community on counseling and the benefits of those services.

1.2 Activities in 2016

1.2.1 Implementation of counseling Programmes simultaneously with National Counseling Day.

- I. Commemoration Ceremony of National Counseling Day was celebrated in conviviality under the theme of "Counseling as a first aid of Mental health and Psychology for all" at Royal Kandyan Reception Hall under the patronage of Hon. Minister of Social welfare and Empowerment, Mr.S.B.Dissanayake collaborating with Government and Non-government Institutions on 13 October 2016.
- II. Awareness Programmes were conducted with a aim of propagating the counseling service at District and Divisional level based on above said Theme.

1.2.2 Compiling Policies and Plans for counseling services

System of Ethics was drafted for counseling profession with assistance of government and non-government counseling officers.15 Institutions contributed to that practice.

- Prior discussion was conducted with 34 field officers engaged in District level field duties for identification of existing issues required counseling mediation in Polonnaruwa District.

- III. Counselling Mediation Programmes was conducted for the people who had faced to the disaster situation at Salawa area in Colombo District. 936 beneficial families were participated for that programmes.

02. National Council and National Secretariat for Persons with Disabilities

2.1 Introduction

The objective of the National Secretariat for Persons with Disabilities is to make legal provisions relevant to Act of Protection of Rights of Persons with Disabilities No.28 of 1996 enacted for the Promotion, Advancement and Protection of Rights of Persons with Disabilities in Sri Lanka and to provide for matters connected or incidental in that regard.

2.2 Functions and Activities

The National Council for Persons with Disabilities has been established for the purpose of making decisions with regard to rehabilitation of the persons with disabilities and implementing the legal provisions related to enforcing the National Policy on providing welfare and relief to them with a view to realizing the objectives of the above Act. In line with the decisions thus taken, the National Secretariat for Persons with Disabilities (NSPD) carries out the following activities:

- Programmes for poverty minimization and rehabilitation based on promotion of welfare of the persons with disabilities.
- Programmes for prevention and control of main causes of disabilities.
- ❖ Maintaining accurate data and statistics on persons with disabilities.
- Supervision, guidance and assistance when needed, for the institutions established for development and welfare of the persons with disabilities.
- ❖ Facilitating the access to inclusive development, preparing the physical environment and providing the relevant parties with direction, guidance and assistance when needed.
- ❖ Implementing programmes to ensure the continuous education of the children with disabilities who are at their due age for receiving education and currently going to school and such children who are currently not going to school and assisting them in their needs.
- ❖ Implementing Programmes to raise the public awareness about the social responsibility to incorporate the contribution of the persons with disabilities into inclusive development and programmes for carrying out promotional activities in that regard.
- ❖ Identifying the (Geographical) areas where the persons with disabilities occur in relatively higher numbers and implementing programmes to draw the public attention towards the factors causing such disability and carrying out follow-up actions and analyzing the progress of the programmes thus implemented.

2.3 Financial and Physical progress (as at 31.12.2016)

2.3.1 Implementation of the legal provisions for protecting rights of Persons with Disabilities.

2.3.1.1 A new draft bill to provide for protecting rights of Persons with Disabilities

The new bill, which has been drafted by a special drafting committee for further improving the Protection of Rights of Persons with Disabilities Act No .28 of 1996, has been submitted to the Legal *Draftsman's Department* for necessary actions.

2.3.1.2 Sign Language Draft Bill

The Sign Language Draft Bill prepared following the recognition of the Sign Language by the Parlimenr as an accepted language, was submitted to the Department of the Legal Draftsman and as of now, a preliminary draft prepared by the Legal Draftsman has been forwarded. As per the suggestions calling for further development of the draft bill, the National Council recommended obtaining views and suggestion from a committee of subject experts and such views and suggestions have now been referred to Legal Draftsman.

2.3.1.3 Draft Bill for Protection of the Rights of the White Cane Users

Since the rights of the visually handicapped are also protected by the Act No.28 of 1996 for Protection of the Rights of the Persons with Disabilities, the Legal Draftsman has informed that it is suitable to prepare a set of rules under the same Act rather than preparing a new Act for protection of the rights of the visually handicapped.

2.3.1.4 Ratification of the United Nations Convention on the Rights of Persons with Disabilities

The Cabinet Memorandum forwarded to ratify of the International Convention of the United Nations on the Rights of Persons with Disabilities was assented by Sri Lanka on 30 March 2007, was approved by the Cabinet of Ministries on 23.12.2015.

Accordingly, General Assembly of the United Nations has been declared as Sri Lanka is a ratified country to the said UN Convention on 08.02.2016.

2.3.2 Self-employment assistance for income generation.

Under this programme, with a view to poverty minimization of the low-income families with members with disabilities, such families or individuals are provided with a financial assistance up to a maximum of Rs.25,000/- to start or develop a self-employment, and necessary arrangements are made with regard to starting of such self-employments monitoring the progress, improving the quality of the products and assistance with selling of products.

2.3.3 Monitoring of Welfare and Development Centers

Implementation of programmes for supervision of quality, monitoring, and providing assistance when needed, with regard to the Welfare and Development Centers maintained by the voluntary organizations registered with National Secretariat for Persons with Disabilities.

There are 130 of such centers being maintained by those registered institutions.

2.3.4 Providing Accessibility Facilities for the Persons with Disabilities.

All existing public buildings, public places and places of public service delivery shall be made accessible to the persons with disabilities, as per the Accessibility Regulations: No.01 of 2006 promulgated by the Gazettes Extraordinary No 1467/15 on 17.10.2006 and No 1619/24 on 18.09.2009 in accordance with the Protection of the Rights of Persons with Disabilities Act No. 28 of 1996.

However, having appointed the committee headed by the Ministry of Social Empowerment & Welfare and with the participation of Urban Development Authority, Ministry of Transport & Civil Aviation, the *Sri Lanka Institute* of *Architects, Department* of *Urban Engineering, Road Development Authority and etc a report is being prepared for amending the regulations in the* said Gazette Extraordinary notification because the specifications therein should be amended to be suited to more comfortable for the persons with disabilities and for the current needs.

2.3.5 Providing Monthly Allowance for Persons with Disabilities.

The programme for providing a monthly living allowance of Rs.3000/- to the low-income families with disabled members is implemented since 2007. Factors such as poverty in the family, severity of the disability, householder being disabled and the number of members with disabilities in the family are taken in to account in granting the allowance.

It has been revealed through field observations that the economic, nutrition, mental and social levels of the persons with disabilities and their families have been improved with the assistance received under this programme.

2.3.6 Paying Monthly Living Allowance for Kidney Patients

As a measure of easing the difficulties encountered by the people suffering from Kidney Disease in obtaining their medicine or travelling to attend the clinics, 19,645 of kidney patients undergoing blood purification have been selected for a monthly living allowance of Rs.3000/- with the recommendation of the Ministry of Health, from Kurunagala, Ampara, Vavuniya, Badulla, Matale, Monaragala, Polonnaruwa, Mullaitivu, Anuradhapura and Trincomalee districts where the Chronic Kidney Disease is highly spread and 15,453 patients were receiving the allowance by 31st December 2016.

2.3.7 Providing Educational Assistance

The children with disabilities and parents of children with disabilities, of low-income families are provided with the educational assistance up to a maximum of Rs.10, 000/-as a one-time payment, for the purpose of meeting the traveling expenses to go to school and obtaining educational materials. It is revealed through the field observations that due to the educational assistance provided under this programme, there is an improvement in the tendency among the children with disabilities at the school-going age to have education.

2.3.8 Provision of Assistive Devices

In order to making disable people contribute to their own inclusive development and to make them independent persons, while assisting their rehabilitation activities, financial assistance is given to obtain the Spectacles, wheel chairs, hearing devices, tricycles, crutches, wheel chairs and etc of the persons with disabilities. These equipments were provided to low income persons upon the medical recommendation in this year as follows and 98 mobile service programmes were held for this purpose.

2.3.9 Housing Assistance Programme

Housing assistance is provided, subject to a maximum of Rs.250, 000/- each, for building a new house or a part of the house for a low-income person with disabilities who has no house to live in or for the family who take care of such person, or for repair of a house, subject to a maximum of Rs.150, 000/- each. For the purpose of providing assistance under this programme, 5% of the income from sale of the Supiri Vasana Sampatha lottery is currently credited to the National Fund for Persons with Disabilities. Accordingly, as at 31.08.2016, a sum of Rs.35.995 million has been expended in respect of 375 houses.

2.3.10 Medical Assistance

Under the Medical Assistance programme, a family living on an income less than Rs.6000/- per month is provided with a financial assistance up to a maximum of Rs.20,000/-each on priority basis for the purposes such as obtaining medicines not provided by government hospitals to persons with disabilities and those who suffer from long-standing illnesses, meeting the travelling expenses for attending clinics, expenses incurred for heart, eye, kidney, brain, hip bone transplant, ear drum surgeries, purchasing special medical equipment such as water mattress, air mattress and speech aids and for blood transfusion. Medical assistance has been supplied up to 31st December 2016 as follows.

2.3.11 Courses

Ability to Communicating with persons with disabilities is particularly important in easily satisfying their service requirements. National Secretariat for Persons with Disabilities has started a training programe on Sign Language, Braille Methodology, Mobility and Orientation for public officers to enable them to discharge their duties in a more productive and efficient manner and courses ware conducted for two groups of 50 officers in 2016.

2.3.12 Provision of Assistance to Care Homes.

A provision of Rs. 8 million has been released to meet the expenses of water and electricity bills and salaries of the employees of the Victoria Home at Rajagiriya which gives refuge to a large number of persons with disabilities who are incurable and requiring life-long care.

2.3.13 Provision of Assistance to Voluntary Associations.

A sum of Rs. 2.4 million has been provided for development of facilities of 12 institutions engaged in the welfare of persons with disabilities and Rs 2.229 Million has been spent on this purpose by 31 December 2016.

2.4 Special Events

2.4.1 Offer of Scholarships for A/L Students who have been lost their parents by kidney desease (CKDU).

A sum of Rs.752,000.00 by Rs.1000/= each for 752 students who have been lost their parents by kidney desease in 3 districts of Anuradhapura, Badulla and Vaunia has been paid monthly from April to December. Provisions had been provided by Presidential Secretariat.

03. Single Parent Development Programme

3.1 Introduction

The number of Single parent families is increasing in the society at present. The objective of this programme is to be a handrail to the poor single parents citizens who have become single parents due to they were deserted by their spouse and children or due to the spouse were passed away, to uplift those families on standard level in this society by supporting to the economical issues they have faced.

3.1.1 Selection of Beneficiaries

- Women with infants or school-attending children and who have become vulnerable due to death of their husbands/wives by an accident, suicides or such an incidents.
- For families of which wife and children have been deserted by husband or, husband and underage children have been deserted by wife.
- For alone women/men who were not legally married but have underage children or schoolattending children and without sufficient means of income to satisfy the needs of these children.

In selecting beneficiaries under the above criteria, priority is given to families with breast feeding infants and school-attending children.

As per the data of the Department of Census and Statistics in 2012, out of total number of single parents families in Sri Lanka 610,945, widowed and over 50 years old families are 77626, widowed but less than 50 years old families are 441,797, divorced and over 50 years old families are 8,856, divorced and less than 50 years old families are 9,043, deserted and over 50 years old families are 40,436, deserted and less than 50 years old families are 33,186 and the maximum single parent families have been recorded in Gampaha District. Small children and women are specified as significance the most vulnerable grops among them. There is a severe threat for their protection security and dignity because of their helplesness. In addition that Education and Nutrition of them was a problem and there is a tendency to be focused on various social offence

Further, according to a study done by the Ministry of Education, it has been revealed that 2% of children at the school-attending age are not attending to school mainly due to poverty. A considerable portion of this group is from Single parent families.

For alleviating this situation, following activities are carried out under this programme.

- 1. Providing aids for Self Employments, initializing of Self Employments and making feedback for empowering single parent families.
- 2. Initializing Reading Centres for increasing desire of the reading of the children and other members of single parent families.
- 3. Improving the Strength of Economy of mothers/fathers in single parent families, By making awear them about the role of performance executed for improvements of their families and social accountability, they are given necessary knowledge to countinue their children's education. Conducting programmes to provide technical knowledge for the projects initialized by them and to develop psycological status of the target group while conducting programmes to stabilize families identified as risky families.

04. Rural Development Division

4.1 Samurdhi Model Village Programme

4.1.1 Introduction

Samurdhi model village programme was implemented in order to achieve special objectives such as guidance community of the villages to livelihood development projects by empowering them for upliftment of their lives, infra-structure development for this purpose, providing market fascilities for rural products, development of rural industries by using resources in the village, urging people for organic farming without poison, increasing nutrition condition of the family by influence to consume fresh fruits and vegetables, creation the righteous citizen through spiritual and ethical development, creation a protective and pleasant environment for living, reducing poverty in the village and with a view to develop a village as the pilot exemplary village to the Divisional Secretariat.

Under Stage I of this programme, at least one village in to one District amounting to 40 villages have been selected.

When selecting villages for this programme, the attention was drawn to a high density of low income people in the area and potentials of developing all sections including economical, social, cultural, spiritual environmental sections and when converting to a prosperous village it was also considered attitudes and effectiveness of the community, as well as officials and other parties associated the village.

Department of Divineguma development allocates Rs.7.0 million per one village for implementation this programme. Monitoring, supervision and follow up activities of this programme are carried out by the officers of Rural Development Division and Department of Divineguma under the provisions of the Department of Divineguma. This programme is implemented by the officers directly related to the village including Economic Development Officers in Divineguma Development Division of District Secretariats and Divisional Secretariats and in village level, Grama Niladhari, Divineguma Development Officers, Agriculture Reserch and Production Assistants, Mid-wives etc.

05.Department of Social Services

5.1. Introduction

The Department of Social Service was established on 01^{st} of February 1948 on a reccomendation of Social Services Commission which was appointed in 1944 with the chair of Sir Ivor Jenings. Initially, the main task of the Department was to provide financial assistance to estate workers and poor families in our country on the occations of victimization by dissasters and illnesses. These relief programmes which were in primary level, have been expanded to encompass their livelihood development a well rising above the dependence mentality on the basis of contemporary needs.

Curuntly Sri Lankan government has to combat a number of contemporary social issues such as disability, sub-furtility, Non Communicable Deseases, Psychosis, suicides, poverty and drug addiction arisen due to either environmental hazzards or conscious or unconscious human activities. This situation has direct or indirect negative impacts on the progress of the entire society as well as the individual.

The main objective of the Social Services Department is to incorporate these marginalized and disadvantaged communities in to national development as active stakeholders through developing them by their own efforts. In view of achieving the above, various surveys, policy planning and development programmes have been successfully executed starting from national level to grass root level through participating development aproches during the year of 2016.

Service providing officers have been directed to local and foreign workshops, conferences and training programmes in order to promote their efficiency, mortivation and productivity. The department won the 3rd place for government institutes at the productivity award ceremony in the year of 2016. Six vocational training institutions out of eight functioned under the purview of the Department could acquire awards and certificates at that award ceremony.

Activities

- I. Provision of Vocational Training and working tools for self employments for the youths who are disabled and directing them for open careers.
- II. Identifying and expansion the job marcket for persons with disabilities.
- III. Conducting surveys in order to identify contemporary needs and priorities of persons with disabilities.
- IV. Provision assistive devices for the persons with disabilities and empowering their families.
- V. Guidance of children with special needs for inclusive education through prior mediation.
- VI. Conducting workshops, conferences and training programmes for service providing officers in order to uplift their knowledge, skills and attitudes.
- VII. Providing a relief to day to day works of the person with hearing disabilities by issuing special identity cards and providing signal language translation services.

- VIII. Safe guarding the boys who are mentaly retarded and had not custody of the guardian.
 - IX. Providing financial assistance to the voluntary associations which are being standed for welfare of the persons with disabilities.
 - X. Providing sports, educational and cultural aids for visually handicapped children.
- XI. Rehabilitation of drug adicted people in a residential manner.
- XII. Providing necessary services for the peoples with disabilities under community based inclusive development programme.
- XIII. Establishment, empowering and continueing swa shakthi groups of peoples with disabilities in divisional level.
- XIV. Implementation of various programmes through combined approachs.

5.2.3.1(a). Rehabilitation, providing vocational trainings, Zocialization and providing security for the youth with disabilities.

This is a main programme implemented on target disabled community. The programmes carried out with the aim of empowering career capabilities, providing vocational training to develop their livelihood for youth with disabilities have been progressed successfully in 2016. 08 vocational training institutes have been functioning at Seeduwa, Amunukumbura, Ragama, Madampe, Ketawala, Waththegama, Kalawana and Thelambuyaya which are established in 06 Districts of Colombo, Gampaha, Kandy, Puttalam, Rathnapura and Hambanthota under this programme. The disabled young children between the ages 16-35 and eligible to follow certain training courses are admitted to these courses and trained formaly in these institutions. Foods, accomadations and health facilities have been provided free of charging within the training period. Training periods of those courses are held as one year and two year. Allowance is paid for daily needs of trainees. The trainees, those who have successfully completed the training would be given the recognized certificates and tool kits for the self-employments. The department has been mediated for job opportunities in government and private sector for trainees who ere left to the society from institutes.

This taining not only provides oppotunities to improving their vocational capabilities but involves sharing their knowledge and skills regarding new technologies, communication, atr and sports with the world also. In addition to the vocational training, providing special identity cards to the persons with hearing disabilities, providing training allowances to the voluntary institutes which provide trainings for persons with disabilities, providing allowances to the preschool teachers who teach the children with hearing disabilities and low intelligence, providing of pre-school teachers training, granting maintenance aids and ad hoc aids to the voluntary social institutes which receive financial assistance from the Department of Social Services and providing the sign language service to the persons with hearing and speaking disabilities are successfully done by the Department subject to this project.

5.2.3.1(b). Jayaviru Sewana (Caring home, Puwakpitiya)

Jayaviru Sevana Caring home has implemented programmes for providing protection and residential facilities to the mentally retarded boy children who lost their parents and guardians. Since the new building was constructed 23 of new trainees have been admitted within this year. These children are provided residential for entire life time, and they are referred to the day to day activities. There were 72 children obtained protection by 31.12.2016.

5.2.3.1(c). Child Guidance Center at Nawinna

In a doubted situation arisen of a growth defect or a stunted growth of a child in his/her prechildhood, this programme gives afore mediation for guidance to develop the child. The parents, who came to seek the correct guidance towards their children, are initially registered by having obtained the bio data of such children. Having identified the needs of the child, estimation is taken on the basic growth condition. After having the discussions between teachers and parents the children are referred to the suitable class room as per the skills of the children following the preparation of the detailed quality report. Their skills and growth conditions reports are prepared in every 6 months and 1 year as well as if it is required their follow up activities could be further extended.

5.2.3.1(d). Drug Addicts Rehabilitation and Socialization Project

Drug addicts rehabilitation and socialization project is implemented by Jayaviru Samadhi home at Puwakpitiya which is functioned under the Department of Social Services. After the persons who have driven their lives to darkness by addicting Heroin, Ganja/Kerala ganja, alcohol and intoxicated tablets came to our institute, basically they are forwarded for rehabilitation process through the psycho therapeutic, psychological counseling methods and medical scientific

approaches. In the training period, yoga meditation and various religious programmes are held for the spiritual development of trainees. Foods, accomadations and health facilities are provided free of charging within their training period. A training of career development too is provided within the training period for developing their level of living. There were 212 service gainers to be rehabilitated in year 2016 while new admission was 167. 127 persons have been socialized in that year.

5.2.3.2. Visually Handicapped Trust Fund

The mission of this fund is inter alia to provide required services to persons with visual impairment rehabilitate and provide relief. The positive commitment to the growth of new attitudes has been gradually arisen on the disabled persons in Sri Lanka following the declaration of 1981 as the International year of Disabled Persons. As a sequel to this direction, an Act of Parliament No 09 of 1992 to establish a fund for visually impaired persons was passed by parliamentary of the Domestic Republic of Sri Lanka and this was published by a Gazette Notification. Various services in support of the disabled persons in Sri Lanka have been initiated in line with this Act.

During the beginning of the final quarter of 2015, it had been decided to hold an island wide census to identify beneficiaries who really deserve the Samurdhi subsidy, and 2.5 million census forms in this respect had been printed and distributed.

In addition to that, it is scheduled to conduct some researches and publication related to the subject field. Rural Development training & research institute wishes to be the expect in the rural development process through strengthing the research and plans.

07.National Secretariat for Elders

7.1 Introduction

The objective of this Secretariat is encouraging elders in Sri Lanka through various programmes for creating freedom, protection, self achievement, participation and dignity for them as well as offering due rights of the elders. In reaching those aims, powers are vested with this Institute by the National Council for Elders by virtue of Act No. 09 of 2000 and by amended Act No.5 of 2011 on ensuring the rights of elders. The Programmes implemented for the well-being of the Sri Lankan Elder population are as follows.

7.2 Activities & Progress up to 31st of December 2016

7.2.1 Financial Assistance for Elders committee

Provide financial assistance to Village Level Elders Committees/ Divisional level elder committees/ District level Elders Committees and Provincial level elders committees established as per Section16th and their supervision. By the end of 31st of December 2016, Rs 1.999 million for 325 village level elders committees (Rs.5000/- each), 03 Divisional level elders committees (Rs.7500/- each), 01 District level committee, 01 North Western religious programs,01 Northern province Meeting, Stationeries for 17 District elders committees have been spent under this programme.

7.2.2 Providing Eye lenses & Hearing Aids

Equipments such as eye lenses/ hearing aids needed by low income earning senior citizens aged over 60 were provided. By the end of 31st of December 2016, the total of incurred expenditure was Rs 9.998 million to grant eye lenses for 3693 peoples and hearing aids for 489 peoples under this programme.

7.2.3 Publication

By the end of 31st of December 2016, as publications 2000 copies of elder magazines, 5000 Elder Hand books and 4,000 Elders acts were printed for distributing among elderly community. Total incurred expenditure was 1.400 Million.

7.2.4 Providing of Identity Cards for Elders

The Special Identity card provides for above 60 years senior citizens. Under this, 61791 Elders Identity Cards have been provided for the Elders by the end of 31st of December 2016 and Rs 0.600 million has been spent.

7.2.5 Conducting of pre – retirement training and awareness programmes

Consultancy services are provided for improving mental health of elders through retirement training programmers for peaceful retirement life for employees of all sectors who are in retirement age. Further workshops for elder's committee members, other organizations and care givers (Home-base Attendants) who handle care of aging elderly citizens are also conducted. By the end of 31st of December 2016, Incurred expenditure was Rs.5.500 million for conducting 120 awareness programs for School Children, 121 awareness programs for womans` organizations, 01 District committee Awareness, 01 Awareness programms regarding 2000/-allowances, 02 care giver awareness programs, Care giver T- shirts 90 and ID 30, 01

Care giver training, School Children awareness program in Anula Abhman Exhiibition, 01 friendship exchange programme, 02 progress evaluation meetings.

7.2.6 Maintenance Board

Taking actions to refer helpless parents to the Maintenance Board for Elders established as per 24th section of the Act and taking initial steps to pay Maintenance. By the end of 31st of December 2016, 90 requests have been settled out of 130 and incurred expenditure for this purpose was Rs. Mn. 1.055

7.2.7 National council for elders

12 national council meetings and 05 audit and management committee meeting were held by the end of 31st of December 2016, under this providing financial assistance up to Rs. 0.903 Million were spend.

7.2.8 Monthly allowance for Elders (Rs. 2000/=)

Public Assistance Programme of Rs. 2000/-for low income earning senior citizens is being implemented, commencing from 2015 to provide protection and welfare to Sri Lankan citizens aged over 70. Under this, 386080 elders are benefited. Incurred Cost is 9265.92 million. Also 2.900 million was spent as administration Expenses on 2000/-Allowance.

7.2.9 Financial Assistance for Elders Homes

Funds to develop infrastructure facilities in Elders' Homes are provided Island-wide. Under this, incurred expenditure was Rs 13.580 Mn for 14 Elders Homes by the end of 31st of December 2016.

Under the theme of "Take Stand against Ageism", The International Elders day were celebrated on 2016.10.01 with the participation of Hon Minister and Elders who came from. By the end of 31st of December 2016, under this providing financial assistance up to Rs 11. Million were spent.

08. National Institute of Social Development

8.1 Introduction

The National Institute of Social Development (NISD) is recognized by the University Grants Commission (UGC) as a degree awarding Institute, under section 25 of the Universities Act No. 16 of 1978. It functions under the purvies of the Ministry of Social Services. It is premier institution in Social Work education in Sri Lanka producing professional social workers to serve the social welfare system and to promote social development. This Institute operates under the provisions of the National Institute of Social Development Act No. 41 of 1992 in 2005 on the recommendation of the University Grants Cimmssion, the Government of the Democratic, socialist Republic of Sri Lanka, granted the degree awarding status to the National Institute of social Development for the purpose of developing higher education leading to the conferment of the Bachelor's degree in Social work. Subsequently the Master's Degree programme in social work was also approved and commenced in 2008. In 2013 Commencement of diploma, higher Diploma and Bachelor's Degree in social Work in Sinhala, Tamil and English medium according to trilingual Policy is a remarkable achievement.

National Institute of Social Development conducts interim professional training courses Bacholor of Social Work, Master of Social Work, Higher Diploma courses, Diploma Courses, Certificate Courses, conflict Management, leadership, Skills Development, Stress Management, Priliminary Counseling Courses and Project Management courses in Colombo head office and regional centres. In addition to that, having identifies the researches and training activities which are currently important for formulating the government policies are also implemented.

These courses, which include practical trainings as well, have very high standard and applicable hence all the graduates who follow these courses are employees. 6.4% among them are employed in foreign universities and are attending in post graduate degree activities following the receipt of half and full scholarships.

The Organizational Structure of the Institute

The Governing council is the apex body in the organizational structure of this Intitute while the Academic Affairs Board functions under the council as an advisor body on all academic matters. The regular operational functions of the Institute are carried out by four integrated divisions. They are;

- Sri Lanka School of Social Work

8.4 Other Programmes

8.4.1 Construct of Seeduwa building belonging to National Institute of Social Development

2.1493 ha (05 Acr.01R 9.08 P) of Seeduwa land belonging to the Department of social Services of the Ministry of Social empowerment & Welfare was taken for constructing the permanent building for the National Institute of Social Development.

8.4.2 Open of Killinochchi Regional Traing Centre

With the objective of expanding the courses of National Institute of Social Development in rural areas, training centres were initiated. Thalawa Regional Training Centre in Anuradhapura District, Ranna Regional Training Centre in Ampara and Hambantota District have already been opened and fourth Regional Training centre was opened in the killinochchi District Secretarate on 16 January 2016.

8.4.3 Convocation of National Institute of Social Development

Convocation ceremony of awarding degree certificate and diploma certificates of the National Institute of Social Development was held on 20.03.2016 at BMICH. Accordingly 11 social work post graduate degree holders, 56 graduate holders and 401 counseling Diploma holders obtained their degrees.

8.4.4 Renovation of the Thalawa Regional Training Centre

This work has been completed and short term and long term training courses are being conducted. In addition to this, lecture hall and residential facilities are provided with the external institutes and persons.

8.4.5 Filling of Vacancies

Activites have been made for filling 24 vacancies of academic and non academic staff of the institute. Provisions have been requested for the year 2017 for this purpose.

8.4.6 Library Facilities

The library which is the largest resource centre in Sri Lanka consisting of more than 2000 publications and books related to social works. These books have been computerized successfully.

8.4.7 The programme of Teaching English Language

There are continuous English classes for the students who follow social work Doploma, Higher Diploma, and degree in the NISD. An intensive course for improving English language will be conducted one month prior to start the Bachelor of Arts degree and qualified external and internal English lectures are employed for this purpose.

8.4.8 Library facilities for Regional Centres

A small library has been opened for each thlawa, ampara, Ranna and killinochchi Regional Centres. Supervision and documentation of these library affairs will be conducted by the library and store division of this institution.

8.4.9 Affliated National Institute of Social Development with the University of Sri Jayawardanapura

The process of affliating the NISD with the University Sri Jayawardanapura has been commenced and it officially opened under the Memorandum of Understanding (MOU) between two institutions.

8.4.10 Special Projects

09. Sri Lanka Social Security Board

9.1 Establishment of the Board

Sri Lanka Social Security Board has been established in accordance with the Act No. 17 of 1996 dated 26th July 1996 and subsequently the original Act was amended by the Act No. 33 of 1999.

9.1.1 Activity

This Social Security Board was first established under the purview of the Ministry of Social Services in the year 1996 and subsequently it was affiliated to the Ministry of Finance from May 2010. Later on, this Board has been executed under the authority of the Ministry of Social Empowerment & Welfare with effect from 21.09.2015.

9.1.2 Objectives

- To provide social security to self employed persons during their old age and on disability
- To provide relief to the dependants of self employed persons, upon death;
- To encourage self employed persons to continue in their respective occupations and to develop their capabilities and skills
- To encourage youth to be self employed and to develop their capabilities and skills
- To educate self employed persons on the benefits of thrift and resource management
- To improve the living standards of self employed persons generally.

9.1.3 The Role of the Board

The pension and social security benefits scheme is targeting the individuals, who do their own self-employments. Nevertheless, presently, in addition to the self-employed persons, there is a need and situation of implementing the pension and social security benefits scheme for the employees in the private sector, foreign employees, artists, and for individuals, who engage in agricultural and fishing activities.

9.1.4 The Pension and Social Security benefits Scheme

Sri Lanka Social Security Board provides the social security to all, who need the coverage of the government pension during their older age and benefits like monthly pension to the spouse in case of death of the subscriber, partial disablement benefits and total disablement benefits before reaching the pension entitlement, death gratuity are implementing in-an-assured-manner.

9.1.4.1 Service fields, which have been covered

Presently the self-employed persons, the employees in the private sector, the employees in the Cooperative Services, the employees in the Statutory boards, professionals, artists, ayurvedic medical practitioner, foreign employees, priests, indigenous people and all the others who need the care and security of the government pension scheme are covered by the Sri Lanka Social Security Board.

9.1.4.2 The Pension and Social Security benefits Schemes, which have already been implemented

- "Surekuma" pension and security benefit schemes was introduced by an Extraordinary Gazette Notification of the Democratic Socialist Republic of Sri Lanka dated 22 nd September 2006 bearing the number 1464/5. All those who are in the ages of 18 to 59 years can be entitled to the scheme.
- "Arassawa" preplanned Social Security Benefit scheme was introduced as a preplan for the Surekuma" pension and security benefit schemes for the children who are below the age of 18 years.

9.1.4.3 Benefits of the Pension Scheme

- To provide a pension at the age of 60 years until the demise of the contributory members.
- At the demise of the contributory member before reaching to the age of 80 years,
 - If the spouse is alive he/she is entitled to the pension up to the age of 80 years.
 - ➤ If the spouse is no more, his/her nominating successors would be able to obtain the net total contribution and interest deposited on the name of the contributor in return.
- If a contributory member becomes permanent and partially disabled he is entitled to an adjusted gratuity of net contribution according to the insured's age and, after the payment of contributions completely he/she is entitled to the monthly pension after reaching 60 years.
- If a contributory member becomes permanently incapacitated he is entitled to an adjusted gratuity according to the insured's age and/ or the monthly pension from the date on which the member is incapacitated.
- Special financial benefits are granted to the children in the Grade Five scholarship, G. C.E.(Ordinary Level) and University premises Examinations under "Arassawa" Social Security Benefit scheme.

9.1.4.4 Obtaining the membership of the Scheme

Any member of the society could obtain the membership from the Head Office of Sri Lanka Social Security Board, District Offices, Divisional Secretariats or through Grama Niladhari Officers, Divineguma Development Officers and from any other Officer to whom the responsibility has been entrusted by the Board.

9.1.4.5 Payment of the Installments

Installment payments could be made through all branches of the Bank of Ceylon, People's Bank, and National Savings Bank, Post Offices and Grama Niladhari Officers to whom the responsibility has been entrusted by the authority.

9.1.5 The priority need of the Social Security programme

The percentage of population over 60 years by 2012 was 12.2% and it represented 2,468,329 elders. It is estimated this percentage to be increased up to 24.9% by 2041. Representing a large portion of elders in the population will be a threat to senior citizens, children and generally to the all communities.

Having drawn special attention, in this regard, a considerable number of social security programmes have been included in the government policies following the identification of the elders as the senior citizens. Sri Lanka Social Security Board is highly committed to fulfill the national responsibility of assuring the pension and social security benefits towards the future senior citizens while making them more secured and dignified community.

9.2.4 Fund and Investment Activities

The contributions, which are obtained from the members of the Pension and Social Security Benefits Scheme, are invested in the state banks approved by the General Treasury. The total value of it was Rs. 1.875 Millions by 31. 12. 2016.

9.3 Implementing the special programmes

9.3.1 National Social Security Award Ceremony

The relevant circulars have been released to appreciate the officers, who have achieved the required targets, following the providence of the targets to the Public Officers, those, who implement the Pension and Social Security Benefits Scheme. These appreciations are done in district and national level. Although the district appraisal ceremonies have been held in district level, an appraisal ceremony in national level has not been held since 2008. The said National Social Security Award Ceremony was held under the distinguished patronage of Hon. S.B. Dissanayake, Minister of Social Empowerment & Welfare on 11.07.2016 at the Nelum Pokuna (Lotus Pond) Theatre in Colombo. Awards and certificates were granted to 194 Public Officers including District Secretaries, Divisional Secretaries, Divineguma Assistant Commissioners, Divineguma Managers, Social Services Officers, Grama Niladhari Officers, Divineguma Development Officers and District Coordination Officers of this Board.

9.3.2 International Relations

Special attention has been drawn to implement the pension scheme for the Sri Lankan labours who are serving in South Korea. In parallel to this, we work together with the National Pension Service (NPS), which is the state Institution in South Korea to implement a social security programme and representatives of the said Institution, have visited this Board and had

a discussion with the Authority. Moreover, Officers of this Board participated in the Training Course on Pension of Asia and Pacific Zone held in South Korea in 2015 and 2016. The basic foundation has been made to sign the memorandum of understanding (MOU) between two countries on this matter because the service experiences and methodologies of the said Institution are very important to this Board.

Actions are in the process of obtaining the service of a foreign consultant under the sponsorship of the National Pension Service (NPS) and South Korean Embassy in Colombo in the year 2007.

❖ Re-formulation of the Family Policy for Sri Lanka

In accordance of with the cabinet decision dated 15.12.2011. It was decided to formulate the family policy again with the board frame work that to be fit for strengthening as the primary unit in the society while empowering the family in economic, social and spiritual means, because the family policy, which was presented in the year 2011 as a draft, was only discussed about the disadvantaged people in the society.

In subsequence, a committee, under the chairmanship of Pro.K. Karunathilaka of University of Kelaniya, has formulated this document with the broader vision. Presently, trilingual translation activities (Sinhala, Tamil, and English) are under the process. Final draft has been submitted to the Department of National Planning for observation.

Establishment of the National Volunteering Secretariat (NVS).

The National Volunteering Secretariat Sri Lanka was established in 2013 under the Ministry of Social Empowerment & Welfare in collaboration with the Ministry of Finance & Planning, UNDP and UNV. Preliminary Activities in this connections were done by UNDP and the Secretariat was established under the direct financial contribution of the UNDP. A website was launched for two activities of this Secretariat under the sponsorship of UNDP in the year 2014 and National Policy on Volunteerism was drafted.
