1. Overview of the Ministry

1.1 Introduction

The Ministry of Tourism Development and Christian Religious Affairs was established on 22nd September 2015 under the extraordinary gazette No.1933/13. Among the main objectives of the establishment of a dedicated Ministry in charge of the tourism sector are making available an appropriate policy and regulatory framework, ensure robust infrastructure development, promotion of destination Sri Lanka and exercise administrative and financial overview over institutions Gazetted under the Ministry.

The following Department and statutory agencies are functioning under the supervision of the Ministry.


- Department of Christian Religious Affairs

Available cadre of the Ministry as at 31.12.2017 was 53 as against an approved cadre of 71. Presently there are 18 vacancies in the cadre in various grades which have to be filled by the Ministry of Public Administration and Management.

Establishment of a dedicated unit for the tourism task force. The Tourism Task Force is tasked with making Sri Lanka a leading travel destination and to make the industry a major contributor to national development by initiating projects and programmes to give effect to the Tourism Vision and Strategic Plan.

1.3 Divisions of the Ministry

The Ministry consists of three main divisions. They are Administration, Finance and Christian Religious Affairs Division, Development Division, and Internal Audit Division.

1.3.1 Administration, Finance and Christian Affairs Division

This division is headed by Additional Secretary (Administration, Finance, and Christian Religious Affairs.

Key functions of the division are:

- Recruitment, placement, promotions and retirement of staff.
- Enhancing the knowledge, skill and attitudes of the staff.
- Appraising performance of the staff and giving incentives.
- Maintenance of database with regard to the staff.
- Disciplinary Management.
- Grievance Management.
- Communication management with public institutions.
- Supplement services and procurement management.
- Productivity improvement.

Performance of the Division

i. Training Programs

During the year under review, action was taken by the Ministry to train its staff both locally and overseas with a view to broaden their capacity, knowledge and skills. In the case of local training, 09 members of the staff attended training programs in disciplines related to their areas of work. During the year under review, 13 members of the staff attended training programs, conferences and seminars overseas.



iv. Finance and Accounts Division.

This Division is responsible for managing financial resources of the Ministry. Finance Division provides a range of support services including financial operations, assets management, financial reporting, and professional services. Major functions of the division are:

1.3.2. Internal Audit & Investigation Division

The Internal Audit Division of the Ministry of Tourism Development and Christian Religious Affairs was established in November, 2016 and functions under a Chief Internal Auditor who is directly responsible to the Secretary to the Ministry as per F.R.134(1).

1.3.3. Development Division

This division is functioned under Additional Secretary (Development). It is responsible to implement the annual action plan of the Development division through coordinating relevant sectoral agencies and stakeholders. This division is coordinating with the government and non-governmental agencies in promoting tourism through ensuring proper services to foreign and local tourists. Development of tourism destinations, creating direct and indirect employment opportunities in the sector, ensuring sustainable tourism development in the country, introducing new technologies through foreign assistance are some of the focus areas of this division. The activities of this division are implemented under two sub units.

i. Development Unit

This unit is functioned under the Director (Development). The mandate of this division is to implement the annual action plan of the Development division through coordinating relevant sectoral agencies and stakeholders. This unit coordinates the government and non-governmental agencies in promoting tourism, development of tourism destinations, creating direct and indirect employment opportunities in the tourism sector, ensuring sustainable tourism development in the country.

Key functions of this unit are as follows:

- Handling of all development programmes of the Ministry towards realizing vision, mission and objectives of the Ministry.
- Implementing all Tourism Development Projects and provide necessary instructions to solve matters arising when implementing projects.
- International cooperation in Tourism Development
- New Approaches on Tourism Development activities
- Implementation of e-government policy

ii. Planning and Monitoring Unit

The unit is functioned under the Director (Planning). It is responsible for planning and monitoring activities of the Ministry. Planning unit is entrusted to coordinate and facilitate preparation of streamlined National development policies, Programmes and Projects for the Tourism Sector. In order to achieve this task, this Division plays a key role to facilitate and coordinate the public investment programs and projects of the government, coordinate with Department of National Planning, Department of External Resources, Department of Project Management and Monitoring.

Accordingly the functions of this Division are as follows:

- The Action Plans of the Ministry are formulated in keeping with the Treasury Provision with respect to each year and those targets are distributed among Departments and Institutions under the Ministry within the respective scope of work.
- Obtaining monthly /quarterly progress reports and quarterly review of progress of such development activities in accordance with the Action plan. In addition progress review is carried out at institutional level as well in keeping with quarterly financial and physical targets of the annual Action Plan.
- Handling of result –oriented evaluation process, according to the overall Annual Progress Report of the Ministry.
- Preparation of the annual budget and performance report of the Ministry and submit same to relevant Authorities.
- Evaluation of new project proposals being submitted to the Ministry by Departments and Institutions under its purview and submission of same to the Department of National Planning and Department of Project Management and Monitoring

2. Development Projects

Tourism is recognized as a high priority industry capable of effectively driving the country's Economic Development. To ensure rapid growth of tourism in the future, tourism promotion will have to be complemented with infrastructure development.

In terms of the Budget 2017, Ministry of Tourism Development and Christian Religious Affairs was allocated a sum of Rs.728.18 million to implement seven tourism development initiatives.

However, four projects listed under Nos (05),(6),(07) and (10) above, could not be commenced in time due to reasons beyond the control of the Ministry. Further, according to the Cabinet decission taken on 11th July 2017, the General Treasury has instruted the Ministry to avoid making any commitment regarding above Development projects

2.1 Development of Tourist Attractions

Tourism is recognized as a high priority industry capable of effectively driving the country's Economic Development. To ensure rapid growth of tourism in the future, tourism promotion will have to be complemented with infrastructure development.

In these circumstances, under the 2017 budget a sum of Rs. 568.00 Mn has been allocated to develop tourism related infrastructure in the provinces.

Objectives of the Project:

- To ensure sustainable growth in the tourism industry focusing development of tourism in rural areas.
- To integrate rural tourism development strategy to enhance the living standard of rural communities.
- To create direct and indirect employment opportunities and increasing streams of income for small entrepreneurs and commercial operators.
- To increase number of visitors and facilitating visitors to spend money within the local economy.
- To promote understanding of different cultures and their heritage.
- To develop and popularize lesser known tourist attractions in the Country under varieties of thematic initiatives.

2.1.1 Anuradhapura District

A sum of Rs. 40.14 Mn was allocated for three projects in Anuradhapura District in 2017.

- i. Sanitary Facilities at Isurumuniya Viharaya
- ii. Sanitary Facility between Kuttampokuna and Samadipilimaya nearby Car Park

Introduction:

The sacred city of Anuradhapura attracts both local and foreign visitors, pilgrims and local tourists in large numbers. Therefore, it is important that essential amenities such as health, sanitary, electricity and drinking water facilities be made available in the Greater Municipal area. These two projects started in 2016, the total estimated cost was Rs.34.00 Mn.

Objective:

To provide hygienic sanitary facilities for local and foreign visitors

Result:

- Sufficient Sanitary facilities are available for both local and foreign visitors to Isurumuniya Viharaya, Kuttampokuna and Samadipilimaya areas.
- > Improved hygienic condition in the greater municipal area.

Allocation for 2017: Rs.25.58 Mn

Expenditure: Rs.12.42 Mn **Physical Progress:** Completed

Implementing Agency: Chief Secretary, North Central Provincial Council

iii. Construction of foot a path on Nuwarawewa tank bund

Introduction:

Funds were allocated to construct a foot and cycle path on the bund of Nuwarawawa tank to facilitate local and foreign travelers. This project started in 2016, the estimated cost was Rs.18.23 Mn.

Objective:

Beautification of the city with a path for jogging and cycling.

Result:

Comfortable walking and cycling path for local and foreign tourists for their exercises in an environment friendly atmosphere.

Allocation for 2017: Rs.14.56 Mn

Expenditure: Rs.8.25 Mn **Physical Progress:** Completed

Implementing Agency: Chief Secretary, North Central Provincial Council

2.1.2 Batticaloa District

During the year 2017, a sum of Rs. 26.63 Mn was allocated for two development projects initiated in Batticaloa District.

i. Beautification and improvement of Eravur Lagoon Side

Introduction:

Tourism sector in Eastern Province has been under developed. Nevertheless, a large number of foreign and local tourists are visiting the Batticaloa District daily. Eco tourism has been defined as "responsible travel to natural areas that conserves the environment and improves the welfare of local people. This project focuses on the development of Eravur Lagoon side as a tourism destination focusing on sustainable use of natural resources leading to conservation of such resources as well as ensuring economic benefits to the local population.

Objective:

- To promote Eravur lagoon as a tourism destination focusing on sustainable use of natural resources
- To create high standard and value added leisure facilities at the site.
- Enhance tourists experience and satisfaction with unique eco-culture resources and recreations.

Result:

Improvement of local socio-economic development and creation of economic opportunities in sustainable basis.

Allocation for 2017: Rs.12.13 Mn

Expenditure: Rs. 8.15 Mn **Physical Progress:** Completed

Implementing Agency: Chief Secretary, Eastern Province

ii. Eravurpattu Beach development

Introduction:

Eravur Pattu divisions falling with in the district of Batticaloa and part of Ampara. Eravur Pattu is the ultimate destination for all travelers in search of relaxation combined with excitement. From trying out an amazing the sun along the beaches of the island, beach holidays in Sri Lanka offers everyone the opportunity to enjoy a great vacation. The delightful sights and sounds of the ocean always surprise visitors with its natural beauty. Eravur Pattu beach along the east coast is one among the many stunning beaches of Sri Lanka. This project improve their livelihood ,other infrastructure and also increased local tourism.

Objective:

- ❖ To Increase Eco friendly environment and recreation
- To encourage small and medium entrepreneur
- ❖ To create employment opportunities and increase income generation
- To motivate self-employment at village level

Result:

Improvement of local socio-economic development and creation of economic opportunities in sustainable basis.

Allocation for 2017: Rs.14.50 Mn

Expenditure: Rs. 3.51 Mn

Physical Progress: Work in progress

Implementing Agency: District Secretary, Batticaloa District

2.1.3 Galle District

A sum of Rs.8.48 Mn was allocated for three initiatives in Galle District. These initiatives were implemented by Chief Secretary, Southern Provincial Council.

i. Installation of mobile sanitary facilities with a changing room at natural swimming pool in Akurala Coastal area, Hikkaduwa

Introduction

Amongst, famous beach areas prevailling in Sri Lanka, a lesser known yet beautiful sea belt can be seen in Akurala area. This beach belt and its surrounding area with a natural swimming pool is an attractive place among local and foreign visitors.

Therefore, the area need to be developed and promoted as an attraction of a beach belt with high potential as a destination. Thus, it is important to place a mobile changing room and sanitary facilities in and around natural swimming pool.

Objectives:

- Provision of common amenities and sanitary facilities.
- Popularizing lesser known place as tourist attraction in Southern Province

Result:

Facilitating tourist stay at Akurala beach belt.

Allocation: Rs.2.81 Mn Expenditure: Rs. 0.56 Mn

Physical Progress: Work in progress

Implementing Agency: Chief Secretary, Southern Provincial Council

ii. Development of Tourist Zone at Hikkaduwa-Preparation of Survey plan for proposed Master Plan.

Introduction

The Ministry has taken initiatives to develop Hikkaduwa as a tourist zone in collaboration with Urban Development Authority.

Accordingly, it is scheduled to develop Hikkaduwa area as a prominent tourist attraction. Therefore, necessary actions have been taken to prepare survey plan related to the field as an initial step of the preparation of a master plan.

Objectives

- Development of Hikkaduwa beach belt with a consolidated approach according to a master plan.
- Obtaining the survey plan required to prepare a master plan from the Department of Survey
- Preparation of the master plan by using survey plan

Result:

- Preparation of a survey plan for development of Hikkaduwa beach belt
- Preparation of master plan for the area in collaboration with Urban Development Authority and other institutions.

Allocation: Rs.0.17 Mn Expenditure: Rs.0.17 Mn Physical Progress: Completed

Implementing Agency: Chief Secretary, Southern Provincial Council

iii. Development of Eco-tourism facilities in Ambalangoda Godahena Madampawila Santuary

Introduction:

Madampawila Ihala is located mid to Hikkaduwa Divisional Secretary Division, Ambalangoda and this place is lesser known and very attractive place with attractions for tourist comprised of rich bio diversity It constitutes a higher tourism potential due to its mangrove ecosystem system, associated bio diversity in wetland ecosystem environment, it has been established by Ministry of Environment and Natural Resources as a sanctuary as per the Gazette Notification Order no of 1515/21 dated 21 September, 2007. Further, a beautiful mangrove ecosystem system situated around this lake attracts tourists and this unique ecosystem provides an important habitat for migratory birds. Therefore, it is important to develop infrastructures in an eco-friendly manner.

Objective:

- Construction of a floating jetty for obtaining transport facilities to adjoining the sanctuary between Godahena and Madampawila .
- Construction of a center to provide facilities required to tourists engaging in eco-tourism related activities.
- Promotion of tourist activities surrounding Madampawila while conserving the environment.

Results:

- Possibility of obtaining information and facilities needed for local and foreign tourists engaging in tourism in and close proximity to the sanctuary.
- Safe access to the sanctuary
- Promotion of eco-tourism

Allocation: Rs 5.50 Mn Expenditure: Rs. 1.10 Mn

Physical Progress: Work in progress

Implementing Agency: Chief Secretary, Southern Provincial Council

2.1.4 Jaffna District

A sum of Rs.74.97 Mn was allocated for nine projects in Jaffna District. These projects were implemented by District Secretary, Jaffna and Chief Secretary, Northern Provincial Council.

I . Recreational Boating facility for Tourism in Jaffna Town

Introduction

This project aims to develop recreational boating facility for leisure in Jaffna lagoon and inter islands. The project will be designed and implemented as a Public Private Partnership not only to attract the local and foreign tourists but it also create employment opportunities. This project was started in 2016 and estimated cost is Rs.30.00 Mn. The project is currently in operation.

Objectives

- To improve boating business and revenues.
- * To promote investment opportunities for local people in tourism related business.
- To attract local and foreign tourists towards water based leisure activities and ecotourism.

Result:

- > Establishment of public private participation for recreational events based businesses.
- > Local community participation in related economic activities.
- > Importance of cultural and natural resources is promoted.
- > Increased number of days/stays by foreign/local tourists in Jaffna District.

Allocation for 2017 : Rs.25.54 Mn

Expenditure: Rs. 25.54 Mn **Physical Progress:** Completed

Implementing Agency: District Secretary, Jaffna

ii. Development of Eco Tourism Center in Jaffna Island (Mandathivu) Introduction

Eco tourism is a form of tourism involving visiting fragile, pristine, and relatively undisturbed natural areas, intended as a low-impact and often small scale alternative to standard commercial (mass) tourism. It means responsible travel to natural areas conserving the environment and improving wellbeing of local people. Development of Eco Tourism Center in Mandathivu, Jaffna aims to improve facilities for local and foreign tourists. This project was started in 2016 and estimated cost was Rs.46.00 Mn and projects continue in year 2017.

Objective

- To attract local and foreign tourists through ecotourism development.
- To create the economic empowerment for local people.
- To develop new tourism products.
- To contribute to conservation of cultural resource.

Result:

> Emergence of a new tourism hot spot.

- > Facilitating and encouraging visitors to stay longer period in Jaffna Peninsula.
- > Improve living standard of the local community

Allocation for 2017 : Rs.26.76 Mn

Many opportunities have been created to generate and accelerate entrepreneurs to be further engaged in tourism related fields in the future. As, there is a beach belt for water sports in the area Kappaladiya at present, many tourists are abundantly coming to visit these places.

In view of electricity, it is supplied to two villages called Kalpitiya and Palakudawa with a transformer installed in this area, as it was impossible to provide sufficient electricity in demand. It was impossible to carry out daily activities of entrepreneurs engaged in tourism industry earlier. Electricity is of a significant benefit to fishermen engaging in traditional fishing industry and 300 villages in the locality.

A transformer has been installed by the Central Electricity Board with the aim of improving infrastructure connected with the development of Kalpitiya area as a tourist attraction.

Objective:

 Installation of a transformer with sufficient capacity and voltage for the supply of electricity to improve tourism industry.

Results:

> Improvement of infrastructure requirement for the electricity (with required capacity and voltage) in the area, encouraging entrepreneurs engaged in tourism industry.

2.2 Development of Tourism Human Capital

There is a dearth of skilled personal in the tourism industry. Therefore, government has decided to provide training to youth keen on joining the hospitality industry in collaboration with the private sector. A financial provision of Rs 25.00 Mn was allocated in the Budget Estimates 2017.

2.2.1 Three Month Hospitality Service Training Program

A financial provision of Rs 20 Mn was allocated to train 1200 unemployed youths in the hospitality sector in 2017. This hospitality services training programs have been implemented with the collaboration of Provincial Councils, Private Hotel Schools and Private Hotels. Training course consists of the theory and practical trainings in Front Office Management, Restaurant & Bar Management & Housekeeping Management. Further it was supported to gain a wider knowledge of International Standard English speech, life skill, better communication, and retailing and consumer services. The curriculum was developed by the Sri Lanka Institute of Tourism and Hotel Management (SLITHM) evaluations/ exams were also conducted by the institute.

Students were provided with value added training as well as guidance through industry professionals for career development. The ceremony for award of certificates was conducted by the Ministry. Certificate of accreditation issued by SLITHM will be helpful for them to obtain the local and foreign employment opportunities in hotel industry.

Objectives:-

- 1. To provide job opportunities for unemployed youth.
- 2. To increase the women participation in hospitality training and increase their income.
- 3. To minimize aspects of income and consumption inequality upgrade both standard and quality of life.

Output:-

- 867 youths trained in the Restaurant and Bar Services
- 158 youths trained in the Housekeeping Management
- 132 youths trained in the Front office management

2.2.2 Capacity Building Program for Tourist Service Providers

Ministry initiated to conduct 3 day programme under the development of tourism human capital improvement to develop the capacities of stakeholders in the tourism sector island wide.

This Capacity Building Programme for Tourist Service Providers conducted by professional University lecturers in collaboration with Provincial Tourism Institutions. A sum of Rs. 5 Mn has been allocated for this training program. It was expected to train 1,300 service providers.

The program was formulated to meet the objectives of upgrading behavior and service skills of tourist service providers.

Target Group:

Transport facilitators (Three wheel drivers, taxi drivers, private transport providers); tourist shop keepers, managers, salesmen; small and micro accommodation operators (guest house keepers, home-stay owners, youth hostel operators etc.; and tourism vendors on the streets, sites and cities.

Objectives

- 1. To enhance the community empowerment through tourism
- 2. To bring forth perceptional changes among the ground layer tourism stakeholders towards tourism industry
- 3. To enhance tourism spatial distribution and opportunities for youths in existing and emerging regions of the country
- 4. To ensure the appropriate contribution of ground layer stakeholders for sustainable tourism development in the country
- 5. To improve the quality and standard of tourism services and facilities to enhance perception and satisfaction of tourists

The Programme was implemented by the Ministry of Tourism Development and Christian Religious Affairs in collaboration with Sri Lanka Institute of Tourism and Hotel Management (SLITHM). Provincial Councils, Private sector Hospitality Training Institutions and Leading Hotels in 2016. 605 trainees were awarded with Certificates on 2nd March 2017 at Sri Lanka Foundation Institute, under the distinguished patronage of Hon. John Amaratunga, Minister of Tourism Development and Christian Religious Affairs.

2.3. Community Tourism Development (Development of Tourist Villages)

Introduction

The main purpose of this project is to meet the demand of tourist accommodation as an alternative accommodation. It also helps the rural community to increase their income and employment opportunities. In home stay, tourists stay with the host's family and experience their way of life by engaging in many activities together with the family.

Objectives:

- i. To empower the local communities by creating tourism related employments and distributing economic benefits through tourism.
- ii. To support the demand for supplementary accommodation.
- iii. To develop market facilities in the villages which have rich potentials of Sri Lankan culture such as arts, craft, nature, eco, agro base, etc.

A sum of Rs. 25 Million has been allocated for the development of community tourism villages out of which Rs 0.96 Mn was spent to develop four villages in four districts.

Progress

- As an initial step to this programme, a "Training of Trainers" residential workshop was organized for the implementation level officers from provincial level, Divisional level and Ministry level at Embilipitiya National Centre for Leadership with the cost of Rs. 332,961.09.

 - 02. Yapahugama village home stay development
 - 03. Godahena Village Homestay Development
 - 04. Mederipitiya village homestay development

2.4. Expand Tourist Police Units in Tourist Hot Spots

It is undeniable that the tourism industry has a right to defend itself as well as to have a legitimate expectation that the government will ensure safety and security.

Therefore, the Government has allocated a sum of Rs.50 million to this Ministry to strengthen the tourist police serving in the tourist hot spots areas.

- 1. To ensure safety and security of tourists.
- 2. To ensure a pleasant and memorable stay in Sri Lanka
- 3. To prevent harassment, mistreatment and criminal activities against tourists.

Progress

2.5. Colombo International Shopping Festival (CISF) (Colombo Fair)

Activities:

- Anchor event of CISF was held on 20th to 22nd of October 2017.
- An Advertising campaign was launched focusing on four SAARC countries such as India, Pakistan, Maldives and Bangladesh during the period from October 1st to November 15th.

2.6. Update Print and Electronic Brochures and Guides to be distributed in High Tourist Attractions.

Promotional Materials of both printed and electronic brochures and guides intended for destination promotion through interactive digital display panels located as appropriate in prominent destinations such as Pinnawala Elephant Orphanage, Peradeniya Royal Botanical Garden and Colombo National Museum.

Objectives:

- Updating of outdated contents
- Make available the information in an appropriate way.

i. Department of National Museum

The Department was granted Rs.2.75Mn for the proposal submitted on "Establishment of interactive display panels in Museums".

Progress: The development of software was completed. Information in all three languages had been created for the Interactive Digital Display Panels.

ii. Department of Zoological Gardens

The Department was granted Rs.3.5Mn for the development of "visitor information system" for the Pinnawala Elephant Orphanage.

Progress: Department of Zoological Gardens has completed the development of QR code system in the tickets and displays that can be accessed by the tourists to get more information on tourist destinations under the Department of Zoological Gardens. Further, update of web site and writing 2000 mini CDs and five light boards establishments had been completed to promote the tourist attractions.

iii. Department of Botanical Gardens

The department was granted Rs.3.5 Mn to "install interactive digital information boards".

Progress: Five digital panels at different places in Royal Botanical Gardens, Peradeniya are installed with the objective of guiding the visitors tourists around important places and to provide them with more information on garden including botanical characteristics and features.

2.7. Interest Subsidy Loan Scheme to Tourist Hotels

Introduction:-

As per Budget proposals 2017, it has been proposed to provide interest subsidy loans to hotels in operation over 10 years to refurbish and upgrade their facilities to be in line with the modern requirements. This proposal is focused on supporting the hotel sector by providing financial assistance to implement a refurbishment programme.

Initially sum of 500Mn has allocated for the project. But for the implementation of flood relief programme Rs. 300 Mn was withdrawn by the Department of Budget in July 2017.

Objectives:-

- i. To encourage hotels to improve their product through upgrading and extension works.
- ii. To support hotels to address wider client-based requirements through the diversification of products and services offered.
- iii. To increase competitiveness of the tourism sector by increasing the number of visitors through the provision of value added hospitality services.

Implementing Agency: - Ministry of Tourism Development & Christian Religious Affairs

Progress: Several discussions were held with the banking sector officials and other relevant stakeholders.

However, the scheme was not implemented due to the fact that the Ministry had no proper strength to establish a separate unit for this purpose in order to implement and monitor this project.

Investigation Division

Internal Audit and Investigation Division

- Internal Audit Division, functioning under a Chief Internal Auditor, directly responsible to the Secretary of the Ministry as per F.R 134 (1), was established in November, 2016. Internal Audit activities are being implemented according to the annual internal audit plan being prepared at the commencement of the financial year under the guidance with the Department of Management Audit in General Treasury.
- Internal audits of the ministry were carried out, pertaining to the financial year 2017, thus, 05 internal audit reports have been issued relating to inconsistencies. Officials are being made aware of deviations pointed out in audit examinations and reports of Audit and Management Committees and the Progress Review Meeting. Accordingly, remedial measures will be taken to rectify them.
- Audit and Management Committee Meetings were held in the following dates in year 2017.

First Quarter 30. 01. 2017 Second Quarter 24. 04. 2017 Third Quarter 01. 08. 2017 Fourth Quarter 07. 11. 2017

- All the Heads of the Departments and the relevant officials of the Department of Christian Religious
 Affairs and Statutory Boards coming under the ministry were summoned to the committee meeting.
 Action will be taken to make remedies by drawing personal attention on risky areas of financial
 discipline, as reported by the Auditor General and Internal Auditor.
- Coordination of activities related to Audit Queries, received from the Auditor General and submission of replies to the Auditor General replies of the 12 numbers of audit queries forwarded to the ministry were submitted.
- Coordination of activities of the committee of Public Accounts and the Committee on Public Enterprises were carried out in the period under consideration.
- Discussion and compilation of the replies of Auditor General's Report and current performance of the ministry for the financial year 2015 and the Auditor General's Reports and the current performance of the Department in the financial years 2014 and 2015 were taken under the consideration whilst presenting of the replies in all three languages to the Public Accounts Committee. Replies were submitted to the recommendation of Committee on the Public Enterprises of Sri Lanka Tourism Development Authority.
- In addition, 06 investigations of calling reports by Hon. Minister and 01 investigation of calling reports from the President Office and 01 investigation of calling reports from the Prime Minister Office have been carried out in the period under consideration.

Composition of Internal Audit Division

 Approved cadre of Internal Audit Division of the Ministry comprises of Chief Internal Auditor and three Management Assistants. The existing cadre includes Chief Internal Auditor and one official of Management Assistant.
